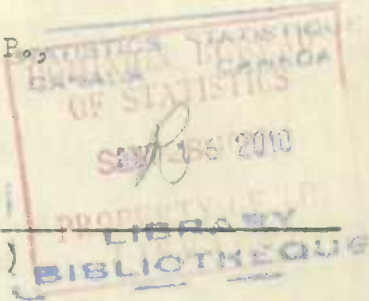

REPORT ON THE PROCESSED CHEESE INDUSTRY, CANADA, 1938.

In 1938, for the first time, the plants engaged in the manufacture of processed cheese were included in the annual collection of returns of the Census of Industry, which requires information concerning capital, employees, materials and fuel used, power equipment, and products. Prior to that year the manufacturers of processed cheese were asked for the quantity of cheese made and the quantity exported only.

The production of processed cheese in 1938 amounted to 14,189,496 pounds, valued at \$3,170,898. In 1937 the quantity made was 12,649,996 pounds, but information regarding the value of the product in that year is not available.

The number of processed cheese factories in operation in 1938 was 23, located by provinces as follows: Ontario, 11; Quebec, 8; Manitoba, 3 and Alberta, 1. The total value of output, including the processed cheese and such miscellaneous items as sandwich spread and salad and mayonnaise dressing, was \$4,555,383.

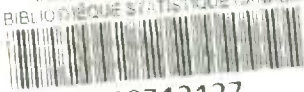
