REPORT ON THE PROCESSED CHEESE INDUSTRY, CANADA, 1944.

Processed cheese production in 1944 registered a decrease of 5.5 p.c. in quantity and 3.5 p.c. in value. Production amounted to 33,991,109 lb., valued at \$10,221,441, as compared to 35,970,129 lb., valued at \$10,589,766 in 1943. The quantity of cheddar cheese used by the industry was 25,135,921 lb., a decrease of 4.5 p.c. as compared with 1943.

The drying of egg powder accounted for \$6,686,930, or 70.8 p.c. of the value of 'other products'. The value of sandwich spread, salad dressing, cheese of types other than processed or cheddar, and other minor products rose from \$2,438,359 in 1943 to \$2,761,855 in 1944. The war-time use of part-time employees is reflected in the statistics of employment and wages; the number of employees increased by 24.6 p.c. while salaries and wages increased by only 20.5 p.c.
