

THE CONFECTIONERY, COCOA, CHOCOLATE AND CHEWING GUM

INDUSTRIES IN CANADA, 1948.

In 1948 reports were received from one hundred and ninety-six establishments whose principal products were confectionery, cocoa, chocolate and chewing gum. These establishments produced goods to the value of \$102,686,263, gave employment to 10,076 employees who were paid \$15,227,428 in salaries and wages, and expended \$56,396,133 for materials.

Ontario, with 78 establishments, accounted for 58.9 per cent of the gross value of production. Quebec, with 49 establishments reported 26.9 per cent of the total. The remainder of the establishments were located as follows: Nova Scotia, 8, New Brunswick, 4, Manitoba, 12, Saskatchewan, 2, Alberta, 5, and British Columbia, 38.

The output of the confectionery and associated industries was much higher in 1948 than in the previous year. The increase in the gross value of production amounted to \$25,831,400 or 33.6 per cent. Accompanying this enlarged output were increases of 731 in the number employed, \$2,509,119 in salaries and wages paid, and \$15,839,437 in the cost of materials used. The net value of production also showed an increase of \$9,863,447. Among the materials used, the consumption of sugar showed an increase of 26,467,478 pounds or 30.2 per cent.

To bring the industry in line with the Standard Classification currently used in the Bureau, the confectionery and associated industries were separated from the biscuit and ice cream cone industry. However, to enable the reader to follow the trend of the combined industries a table is included showing the principal statistics for the biscuit, ice cream confectionery, -cocoa, chocolate and chewing gum industries as a unit. See table 1.

Owing to a change in the items in the production section of the schedule separate production tables are given for the years 1947 and 1948.
