



SYNTHETIC TEXTILES AND SILK INDUSTRY 1956

The synthetic textile and silk industry has two branches. The first is comprised of establishments which produce synthetic filament yarns and staple fibres while the second consists of spun yarn and fabric manufacturers. The establishments in the first branch are too few and their activities too varied to permit a separate, detailed statistical analysis without divulging particulars of individual establishments. Although comprised of only seven concerns, this section of the industry in 1956 accounted for 49 per cent of the industry's employment and 59 per cent of its factory shipments. Production of textile filament yarn by the seven firms in the year under review amounted to 37,801,148 pounds. The production of tire yarn and staple fibre by this branch of the industry cannot be published because the preponderance of several establishments would result in disclosure of individual data.

Factory shipments totalling \$161,161,495 in value were reported by the industry in the year under review. This represents a slight increase of \$1,927,787 or 1.2 per cent over the preceding year's \$159,233,708. Employees numbered 15,694, up narrowly over the 15,408 in 1955. Their earnings rose by 4.7 per cent to \$49,115,583 from \$46,927,250 in the earlier year. Materials used in manufacture cost \$76,492,980 in 1956 compared with \$69,895,625 in 1955, an increase of 9.4 per cent.

There was a slight reduction in shipments of woven fabrics by the synthetic textile industry in 1956. A total of 96,695,576 lineal yards worth \$64,511,571 was shipped compared with 97,840,387 yards valued at \$64,986,302 a year earlier. Major contributor to the decline was all spun rayon fabrics deliveries of which fell from 23,975,721 yards in 1955 to 19,631,686 yards in 1956. Increased shipments were reported for both continuous filament rayon and continuous filament nylon fabrics, the shipments of these totalling 42,881,241 and 5,998,568 yards, respectively, in the later year compared with 39,986,864 and 4,207,674 yards, respectively, in the earlier. Deliveries of knitted fabrics at 3,681,035 pounds were also ahead of the 2,930,687 pounds reported for 1955. Further detail of factory shipments is to be found in Table 4. In Table 4(a) the 96,695,576 yards of woven fabrics shipped by the industry in 1956 are classified further according to construction. Ranking first are dress fabrics with 31,542,235 yards or 33 per cent of total.

In a highly competitive market the price of rayon fabrics declined somewhat whereas the price of rayon yarns managed a modest increase. The Bureau's monthly wholesale price index (1935-39=100) averaged 154.4 for fabric and 170.2 for yarn as against 155.7 and 166.0, respectively, in 1955.

Rayon staple fibre continues as the industry's main material although its consumption was down slightly to 20,370,992 pounds in 1956 from 20,919,494 pounds in 1955. The use of continuous filament rayon amounted to 9,897,549 pounds, down from 10,745,957 pounds the year before. The decrease was due entirely to a contraction in the use of acetate rayon from 6,275,880 pounds to 5,230,180 pounds there being a slightly expanded use of bemberg and viscose. The use of nylon yarn decreased from 2,462,088 pounds to 2,033,809 pounds and cotton from 2,368,062 pounds to 2,295,257 pounds over the two years. The cost of chemicals and dyestuffs rose from \$10,691,949 in 1955 to \$12,293,106 in the year under review.

A total of \$44,883,740 worth of silk and synthetic fibres, yarns and piece goods were imported in 1956 compared with \$41,140,403 in 1955. Woven fabrics accounted for almost half of this total. These were imported to the extent of 8,963,388 yards valued at \$20,853,472 which compares with 8,670,797 yards valued at \$20,401,540 in 1955. Imports of staple fibre were down in quantity but up in value over the previous year being 8,298,642 pounds worth \$5,778,760 in 1956 as against 9,296,490 pounds worth \$4,371,668 the year before. Takings of synthetic yarn for tire fabric totalled 6,022,308 pounds valued at \$3,499,316, up considerably over the 4,278,392 pounds worth \$2,546,526 taken in 1955. A total of \$1,256,574 worth of narrow woven fabrics were brought into Canada in 1956, which compares with \$1,127,551 worth a year earlier.

Capital investment in the industry continues at a high level due largely to improved techniques of production and quality of products. Total capital, repair and maintenance expenditures in 1956 amounted to \$20,414,000, \$17,219,000 of which went for machinery and equipment. The balance of \$3,195,000 was for construction.
