THE ADHESIVES INDUSTRY

1954

This report on the Adhesives Industry in Canada covers the operations of all factories which made glue, mucilage, paste or special adhesive cements as their chief products. In 1954 there were 28 establishments in this group, 14 being located in Ontario, 10 in Quebec, 3 in British Columbia and 1 in Manitoba.

Factory shipments by firms in the Adhesives Industry were valued at \$12,772,801 in 1954, an increase of 5.7 per cent over the 1953 total of \$12,082,115. The number of employees declined from 707 to 621 with a corresponding decline in salaries and wages from \$2,144,997 in 1953 to \$1,987,142 in 1954. The cost of fuel and electricity at \$367,922 was lower by 8.7 per cent than in 1953 and the value of materials used directly in manu-

facturing processes was 4.3 per cent lower at \$6,213,522.

Output of adhesives during 1954, including small amounts from other industries, was as follows: linoleum cement, 14,847,000 pounds at \$1,197,000; rubber cement, 703,000 gallons at \$1,604,000; bone and hide glue, 6,955,000 pounds at \$1,858,000; casein glue, 803,000 pounds at \$218,000; flexible glue, 2,105,000 pounds at \$535,000; synthetic resin glue, 28,913,000 pounds at \$3,797,000; vegetable glues, 19,757,000 pounds at \$2,188,000; mucilage and paste valued at \$848,000; fish glue valued at \$335,000 and miscellaneous adhesives at \$829,000. The total value of all adhesives, including mucilage and paste, was \$13,409,000 in 1954, compared with \$12,317,000 in 1953 and \$11,283,000 in 1952.

NOTE: Figures for value added by manufacture shown in Table 1, prior to 1952 were obtained by subtracting the cost of materials used, including fuel and electricity, from the value of production. In 1952, the gross value of production was replaced by value of factory shipments, f.o.b. plant. As no information on inventory change is available for 1952 and 1953, value added figures for these years were obtained by subtracting from the value of shipments the cost of materials, fuel and electricity. In 1954, information on the value of year-end inventory holdings at plant and plant warehouses was collected as part of the annual Census of Industry and information thus made available was taken into account in calculating the value added figure for 1954.




