THE TOILET PREPARATIONS INDUSTRY

1953

Factory shipments from the Toilet Preparations Industry were valued at \$30,438,474 in 1953 compared with \$27,059,783 in 1952 and \$22,535,080 in 1951.

In the annual census of manufacturing establishments in Canada the operating firms are arranged in a number of industrial groups to which the various factories are classified in accordance with the nature of their main products. Under this arrangement, the Toilet Preparations Industry includes all establishments which are occupied chiefly in making perfumes, toilet waters, face creams, tooth pastes, etc., but in 1953 this industry actually accounted for only about 67 per cent of the Canadian output of toilet preparations as a number of concerns in other industries made this class of goods as a minor or secondary part of their business. In Tables 1 to 4 and 8 to 11 of this report the data are for the

Toilet Preparations Industry as defined for census purposes, but Tables 5 and 6 have been added to show the total output of toilet preparations regardless of the industry in which produced.

In 1953 there were 94 establishments in this industry, 55 being located in Ontario, 31 in Quebec, 5 in British Columbia, 2 in Manitoba and 1 in Saskatchewan. Output from these concerns totalled \$30,438,474, including \$26,773,424 for toilet preparations and \$3,665,050 for other products. Employees numbered 1,955 and salaries and wages amounted to \$4,648,547.

Factory shipments of toilet preparations from all industries were valued at \$39,478,000 at factory prices in 1953. In 1952 the comparable value was \$37,281,000 and in 1951 it was \$30,873,000.
