NOTICE

THE BROOM, BRUSH AND MOP INDUSTRY

1957

Factory shipments in 1957 by establishments in the Broom, Brush and Mop Industry in Canada amounted to \$19,159,950, an increase of \$518,191, or 2.8 per cent, over \$18,641,759, the selling value of products shipped in 1956. Employees numbered 2,100, three fewer than in the previous year. Materials used in manufacturing processes cost \$9,028,238 in 1957, compared with \$8,608,934 in 1956. (See Tables 1, 2, 4 and 5).

There were 100 establishments in the industry in 1957, four less than in the previous year. Provincially they were distributed as follows: Newfoundland 1, New Brunswick 1, Quebec 41, Ontario 41, Manitoba 5, Saskatchewan 3, Alberta 1, and British Columbia 7. This indicates the predominant position of Ontario and Quebec which were responsible for 77 per cent of the total value of the products shipped, for 76 per cent of the employment and for 74 per cent of the wages and salaries paid in this industry. Ontario, alone, accounted for 56 per cent of the factory shipments, for 53 per cent of the employment and for 55 per cent of the salaries and wages. (See Tables 1 and 8).

The industry was concentrated in the eight largest establishments, with shipments of \$500,000 and over, which were responsible for factory sales

of \$10,525,247, or 55 per cent of the total; provided employment for 1,037 persons, or over 49 per cent of all employed; and paid salaries and wages of \$3,018,624, or over 54 per cent of the total paid in the industry. (See Table 10).

Paint brushes, numbering 507,986 dozen and valued at \$4,167,169, were the leading commodity in 1957. Shipments of other main commodities in order of selling value were 301,167 dozen corn brooms valued at \$3,016,670; floor mops, \$2,903,503; brushes for industrial use, \$1,660,566; and brushes for household use valued at \$1,402,648. For complete details of products shipped, see Table 4.

Employment in this industry was fairly constant throughout the year, ranging from a high of 1,637 wage-earners in April to a low of 1,519 in July. (See Table 9).

Beginning with 1954, information on the value of year-end inventory holdings at plants and plant warehouses has been collected as part of The Annual Census of Industry. This data was formerly collected by a separate survey. A summary of the inventory statistics of the Broom, Brush and Mop Industry for 1957 is given in Table 3.
