The Sporting Goods industry, 1930 and 1931.
Ottama, Jnuary, 1933.- A preliminary roport on tho manufacture of sporting foods in Canada in 1930 and 1931 has recently been issued by the Forestry Branch of the Dominion Bureau of Statistics. This report covers the operations of woodmorking factories which specialize in the manufacture of sportinf goods and in most coses covers the greater part of the production of these commodities in Canada. The production of sporting goods, however, is frequently carried on 28 a side line in wood-working factories classed in other industrial groups.

There were 24 ostablishments specislizing in sporting goods in 1931, of which 15 were located in Ontario, 3 in Quebec, 1 each in Nova Scotin and British Columbia and 4 in Manitoba. The capital invested amounted to $\$ 1 ; 678,813$ and the employees numbered 516 , with maces and salaries amounting to $\$ 496,639$. The fuel used cost $\$ 14,363$ and the power employed was $1,430 \mathrm{~F}$. P. The raterials used cost $\$ 628,310$ and the Eross value of production was $\$ 1,582,361$, the not value or the value added by manufacture being $\$ 954.051$.

The wood used in the industry wns chiefly sawn hardmood lumber amountinf to $1,624 \mathrm{M} \mathrm{ft}$. board measure, valued at $\$ 96,798 ; 90 \mathrm{M} \mathrm{ft}$. softmood lumber at $\$ 3,087$; 5,179 cords of hardmond bnlts at $\$ 60,403$ and veneer and plywood valued at $\$ 8,865$. All other materials made up the total of $\$ 628,310$.

The more important items among the principal products were hockey sticks, numbering 545,368 and valued at $\$ 159,094$, and tennis and other racquets numbering 69.208 valued at $\$ 272,557$.

The following tables five, first a comparative surmary of the principel statistics of the industry for 1930 and 1931, followed by detailed comparative tables coverine the distribution of establishments, materials used, products manufactured, capital invested, employment, fuel and power.
