

WHOLESALE TRADE

JUNE 1956

Estimated sales for wholesale trade in Canada amounted to \$694,243,000 in June 1956, a gain of 9.4 per cent over the same month of 1955. These sales cover "wholesalers proper" and do not include the business transactions of manufacturers' sales branches or agents and brokers. They are not adjusted for price changes, seasonal variations or number of business days in the respective months.

Sales for the first six months of 1956 reached \$3,706,332,000, or 15.0 per cent above last year. The most significant gains occurred in durable goods. Automotive parts and accessories were up 104.2 per cnet; industrial and transportation equipment and supplies, 49.8 per cent; farm machinery, 28.0 per cent; and construction materials and supplies, up 20.7 per cent.

Although the increase in June sales was substantially influenced by certain "durable goods" trades, notable gains were registered in fresh fruits and vegetables (16.7 per cent), tobacco and confectionery (12.8 per cent), and coal and coke (17.2 per cent), The textile and apparel trades and drug wholesalers showed little change in sales compared with June 1955.
