WHOLESALE TRADE

JULY 1956

Estimated wholesale sales during July 1956 increased 16.8 per cent over sales for the same month last year. The \$660,626,000 total for the month brought the year-to-date sales to an estimated \$2,137,578,000 which was also a gain of 16.8 per cent over the first seven months of 1955. These sales cover "wholesalers proper" and do not include the business transactions of manufacturers sales branches or agents and brokers. They are not adjusted for price changes, seasonal variations or number of business days in the respective months.

All of the eighteen trade classifications reported increased sales this July with significant gains in newsprint and paper (34.6 per cent), industrial and transportation equipment and supplies (32.2 per cent) and farm machinery (23.2 per cent). The same trades were highest in percentage gain in sales for the first seven months of the year.

Revisions to certain reporting in the automotive parts and "all other" categories have necessitated corrections from March 1956 through June. They are included in the January-July sales shown in this report.
