WHOLESALE TRADE

December, 1958

Estimates of wholesale sales for the month of December 1958 and comparable figures for 1957 will be found on page 6 of this report. Pages 2 and 3 are used for the publication of revised estimates of wholesale sales for the years 1952-1957 inclusive and preliminary estimates for the year 1958. For reference purposes, the adjusted data of the 1951 Census are also shown. Pages 4 and 5 show preliminary monthly estimates of wholesale sales for 1958 after allowance has been made for revisions in the figures of previous years.

December sales of Canadian wholesalers were estimated at \$672,753,000, about 15.9 per cent above December 1957 sales of \$580,231,000. These sales cover "wholesalers proper" and do not include the business transactions of manufacturers sales branches or agents and brokers. They are not adjusted for price changes, seasonal variations or number of business days in the respective months.

A comparison of sales figures for December, 1958, with those for the same month in 1957 shows that all but one of the eighteen trade groups recorded increases, ranging from 60.6 per cent for farm machinery to 4.7 for fresh fruits and vegetables. Newsprint, paper and paper products registered a slight decline of 1.4 per cent.

With respect to the revisions which appear in this report, the reader is referred to the report for September and October, 1955, (Vol. 20, No. 9, of this series) where dollar estimates of wholesale trade were introduced for the first time since 1939 for other than the regular decennial census years 1941 and 1951. The revised estimates published here take account of firms entering and leaving the various trades during the period 1952 to 1957 inclusive.

The adjustments for 1956 and 1957 with regard to new firms are based on surveys of businesses entering the various wholesale trades during these years. The adjustment for 1955 is based on employment data of firms opening for business during the year. For 1952-1954 inclusive, it was assumed that the adjustment factor was similar to that which existed for the years 1955 and 1956. The adjustment for firms leaving the trades has been based on results of the regular monthly sample survey.


