WHOLESALE TRADE

April, 1958

Sales of Canadian Wholesalers amounted to an estimated \$643,750,000 in April and \$2,431,914,000 in the January to April period. These figures were 2 per cent below their respective levels in 1957. These sales cover "wholesalers proper" and do not include the business transactions of manufacturers sales branches, or agents and brokers. They are not adjusted for price changes, seasonal variations or number of business days in the respective months.

Substantial gains were registered in April for Farm machinery (25 per cent), Meat and dairy products (19 per cent) and Drugs and drug sundries (12 per cent). Other increases were registered for Automotive parts and accessories (8 per cent), Other textile and clothing accessories (7 per cent), Footwear, and Tobacco, confectionery and soft drinks (5 per cent each) and 4 per cent for each of Fresh fruits and vegetables, Groceries and food specialties, and Newsprint, paper and paper products. Industrial and transportation equipment and supplies wholesalers accounted for the largest decrease with 27 per cent followed by Coal and coke with 25 per cent. Smaller decreases were registered for Clothing, and furnishings and Construction materials and supplies (4 per cent each) and 1 per cent for each of Commercial, institutional and service equipment and supplies, Hardware, and Household electrical appliances. A 5 per cent decrease was also registered for the "all other" classification.

Revisions have been made to the estimates previously published on the Farm machinery trade and these are included in the January to April cumulative totals on the reverse side of this page. The revised estimates for each period of 1958 were as shown in the following table.
