

NOTES

This bulletin summarizes the statistics published in the monthly series under the same title and contains minor revisions to the monthly data where necessary.

New Motor Vehicle Sales statistics are obtained from Canadian manufacturers who report consolidated totals of their dealers' monthly statements on sales to customers and from direct importers of cars of other than Canadian manufacture. Every effort is made to avoid duplication of sales reported by distributors of European cars.

COMMERCIAL VEHICLES

Commercial Vehicles is a term which is used for convenience in this report and is synonymous with the term "trucks and buses". Passenger models used for commercial purposes, such as taxis, are classified with passenger vehicles.



NEW MOTOR VEHICLE SALES

1965

SUMMARY

Sales of new motor vehicles in Canada reached an all-time high during 1965. The number of new motor vehicles sold rose from 725,879 in 1964 to 830,995, an increase of 14.5 per cent. This marks the fourth consecutive year in which the year-to-year gain in the sale of new motor vehicles has exceeded 10 per cent. The retail value of the new vehicles sold in 1965 totalled \$2,739,329,000, an increase of 17.2 per cent over the previous year.

As in 1964, sales of both passenger cars and commercial vehicles increased substantially—passenger cars by 14.9 per cent and commercial vehicles by 12.1 per cent over the previous year. In terms of dollar volume, expenditures on passenger cars and commercial vehicles rose by more than 17 per cent over the previous year. The larger increase in dollar volume as compared to the number of new motor vehicles sold is due, in part, to a higher average retail value per vehicle—1.9 per cent more for passenger cars and 4.9 per cent more for commercial vehicles.

The share of the new motor vehicle market held by overseas manufactured vehicles appears to have levelled off at approximately 9 per cent. Prior to 1964, the share of the market held by overseas manufactured vehicles had declined dramatically from a high of 25.4 per cent in 1960 to 8.3 per cent in 1963. In 1964, the downward trend was arrested and the overseas share of the market rose to 9.4 per cent. For the year 1965, the share of the new motor vehicle market held by overseas manufactured vehicles declined only fractionally, to 9.3 per cent. However, the sales of overseas manufactured commercial

vehicles declined for the sixth consecutive year—from the high of 8,222 units in 1959 to 2,074 units in 1965.

Although the second quarter of the year continued as the most popular period for the sale of new motor vehicles, with 31.9 per cent of total unit sales in 1965, it appears that a levelling off in the volume of spring sales is taking place. In 1962, 33.8 per cent of all new motor vehicle sales were made during the months of April, May and June; in 1963, 33.0 per cent; in 1964, 32.5 per cent; and in 1965, 31.9 per cent.

British Columbia experienced the highest rate of increase in both the number of units sold and total retail value: 19.8 per cent and 23.7 per cent respectively. Significantly, the year-to-year percentage change in the sale of new motor vehicles in British Columbia has equalled or exceeded +16 per cent in each of the past four years. Increases in the number of new vehicles sold in other provinces ranged from 17.3 per cent in Ontario to 1.4 per cent in Manitoba.

As compared with 1964, Ontario and Quebec accounted for a slightly larger share of both total sales and number of vehicles sold in 1965—65.5 per cent and 65.2 per cent respectively. These proportions are somewhat larger than the percentage of total retail trade accounted for by the two central provinces (62.3 per cent).




