NOTES

This bulletin summarizes the statistics published in the monthly series under the same title and contains minor revisions to the monthly data where necessary.

New Motor Vehicle Sales statistics are obtained from Canadian manufacturers who report consolidated totals of their dealers' monthly statements on sales to customers and from direct importers of cars of other than Canadian manufacture. Every effort is made to avoid duplication of sales reported by distributors of European cars.

COMMERCIAL VEHICLES

Commercial Vehicles is a term which is used for convenience in this report and is synonymous with the term "trucks and buses". Passenger models used for commercial purposes, such as taxis, are classified with passenger vehicles.

NEW MOTOR VEHICLE SALES

1966

SUMMARY

For the first time since 1961, sales of new motor vehicles failed to achieve a new high. The number of new motor vehicles sold declined fractionally from 830,995 in 1965 to 827,431 in 1966, a decrease of 0.4 per cent. The retail value of the new motor vehicles (based upon Manufacturers suggested retail list price) however, increased by 3.1 per cent over the previous year to a record \$2,824,591,000.

The decline in sales of new motor vehicles was due solely to decreased purchases of passenger cars; from 708,716 in 1965 to 694,820. Sales of commercial vehicles, on the other hand, increased by 10,332 units or 8.4 per cent. In terms of dollar volume, however, expenditures on both passenger cars and commercial vehicles rose to record levels. The decrease in the number of passenger cars was more than offset by the higher average retail value per vehicle - \$3,273 in 1966 as compared to \$3,199 in 1965. Expenditures on commercial vehicles rose to a record \$550,508,000, an increase of 16.6 per cent over the previous year.

The share of the new motor vehicle market held by overseas manufactured vehicles continued to shrink in 1966; 8.4 per cent of total sales as compared to 9.3 per cent in 1965. The reader should note that overseas vehicles assembled in Canada are considered as Canadian manufactured vehicles. During the past few years a number of plants for assembling European cars have commenced operation in Canada. This fact may account for a part of the declining market share of European manufactured vehicles. Nevertheless the market share of new

motor vehicles held by European manufactured vehicles has declined dramatically since 1960, when the market share attained by European manufactured vehicles had reached 25.4 per cent.

The popularity of the second quarter of the year for the sale of new motor vehicle sales has continued to decline. In 1966, 28.2 per cent of total unit sales were made during this period as compared to 31.9 per cent in 1965; 32.5 per cent in 1964 and 33.0 per cent in 1963. The levelling off of spring sales has produced a more even distribution of unit sales throughout the year.

Manitoba experienced the highest rate of increase in both the number of units sold and total retail value; 14.6 per cent and 20.0 per cent respectively. Other provinces which registered gains were Alberta (5.6 per cent); Atlantic Provinces (4.4 per cent); and Saskatchewan (2.3 per cent). British Columbia which registered increased sales of new motor vehicles equal to or exceeding +16 per cent in each of the past four years experienced a decline of 1.7 per cent in 1966.

As would be expected, Ontario and Quebec accounted for the largest share of the new motor vehicle market. The market share held by the two central provinces declined to 63.6 per cent in 1966 from 65.5 per cent in 1965.



