### NOTES

This bulletin summarizes the statistics published in the monthly series "New Motor Vehicle Sales", Catalogue No. 63-007, and, in addition, contains minor revisions to the data published in this series.

**New Motor Vehicle Sales** statistics are obtained from Canadian manufacturers (for both Canadian and U.S. made cars) and from direct importers of cars of other than Canadian or U.S. manufacture. In both cases, respondents are requested to provide consolidated totals of their dealers' monthly statements on sales of new motor vehicles. Every effort is made to avoid duplication, particularly for sales reported by distributors of European cars.

**Commercial Vehicles** is a term employed for convenience throughout the text, with reference solely to "trucks and buses". Passenger-carrying automobiles used for commercial purposes, such as taxis and local delivery services, are nevertheless classified with passenger vehicles for the purpose of this report.

# NEW MOTOR VEHICLE SALES

## 1967

### SUMMARY

The total value of new motor vehicles sold in Canada fell during 1967 by more than \$26 million, a decline of 0.9 per cent from the previous year. As reported by automobile manufacturers, sales of passenger and commercial vehicles in 1967 reached a value of \$2,798,366,000, as compared to the \$2,824,591,000 recorded during 1966. Although a sizeable proportion of this decline can be traced to a change in reporting methods which took effect in 1967, there was no similar explanation for the fact that, for the second successive year, there was an absolute decline in the **number** of new motor vehicles sold across the country. The total of 815,307 vehicles sold in 1967 was 12,124 units or 1.5 per cent lower than in 1966, and 15,688 (1.9 per cent) less than the 1965 total.

The drop in number and value of new vehicles sold was confined to the passenger car field, where sales declined in number by 15,385 units (2.2 per cent) and in value by \$63,774,000 (2.8 per cent) below 1966 levels. Even the average retail value (based on number of passenger vehicles sold) fell during the year—from \$3,273 in 1966 to \$3,253 in 1967. In marked contrast, sales of new commercial vehicles reached new highs during 1967, in terms of both number (135,872) and value (\$588,057,000). These represented increases of 2.5 per cent and 6.8 per cent, respectively, over the previous year. As a result, the average retail value of commercial vehicles rose during 1967 to a new high of \$4,328.

Reference was made earlier to a change in reporting methods which affected the data on value of sales of new motor vehicles. During 1967, automobile manufacturers and distributors were requested to report the **actual cost to purchasers** of new motor vehicles, rather than the value based on manufacturers' suggested list prices. By year-end 1967, nearly all respondents (in terms of dollar sales) were supplying monthly valuations on the new basis. Since the values reported following the change-over are assumed to be somewhat lower than under the previous basis, the net result is an unknown amount of contraction in the value of new motor vehicle sales, as noted above, and an interruption in the continuity of the historical series shown on page 7. This factor must be borne in mind by the reader when studying the percentage changes in retail sales value described elsewhere in this report. It must also form an important part in any analysis of trends in the new motor vehicle field.

One of the more significant of these trends, in recent years, has been the declining share of the new motor vehicle market held by overseas-manufactured passenger and commercial automobiles—a decline which was at least partially attributable to

the growing number of automotive plants operated in Canada for the assembly of European and other overseas cars. In 1967, however, overseas-manufactured vehicles accounted for 9.4 per cent of total unit sales, as compared with 8.4 per cent in 1966 and 9.3 per cent in 1965. The value of these sales, as a proportion of total new motor vehicle sales, also rose during 1967, to 6.1 per cent—the first such increase since 1964. Growth in this field can be traced to the fact that the number of overseas-manufactured vehicles sold last year increased by 10.2 per cent and the sales value by 13.3 per cent.

Another reversal of trend which invites closer study is the increase in second-quarter results, from 28.2 per cent of total unit sales during 1966 to 32.6 per cent in 1967. Since 1963, the levelling off of spring sales had produced a more even distribution of new motor vehicle sales throughout the year and a resulting decline in second-quarter volume. The rather sizeable increase in the 1967 second quarter results in a figure which is only slightly less than the 33.0 per cent recorded in 1963 and indicates a resurgence of this period as the most popular one for new motor vehicle buyers.

Manitoba and Alberta were the only provinces that experienced an increase in the number and value of new motor vehicles sold during 1967. The largest gains for both passenger cars and commercial vehicles, were recorded in Manitoba—where the value of sales increased over 1966 by 3.6 per cent for passenger cars, 15.2 per cent for commercial vehicles and 6.2 per cent for both types combined. In the commercial vehicle field, which in general showed positive gains in 1967, declines were experienced in the Atlantic Provinces (in terms of number), Saskatchewan (in value of sales) and British Columbia.

The two central provinces, Ontario and Quebec, continued to account for a major share of the new motor vehicle market, although the proportion—63.6 per cent—was unchanged from the previous year, in contrast with the 1.9 per cent decline experienced between 1965 and 1966. A downward trend was also noted in British Columbia, where the share of the market has fallen from 9.7 per cent to 9.4 per cent during the past two years. On the other hand, continuing gains in market share were registered in Manitoba, which rose from 4.0 per cent in 1965 to 5.0 per cent in 1967, and in Alberta, which increased during the same period from 8.1 to 9.1 per cent.

A detailed study of motor vehicle financing by sales finance companies is included as part of the annual report "Sales Financing." Catalogue No. 63-211.






## NUMBER OF NEW MOTOR VEHICLES SOLD IN CANADA
