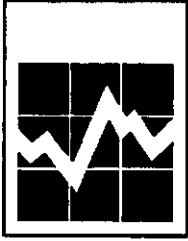

There are two aggregation universes that comprise the Trade Measures database. The first is aggregated by commodity while the second, a re-aggregation of the first, is by 'commodity grouping'. Each record contains one year of data, that is, twelve monthly figures, four quarterly figures and one annual (or year-to-date) figure. The identification that appears in the first eight bytes of each record breaks down as follows: Positions 1 - 3 Data identifier

- Pos. 1 Trade direction code ('M' for Imports; 'X' for Exports)
- Pos. 2 Data type ('B','K','T','U','V','W','X','Y','Z')
- Pos. 3¹ Combined 'level of adjustment' and principal trading area code
- Positions 4 - 6 Commodity Group identification
- Positions 7 & 8 Year code

At present, only the grand total current dollar value records are also published by PTA and, as such, are the only records which actually require the full complement of codes.
