VOLUME OF HIGHWAY TRAFFIC ENTERING CANADA ON TRAVELLERS' VEHICLE PERMITS OCTOBER, 1957

The volume of foreign vehicles entering Canada on travellers' vehicle permits in October declined 7 per cent when compared with the same month of last year. Cumulative entries for the ten months of 1957 were increased by 64,468 vehicles or a gain of about 3 per cent for the period.

NOTE: Travellers' vehicle permits are issued to foreign vehicles which remain in Canada longer than 48 hours or which travel beyond the jurisdiction of the port of entry. (Thus a motorist who intends to leave the country at a point other than that of entry must apply for a traveller's vehicle permit). Figures shown above refer almost exclusively to automobiles. They include a small number of taxis, motorcycles and bicycles, but exclude buses, trucks and other commercial vehicles. Data for current month are subject to revision. Entries into Canada via Newfoundland and Nova Scotia are by vessel.
