Foreign vehicles entering Canada during May 1967 numbered 9 mcrease of 113,512 or 12.9 per cent over May 1966. Some 96 per cent of the gain over the previous year appeared in Quebec which accounted for 109,214 of the overall increase. No doubt "Expo" contributed substantially to the gains in that area. Cumulative data for the first five months how an increase of 184,134, of which nearly 150,000 was in the province of Quebec. The pattern for the other provinces was varied with increases and decreases appearing for the period.
