## MAY 1968

Entries of vehicles registered in other countries totalled 955,273 in May, a decrease of 40,810 or 4.1 per cent under the corresponding month of 1967. The overall decline can be traced to the long-term traffic where 72,622 or 24.1 per cent fewer entries were reported. Gains were evident for all provinces except Ontario and Quebec where 1967 data were affected by the first full month of Expo attendance.
