Entries of vehicles registered in countries other than Canada numbered 1,117,943 in September, B ackage of 11.6 per cent compared with 1967, but an increase of 4.7 per cent over September 1966. The decrease was more pronounced the below term traffic which was 21.2 per cent below the comparable figure for 1967. Cumulative data for the period January — September show a total of 9,817,957 vehicles in 1968 and, although 2.5 per cent under the 1967 record, does represent a sizeable increase of 9.7 per cent when compared with 1966.
