NON-RESIDENT (1) VEHICLES ENTERING CANADASource: Reports from Border Offices of the Department of National Revenue

NOVEMBER 1970

A total of 704,470 vehicles registered in other countries entered Canada during November 1970, a decrease of 4.7 per cent compared to the same period last year. Vehicles remaining one or more nights numbered 147,526, declining 1.4 per cent versus November 1969. Figures reported on total vehicles entering during January - November 1970 show an increase of 3.9 per cent versus 1969. Long term traffic increased for the first eleven months of 1970, 8.6 per cent above the same period in 1969.
