#### NON-RESIDENT(1) VEHICLES ENTERING CANADA

Cumulative totals for the January - September 1971 period show that 10.5 million non-resident vehicles entered Canada, a slight increase from the previous year. Total long-term traffic over the same period increased 5.1 per cent. During the month of September 1.2 million non-resident vehicles entered Canada, a 2.4 per cent increase from last year; and of which 38.7 per cent was of a long-term nature.
