PREFACE

This report is the second edition of Part II of the Handbook of Agricultural Statistics, Farm Income, Reference Paper No. 25. It sets forth estimates of income of farm operators from farming operations for the years 1926 to 1957 inclusive, including revisions based on data obtained from the 1951 Census of Agriculture. Part I, Field Crops, was first published in 1951 followed by the publication of a supplement in 1955. Part III of the Handbook, Trends in Canadian Agriculture, was also published in 1955 and Part IV, Food Consumption in Canada, 1926-1955 was published in 1958. It is expected that sections dealing with special crops, livestock and animal products will be released at a later date.

While these estimates are almost entirely the work of the Agriculture Division, Dominion Bureau of Statistics, grateful acknowledgment is made to thousands of Canadian farmers and many agencies who have been most helpful in providing basic data necessary for the development of this project. The principal sources of information are:

- 1. Census of Agriculture data.
- 2. Mail questionnaire surveys undertaken by the Agriculture Division of the Dominion Bureau of Statistics in co-operation with statistical offices of provincial departments.
- Other divisions of the Bureau of Statistics who provide basic data relative to the trade and processing of agricultural commodities and goods and services used in agricultural production.
- 4. Other government departments and agencies who, in the course of their work, voluntarily make available to the Bureau much information of a statistical nature. Considerable reference was made to the Report of the Royal Commission on Dominion-Provincial Relations, 1939.
- 5. Processing and manufacturing firms, trade associations and marketing boards who willingly provide statistics on marketings and prices.
- 6. The Bureau of Agricultural Economics, United States Department of Agriculture.

DEFINITIONS AND CONCEPTS

In the preparation of farm net income estimates, two separate series were developed:

(1) realized net income of farm operators from farming operations, and (2) total net income of farm operators from farming operations.

Estimates of realized farm net income are based on the following principal components:

I. Realized Gross Farm Income

- Cash income from the sale of farm products, including participation payments and subsidies.
- Income in kind This is all produce, valued at farm prices, consumed in homes on farms where grown, plus imputed rental value of farm homes.
- Supplementary payments These are payments made under the provisions
 of the Prairie Farm Assistance Act, the Prairie Farm Income Plan, and
 the Wheat Acreage Reduction program.
- II. Operating Expenses & Depreciation Charges This includes farm business expenses incurred regardless of whether they were paid for or not.
- III. Realized Farm Net Income This is calculated by subtracting operating expenses and depreciation charges from realized gross farm income.

The term realized net farm income is used because the gross value of output included in the income component is only that which is sold or used by the farm family, with no allowance for production that exceeds sales and home consumption during the year or for sales and home consumption in excess of current production. In other words, realized farm net income does not include changes in farm inventories of crops and livestock on farmsduring the year. With the exception of Canadian Wheat Board payments, which are included in the year received by farmers rather than the year earned, the omission of inventory changes provides a gross income estimate that fails to reflect the production for which operating expenses and depreciation charges have been incurred during the year. Nevertheless, realized farm net income is a very useful estimate in that it provides the best measure of net income from farming operations available to farm operators and their unpaid family help for living expenses, payment of income taxes, savings or investment.

The following principal components were used in the calculation of farm net income from farming operations:

I. Total Gross Farm Income

- 1. Realized gross farm income see above.
- Value of change in year-end inventories of grains and livestock on farms.
- II. Operating Expenses & Depreciation Charges as above.
- III. Total Farm Net Income This is calculated by subtracting operating expenses and depreciation charges from total gross farm income.

As will be noted, this net income estimate includes the value of inventory change of grains and livestock referred to in the remarks concerning realized net income. In other words, the income component makes an allowance for production that exceeds sales and home consumption during the year or for sales and home consumption in excess of current production. With the exception of Canadian Wheat Board payments which, as mentioned above, are included in the year received by farmers rather than in the year earned, the total gross income accounts for the total production of the year for which expenditures have been incurred. With some adjustments in as set forth in the following section, this is the estimate of net income of farm operators from current production which serves as a component of total National Income. It is the preferred measure of farm income for comparisons with net income of non-farm business enterprise.

From the foregoing it will be seen that these estimates purport to measure income accruing to farm operators as a result of their farming operations. They do not include any income derived from non-farm sources and from capital (net rent and interest payments on mortgages and agreements for sale) invested in farms of which the farmer himself is not the operator. Nor do they purport to cover all income originating in agriculture; three segments of income originating in agriculture and excluded from these net income estimates are (1) net farm rent (2) interest payments on farm mortgages and agreements for sale, and (3) wages paid to hired farm help.

RECONCILIATION WITH NATIONAL ACCOUNTS - INCOME & EXPENDITURE, 1926 - 1957 1/

For National Accounts purposes, certain adjustments are made to estimates of farm net income. First, imputed net rents on owner-occupied farm dwellings, and profits of agricultural enterprises organized as corporations, are deducted, since these are included in investment income. Second, payments from the government under the Prairie Farm Assistance Act and Prairie

Farm Income Plan are deducted since these are regarded in the National Accounts as transfer payments, and not payments for productive service. Wheat acreage reduction payments, however, are treated as a subsidy in the National Accounts and therefore not excluded.

The third adjustment allows for differences in the method of calculating the change in farm inventories for National Accounts purposes. In the National Accounts, the value of the physical change in inventories of grains on farms annually from 1947 to 1956 has been defined as the sum of the change in the four quarters. However, the Agriculture Division calculates an annual value of physical change in inventories based on average annual prices. The difference between the two figures is due to differences in weighting, and an adjustment must therefore be made to reconcile to the National Accounts basis.

The fourth adjustment consists of an estimate of agricultural net income in Newfoundland (beginning in 1949). Since the Agriculture Division does not yet include that province in its annual surveys, this estimate is added.

The fifth, and final, adjustment is called "adjustment on grain transactions" and is made up of two parts. The first part takes account of the earnings arising out of the operations of the Canadian Co-operative Wheat Producers and the Canadian Wheat Board. The second part of the adjustment allows for the fact that the earnings of these agencies are calculated on the basis of change in book values of inventories, whereas the required valuation of inventories for the National Accounts is the value of physical change.

INTERCENSAL REVISIONS OF ESTIMATES OF FARM INCOME FROM FARMING OPERATIONS

As will be indicated in the outline of methods and sources which appear later in this publication, estimates of many items considered in farm income and expenditure are based on Census of Agriculture data. Up until 1956 these Census data were collected once every ten years for all Canada and once every five years for the Prairie Provinces. Used as bench marks, this information is projected forward year by year by means of related annual information until the results of the succeeding Census of Agriculture become available. In some cases the annual projections may have to be carried forward by use of annual information which is incomplete with the result that estimates prepared at the end of the intercensal period often vary from the subsequent Census figures. When this occurs, revisions must be made to bring the annual estimates into line with the Census. This outline is intended to set forth in very general terms the revisions made in income estimates during the intercensal period of 1941-1951 and the projections from 1951-1956.

Over the seventeen years, 1940-1956, farm net income was adjusted downward on the average by 8 per cent per year, ranging from less than one per cent to almost 16 per cent just prior to the 1951 Census of Agriculture. About one-sixth of this downward revision can be attributed to revised estimates for cash farm income, about one-third to income in kind, one-fifth to inventory changes and almost one-third to farm expenditures.

Farm cash income: - Income from the sale of farm products is the most important item in the farm accounts and, as previously noted, the revision to this series accounted for about one-sixth of the adjustment to farm net income. Over the seventeen years, 1940-1956, farm cash income was adjusted downward on the average by one per cent, ranging from substantially less than one per cent to three per cent. Forestry products and hogs accounted for four-fifths of the revision for the years 1945 through 1950. Other commodities such as poultry products, dairy products, fruits and grains accounted for the remainder.

It was necessary to adjust income from the sale of forestry products downward by about one-third on the average in order to bring the intercensal estimates into line with bench-mark data obtained from the 1951 Census. In preparing the original estimates of farm cash income from the sale of forest products, it was assumed that this source of income moved in sympathy with the estimate of total value of all forestry production. Between 1940 and 1950 the value of total forestry production tripled. Not until the 1951 Census of Agriculture became available was it evident that farm income from this source had only doubled during this period largely as a result of a decline in the amount of farm forestry products produced for sale. This was in contrast to an increase in output recorded for total forestry production. This situation suggests that, during the period 1940 through 1950, the farm wood lot faced increasing competition from other farm enterprises for available labour and other resources used by farmers with the result that fuel-wood sold off farms in 1950 was only about half that sold in 1940. Although this decline was offset to some extent by increased pulpwood sales, the physical volume of all forestry products sold off farms in 1950 was substantially less than 10 years earlier.

Income in Kind: - Annual forward projections of Census bench-mark data for income in kind for the years following 1940 were accomplished in some cases by means of annual information which was not entirely complete and could not be made complete until the 1951 Census data became available. Two important factors which affected these projections are as follows: (1) change in number of farms and (2) consumption habits. These two factors were particularly important in eastern Canada.

Between 1941 and 1951 the number of occupied farms declined from 732,858 to 619,465, partly as a result of change in definition. In 1951, a farm was defined as a holding on which agricultural operations were carried out. The holding could consist of a single tract of land or of a number of separate tracts held under different tenures. It had to be (a) three acres or more in size, or (b) from 1 to 3 acres in size with agricultural production in 1950 valued at \$250 or more. Where the farm was made up of several parts located in different municipalities, the 1951 Census reported the complete farm as one unit in the municipality where the headquarters were located. Previous censuses counted as separate farms, all tracts of land one acre or more in size that produced agricultural products valued at \$50 or more.

It is estimated that approximately 55,000 of the decrease of 113,393 farms between 1941 and 1951 was the result of the change in definition. Assuming no change of definition, it would appear that the decrease in number of farms between 1941 and 1951 would have been 58,000, or about 8.6 per cent instead of 113,393, or 15.5 per cent. The use of a new definition almost doubled the rate of decline in the 10 years, necessitating a substantial adjustment to the income in kind series.

On a commodity basis, forestry products accounted for a low of one-sixth of the total adjustment to the income in kind series in 1940 to a high of three quaters during the years immediately preceding 1956. The reduction in farm numbers coupled with the decline in the popularity of wood as a fuel were the principal reasons for the necessary downward revisions. The quantity of wood used as fuel did not vary greatly between 1930 and 1940 but in 1950, farmers used only about half the physical volume of wood for fuel as in 1940. Evidently farmers, like other groups, turned to more convenient forms of fuel during the period 1941-1951.

As previously noted, other adjustments to the income in kind series can be attributed largely to the change of definition of a farm and to revised estimates of various commodities produced and consumed on farms.

Inventories: Revisions to year-end inventory values accounted for about one-fifth of the revision to net farm income and can be attributed largely to revised estimates of year-end numbers of livestock on farms. A second factor, but not nearly as significant, was a change in the method of valuing inventories. In the original series, year-end inventories were valued at year-end prices whereas inventories in the revised series, were valued at annual average prices. Revisions to grain inventories were small and can be attributed almost entirely to the change in method of valuation.

Operating and Depreciation Charges: - Revisions to operating and depreciation charges accounted for almost one-third of the average annual 8 per cent revision to the net farm income series. Operating and depreciation charges were revised upward on the average by about three per cent per year. Although relatively small, this revision had a significant effect on the downward revision to farm net income since the ratio of farm expenses to gross farm income is relatively high.

Revisions made to estimates for taxes, rent, wages and depreciation charges during the 1941-1951 interval are directly related to the establishment of new bench-marks from the 1951 Census of Agriculture. Changes in the estimated farm expenditures for feeds can be attributed to new methods of estimating feed expenditures and to improved and more complete information provided by the Bureau's Census of Industry Division. Revised estimates of farm outlays for tractors, trucks and automobiles are based on data obtained through a sample survey of selected farm expenditures made in 1952. The revised estimates also include farm costs which had not been included in the original estimates. These include electric power, artificial insemination charges, pure bred livestock registration fees, agricultural limestone and livestock purchases.

FACTORS AFFECTING FARM NET INCOME, 1926-1957

The most important factors affecting farm net income are high variability in volume and prices of farm output on the one hand and a high degree of stability in both volume and prices of goods and services purchased by farmers on the other. It is obvious that when farm output falls as a result of crop conditions or when prices received by farmers for farm products decline, farm net income drops, often precipitously. The variability of farm prices and farm output combine with the stability of farm costs to exert a whip action on farm net income.

For the first three years of the period, farm net income averaged about 630 million dollars per year. Starting in 1929 it dropped very sharply until it reached a level of 136 million dollars in 1931, about one fifth of the 1928 estimate of 642 million dollars. This precipitious drop can be attributed largely to lower cash returns from the sale of wheat in the period 1929-31 and livestock for the years 1930 and 1931. While general farm operating expenses which were charged to the year incurred whether paid or not, were also down during this period, they did not decline as sharply as did cash income partly as a result of increasing interest charges on enlarged farm debt. While cash income and operating expenses continued downward in 1932, net income tended to level off largely as a result of a sharp increase in grain production and a build up of farm-held year-end inventories. Smaller grain production in 1933 and a decline

in year-end stocks on farms more than offset the effects of a further lowering of operating expenses and a slight upswing in cash income due to higher returns from the sale of hogs and fruit.

From the low of 109 million dollars in 1933, farm net income increased slowly during the next eight years until it reached close to 489 million dollars in 1941. While cash income was increasing, during this period farm operating expenses were also following an upward trend but at a slower rate.

Although cash income moved generally upward during the 1933-1941 period there were some variations in the movement of the major items contributing to farmers' cash returns. During 1934, 1935 and 1936 a general upward movement was displayed by all major items. While income from grains was down in 1937 as a result of crop failure in Saskatchewan, this decline was more than offset by the continuing rise in receipts from the sale of cattle, hogs and dairy products. Increased receipts from grains and dairy products in 1938 were more than sufficient to overcome declines in returns realized from the sale of cattle and hogs. In 1939, for the first time since 1932, income from dairy products was down, but this reverse was far outweighed by increased receipts from wheat and a revival of income from cattle and hogs. Income from wheat, down in 1940, was more than offset by increased income from cattle and a spectacular rise in returns from the sale of hogs. This substantial increase in hogs marked the beginning of a sharp upswing in income from this source which was to reach a new record high in 1944.

The effects of changing patterns of farm production to meet war-time needs were becoming evident by 1941. The Wheat Acreage Reduction Program became effective that year and resulted in a reduced income from wheat and a sharp drop in inventories of grain. On the other hand, production of livestock and livestock products increased with the result that income from these sources rose sharply as well as numbers of livestock on farms. The fact that farm net income did not rise sharply in 1941 in sympathy with cash returns was due to the substantial reduction in year-end farm-held stocks of grain which more than offset gains in year-end livestock numbers.

There was a striking rise in farm net income in 1942 from approximately 489 million dollars in 1941 to slightly more than a billion dollars. The largest contributing factor was the record production of grain crops. The production of coarse grains was the largest and the wheat crop the second largest, recorded up to that time. Income from the other field crops, livestock and livestock products also continued to increase with the result that income to farmers was advancing more rapidly than farm expenditures.

Cash income from the sale of wheat in 1943 was substantially higher than a year earlier due to higher prices and larger marketings from the near record 1942 crop. Other field crops, livestock and livestock products maintained their upward climb. However, a substantial reduction in grain production and its consequent effect upon year-end inventories more than offset these gains and net income dropped from slightly more than a billion dollars in 1942 to 792 million in 1943.

Year-end inventories of grains declined for a second year in 1944, but the effect of this on net income was far outweighed by increased receipts from the sale of farm products. Income from wheat exceeded the previous record high established in 1928 and income from livestock and livestock products set new high marks. Farm expenses continued to rise but not as quickly as cash income.

Cash income from the sale of farm products declined in 1945 for the first time since 1932 as the result of a significant drop in returns from the sale of wheat and hogs. Inventories of both grains and livestock declined and farm operating expenses continued to increase with the result that net farm income was estimated at 868 million dollars, well below the 1944 estimate of 1.1 billion dollars.

Net farm income turned upwards again in 1946. A larger wheat crop combined with higher prices and higher returns from cattle, dairy products and other field crops more than offset the effects of substantial declines in returns from the sale of hogs and poultry.

A further gain was made by farm net income in 1947. Generally higher prices and substantial payments made on wheat participation certificates as well as adjustments on wheat and barley deliveries boosted income from the sale of grains. Larger hog marketings and higher prices offset the decline in the marketings of other classes of livestock. Farm operating expenses were up sharply in 1947 with the most significant increase occurring in the case of feeds. Year-end stocks of both grains and livestock on farms were below the 1946 level.

Farm net income reached a near record level of 1.6 billion dollars in 1948. This sharp increase from 1.1 billion dollars to 1.6 billion can be attributed to a record high cash income up to that time which more than offset the effects of increasing farm costs and a decline in the year-end values of livestock inventories on farms. The substantial gain in income can be largely attributed to rising prices and the large sums of money distributed by the Canadian Wheat Board and western grain companies in the form of grain equalization and participation payments.

Cash farm income increased again in 1949 but was more than offset by a lower total

value of farm produce consumed in farm homes, a further decline of the livestock inventories and higher farm operating costs. Larger payments by the Canadian Wheat Board and fairly substantial gains in the returns realized from the sale of wheat, coarse grains, tobacco, cattle and calves contributed largely to the high level cash income.

Farm cash income as well as farm net income declined in 1950. The lower cash returns can be attributed largely to a drop in cash receipts from the sale of grains and substantially smaller grain equalization and adjustment payments than in 1948 or 1949. The substantial decline in income from wheat can be attributed to a lower initial payment after August and a poor quality crop.

Farm net income moved upward sharply in 1951 to a post-war and all-time high of 1.9 billion dollars. A combination of events contributed to this development. Sparked by the "Korean Incident", farm prices in 1951 rose on the average by 13.8 per cent, a rate of increase that was exceeded only in 1948 when farm prices rose by 18.5 per cent. At the same time, farm out-put was 12 per cent higher than the year previous. This combination of higher farm prices and higher farm output resulted in a significant increase in farm cash income and year-end farm inventory values which more than offset the effects of higher farm expenditures. The large year-end inventories can be attributed in the main to large accumulations of threshed and unthreshed grains on Prairie farms due to adverse harvesting conditions.

The following year, 1952, marked the beginning of a precipitous decline in farm prices which continued through 1954 and had a significant effect on farm income during this period.

Farm prices fell by eight per cent in 1952 and largely offset the effects of an increase of seven per cent in farm output and substantial spring marketings of the 1951 grain crop. Compared with the previous year, cash income from livestock was down as a result of lower prices and smaller marketings resulting from restrictions placed on the movement of livestock due to the outbreak of foot-and-mouth disease in February. In total, farm cash income increased at about the same rate as farm expenditures with the result net income in 1952 was substantially the same as in 1951, namely, 1.9 billion dollars.

Farm operators' net income fell for the second consecutive year in 1953 as the result of a decline in farm output and a further decline of 9 per cent in farm prices. Year-end farm inventory values increased again, but at only about a third the rate of 1952. The lower rate of inventory accumulations in 1953 compared with a year earlier can be attributed to lower farm output as well as to the removal of restrictions on the movement of livestock. Measures taken

to eradicate the outbreak of foot-and-mouth disease in February 1952, were removed in March 1953, permitting the resumption of normal livestock marketing. In brief, about two thirds of the decline in net farm income in 1953 from the level of a year earlier, can be attributed to a much lower accumulation of inventories and about one third to a decline in cash income. Farm operating costs were only very slightly below the 1952 level despite the fact that prices of goods and services purchased by farmers declined by almost four per cent. This was the first year that prices paid by farmers had declined since 1939.

Net income to farm operators fell to a post-war low of 1 billion dollars in 1954, the end of the precipitous decline so evident since 1951. The drop of six hundred million dollars in farm net income compared with a year earlier, can be attributed not only to a further decline of about 7 per cent in farm prices, but also to a significant reduction in farm output. Rust damage reduced both the quantity and quality of the 1954 western grain crop, and year-end inventory values declined for the first time since 1949. Farm operating expenses, although at a near record high, contributed little to the marked decline in net farm income in 1954 because they remained substantially the same as during the two previous years, namely, 1.6 billion dollars.

Farm prices continued to decline in 1955, but at a greatly retarded rate (about one per cent) compared with the three previous years when they declined on the average by about 8 per cent per year. Farm output, on the other hand, increased by 28 per cent over 1954. Despite these two favourable developments, cash farm income declined slightly to 2.3 billion dollars, the lowest level since 1950. This decline in cash farm income can be attributed largely to lower returns from the sale of oats, barley, rye, hogs and total participation payments. The effects of lower cash income were, however, offset by an increase in year-end inventory values with the result that net farm income increased from 1 billion dollars in 1954 to 1.3 billion in 1955.

Net income to farm operators increased for the second consecutive year in 1956, to 1.5 billion dollars. This estimate of 1.5 billion dollars can be attributed largely to a further increase in the farm output of both grain and livestock, a leveling out of farm prices which remained at substantially the same levels as in 1955 and a further significant increase in farm inventories at the end of the year. This combination more than offset the effects of an increase of farm operating costs which increased from 1.6 billion dollars to 1.8 billion dollars. The higher farm operating costs can be attributed to a combination of both higher

prices paid for goods and services used by farmers and the more widespread use of new materials and equipment.

After moving slowly upward for two years, farm net income dropped back in 1957 to the 1954 level of slightly more than 1 billion dollars. This decline of 28 per cent can be attributed to lower net income to farmers in all provinces except British Columbia and Ontario where it increased by 4 per cent. Farm net income was about 25 per cent, 4 per cent and 47 per cent lower in 1957 than in 1956 for the Maritime Provinces, Quebec and the Prairie Provinces respectively. The increase in Ontario and British Columbia was almost sufficient to offset the decline in Quebec and the Maritime Provinces. As a result, 395 million of the Canadian total decline of 403 million dollars in farm net income can be accounted for by the drop in the Prairie Provinces which was due to a smaller grain crop and smaller grain marketings compared with a year earlier.

Farm expenses and depreciation charges were smaller in all provinces in 1957 than a year earlier. This tended to somewhat offset the effects of lower incomes.

THE SCOPE AND SOURCES OF DATA USED IN FARM INCOME ESTIMATES, 1926-1957

Much of the data required for direct documentation of farm income was available as "official" statistics derived from regularly conducted surveys of the Dominion Bureau of Statistics, or was obtainable from non-Bureau agencies whose functions included the continuing collection of particular statistics. The latter are "secondary" statistics to the Bureau.

After these sources were exhausted, the many remaining gaps in the data required for farm income estimates were filled by "calculated" data involving interpolations, projections, supply disposition balance sheets and even arbitrary assumptions.

In the descriptions of scope and sources of data to follow, it is intended to distinguish the above three sources as (1) official, (2) secondary, and (3) calculated; these terms will be used exclusively in that sense below. In the case of secondary data, the originating agency will be named.

This outline is intended only as a broad guide to content and source. It is hoped that, at a later date, time will permit the preparation of a more detailed account of sources and methods for the use of interested individuals and organizations.

CASH INCOME FROM THE SALE OF FARM PRODUCTS

Estimating cash income from the sale of farm products normally involved separate estimates of two components, (1) marketings (excluding interfarm transfers) and (2) farm prices

per unit of marketing. The products included for cash income purposes varied as between provinces and in some cases were included for only part of the period 1926-1957. The criterion for inclusion was the relative importance of the product in sales of farm products of the individual province. Availability of information was not a criterion respecting products to be included, even though scarcity of official or secondary data in the earlier years of the period necessitated considerable use of calculated data.

The scope and sources of marketings are described below. With respect to farm prices, two types were generally used: (1) farm prices collected by means of a regular monthly mail questionnaire survey, and (2) calculated prices obtained by subtracting transportation and handling charges from terminal or wholesale market prices. These two types of prices were those most commonly used in the calculation of farm cash income from the sale of farm products and no further reference will be made to them.

Field Crops

Wheat, Oats, Barley, Rye and Flaxseed: - For each of the Prairie Provinces, marketings of these five grains were obtained from the Statistics Branch of the Board of Grain Commissioners for the entire period 1926-1957.

Marketings of wheat in each of the Maritime Provinces and Quebec were considered only for the period 1926-1941 inclusive and were calculated by assuming the percentage relationships between marketings and total farm production were the same as reported by the Censuses of Agriculture. Marketings of oats and barley in these provinces were calculated for the period 1926-1940 by a supply-disposition balance sheet and for the period 1941-1957 by means of a marketing-production percentage from the 1941 Census of Agriculture.

Ontario marketings of wheat were estimated by assuming a marketing-production ratio of one-third for the period 1926-1945. For the years 1946-1948 marketing information was obtained from the Canadian Wheat Board. Since 1948, it has been assumed that Ontario wheat marketings were equal to the amounts milled and the quantities exported plus an allowance for local transactions. Rye and flaxseed marketings were based on a marketing-production ratio for the entire period 1926-1957.

In British Columbia, farmers' marketings of wheat, oats and barley were calculated for the period 1926-1935 by using Census of Agriculture data and official carloadings. From 1936-1950 for wheat and from 1936-1957 for oats and barley, marketing estimates were based on official milling statistics and information supplied by the Board of Grain Commissioners. Since 1950,

farmers' wheat deliveries have been estimated by means of marketing data reported by the Board of Grain Commissioners for designated areas of the Canadian Wheat Board in British Columbia and a marketing-production ratio for the remainder of the province. Flaxseed marketings were derived from statistics of the Board of Grain Commissioners.

Potatoes: - With the exception noted below, marketings were calculated for each province by means of marketing - production ratios derived from the Censuses of Agriculture, surveys of the Department of Agriculture, and supply disposition balance sheets. For Prince Edward Island, data on potato shipments out of the province were provided by the provincial Department of Agriculture from 1949 to date.

<u>Tobacco</u>:- Official statistics of the value of total tobacco production were used as the estimate of income from the sale of this product.

Fruits: - Official estimates of the value of commercial production of fruits were used as the value of marketings.

<u>Vegetables:-</u> From 1926-1938, marketings were estimated by means of marketing-production ratios derived from the Censuses of Agriculture. Since 1938, official estimates of commercial production were used.

Other Crops (corn, sugar beets, clover and grass seed, hay and clover, fibre flax and miscellaneous items)

Corn: - Ontario marketings for the period 1926-1957 were calculated by, means of marketing-production ratios derived from the Censuses of Agriculture.

Marketings in Manitoba were calculated for the period 1939-1944 using official carloading data and an allowance for sales to local agents. Since 1944 marketings have been based on inspection statistics from the Board of Grain Commissioners.

<u>Sugar Beets</u>:- For the years 1926 to 1940, income figures were calculated from reports on the sugar industry. Since 1940, returns to farmers were reported by all sugar beet processors.

Clover and Grass Seed: - Production and price data were obtained from the Federal Department of Agriculture for each province. It was assumed that all production of seed would be marketed.

<u>Hay and Clover: - Marketings</u> for each province were calculated from official carloading data by assuming all hay loaded was destined for inter-provincial shipment or sale to non-farm industries.

Fibre Flax: - Information regarding production and value was obtained during the war years from the Fibre Flax Controller of the Agricultural Supplies Board and since that time from the Fibre Flax Division of the Central Experimental Farm.

Miscellaneous: This item includes farm products which were not of sufficient importance to be listed separately. The estimate for the total of these items was calculated as a certain percentage of total cash income excluding income from the sales of furs and forest products. This percentage relationship was computed from the Censuses of Agriculture, and applied to the intercensal years with such adjustments as seemed warranted by relative price changes and production trends.

Livestock and Products

Marketing data used for livestock and poultry since 1940 were official figures. The sources of data for the period 1926-1940 were as follows:

Cattle and Calves: For the years 1926-1934 in the Maritime Provinces and British
Columbia, marketings were calculated from the 1931 Census of Agriculture with annual projection
according to official numbers on farms. From 1935 to 1940 a disposition balance sheet was used.
Sales in Quebec, Ontario and the Prairie Provinces were calculated for the period 1926-1940 using
commercial marketing data of the Federal Department of Agriculture plus an allowance for local
sales off farms.

Hogs:- Marketings in the Prairie Provinces were calculated during 1926-1940 as commercial marketings plus an allowance for local sales. Marketings in Ontario and Quebec were similarly calculated for the period 1926-1934, but for the years 1935-1940 the basis of calculation was a disposition balance sheet. For the Maritime Provinces and British Columbia annual sales were calculated for 1926-1934 using Census of Agriculture data projected according to official numbers on farms. A disposition balance sheet was used for 1935-1940.

Sheep and Lambs: For Quebec, Ontario and the Prairie Provinces, marketings were calculated for the period 1926-1940 using commercial marketing data supplied by the Federal Department of Agriculture plus an allowance for local sales off farms. Sales in the Maritime Provinces and British Columbia 1926-1939 were calculated as projections of Census of Agriculture data according to official numbers on farms. For the year 1940, sales in these provinces were calculated from commercial marketing data with allowance for local sales off farms.

Dairy Products: - Marketings of dairy products included milk and cream sold off farms for fluid purposes and for manufacturing purposes and sales of dairy butter. Official sales for manufacturing purposes were used for the entire period 1926-1957. Fluid sales and sales of dairy butter were calculated for the period 1926-1939, but since 1939 official sales were used.

Eggs:- From 1941-1957, official marketings were used. Prior to 1941, marketings of eggs were calculated by using official production estimates in conjunction with marketing-production ratios derived from the Census of Agriculture and adjusting the results to bring them into line with levels established by the 1941-1956 estimates.

Other Livestock and Products (fur, wool, honey and horses)

Furs: - Marketings and prices were official estimates for the entire period 1926-1957.

<u>Wool</u>:- For the years 1926-1938 sales of wool were calculated from official production estimates and data supplied by the Canadian Co-operative Wool Growers Association. Since 1938, wool sales were official estimates.

Honey: - Marketings of honey and beeswax were official production estimates less quantities consumed by producers for the entire period 1926-1957.

Horses: - From 1926 to 1947 sales of horses in the Prairie Provinces were based on exports and shipments through stockyards at St. Boniface, Manitoba. For the years 1940 to 1947 in eastern Canada and British Columbia, sales of horses were estimated from official livestock statistics. For the years 1926 to 1939 in eastern Canada and British Columbia and for 1948 to date for all Canada, the methods of estimation were similar to those outlined above for miscellaneous field crops.

Forest Products: - The value of sales was calculated, 1926-1940, by using data from the Censuses of Agriculture and official estimates of the annual value of forestry production. Since 1940, estimates are those provided by the Forestry Section of the Dominion Bureau of Statistics.

<u>Maple Products</u>:- Marketings were calculated from official production estimates and Census of Agriculture data on producers' consumption.

SUPPLEMENTARY PAYMENTS

Prairie Farm Assistance: - Under the provisions of the Prairie Farm Assistance Act, passed in June 1939, assistance is given to Prairie Farmers who suffer low yields because of factors beyond their control. This assistance takes the form of cash payments made out of a fund provided by government contributions and a one per cent levy on the value of all grain marketed from farms in Western Canada.

Prairie Farm Income Plan: - Effective only for the 1941-1942 crop year, this emergency measure was designed to help low income western wheat farmers. Direct payments were made to these farmers in order to provide sufficient income to maintain them on the land.

Wheat Acreage Reduction Program: The main purpose of this program was to remedy a critical situation arising from a large crop and a loss of export markets for wheat during the early years of World War II. Commencing in the spring of 1941 and continuing until the end of the crop year 1943-1944, this plan provided for cash payments to farmers for acreages diverted from wheat growing to summer-fallow and the production of grass and coarse grains.

INCOME IN KIND

This income represents the value of that produce grown by farm operators and consumed in the farm home together with an imputed rental value of the farm dwelling. The home-consumed produce was valued at its alternative market price, i.e., the price the farmer would have received had it been sold.

<u>Dairy Products</u>:- The estimates of this item were official estimates and included fluid milk, butter and cheese.

Poultry & Eggs: - Official estimates were available only for the period 1938-1957.

Estimates for the years 1926-1937 were based on the official estimate for 1938 extrapolated according to estimates of the value of home-consumed poultry and eggs reported in Appendix 4 to the Report of the Royal Commission on Dominion-Provincial Relations, 1939.

Meat: For the years 1926 to 1937 estimates were calculated from the 1941 Census of Agriculture with annual projections according to charges in livestock prices and estimated farm population. For the years 1938 to date estimates were based on the Censuses of Agriculture with annual projections according to data provided by official livestock surveys.

Fruits and Vegetables: - The value of this produce grown on farms for home use was calculated from the Censuses of Agriculture for 1920, 1930 and 1940 with annual projections for the years 1926-1934 according to the official wholesale price index for fruits and vegetables. Since 1934 annual estimates were based on the official index of farm prices of these products and changes in farm population.

<u>Potatoes</u>:- The quantity of potatoes consumed in farm homes was estimated at 275 pounds per capita for persons living on farms.

Honey: - Home consumption of honey 1926-1937 was calculated by means of a consumptionproduction ratio applied to annual official production figures for the period. For the years 1938 to 1948 inclusive, it was assumed that consumption amounted to 25 pounds per beekeeper. Since 1948 data have been derived from official annual honey surveys.

Maple Products: - Consumption of maple products in farm homes was calculated by means of a consumption-production ratio derived from the Census of Agriculture 1941 and applied to official annual production data.

Forest Products: - This item included firewood, fence rails, fence posts and logs for lumber. For the years 1926-1940, it was calculated from the Censuses of Agriculture with annual projections according to official estimates of the annual value of the production of firewood. Since 1940, estimates are those provided by the Forestry Section of the Dominion Bureau of Statistics.

<u>Wool:</u> - For the years 1926 to 1938 the value of home-consumed wool was calculated by subtracting cash receipts from the sale of wool from the total value of wool production. Since 1938, wool sales were official estimates.

Cereal Products: - Official country milling statistics were used for the years 19261937. Estimates since 1937 were based on the value of those products which were produced through custom and exchange grinding and assumed to be used for human consumption.

House Rent: - House rent was imputed on the basis of the actual cost of maintaining the farm home and was calculated by making an allowance for repairs, depreciation, return on investment and taxes. The cost of repairs, depreciation, interest and taxes on farm dwellings were already included in the totals for these items in farm business expenditures. Since these are farm family living costs and not farm business expenditures, imputing a rental value and including it in income in kind was equivalent to deducting them from general farm operating expenses.

FARM OPERATING EXPENSES & DEPRECIATION CHARGES

Operating Expenses

These outlays represent the cost to farmers as a group of earning income from farming operations and, as far as possible, exclude those amounts which farmers paid to other farmers. These estimates represent operating expenses incurred whether paid for in cash or accumulated as new debt. In most cases, estimates of farm operating expenses were calculated estimates, i.e., they were not the direct product of regularly conducted official surveys of farm operating expenses. In compiling farm operating expenditures, all subsidy payments were taken into account. Thus the estimates of expenditures represent only the net amounts paid by farmers. In the case

of taxes, interest on mortgages, repairs and depreciation of farm buildings only those amounts paid an owner-operated farms were included under these headings. The share of these expenses, chargeable to rented farms, were included in the gross rent estimates.

Taxes:- For the period 1926 to 1939 the tax estimates used were those prepared for the Royal Commission on Dominion-Provincial Relations 1939, with adjustment for consistency with the Census of Agriculture, 1941, and to include only taxes on owner-operated farms. Since 1939, taxation estimates were Census of Agriculture data projected according to rural-municipal taxation figures supplied by the Bank of Canada. Taxes on tenant-operated farms were covered in the item, gross farm rent.

Gross Farm Rent: This item represents the amount paid by tenant-operators, whether cash, kind or share, for the use of farm property including farm houses and purports to cover taxes, return on investment, repairs and depreciation on buildings. These estimates were calculated from Census of Agriculture data projected annually according to official estimates of the values per acre of farm land and the value of field crop production.

Hired Labour: This item includes the amount of wages paid and the value of room and board provided hired farm help. From 1926-1942 the estimate of wages paid was calculated from Census of Agriculture data projected according to changes occurring in the hired farm labour force and official farm wage rate information; since 1942 these estimates were based on the Censuses of Agriculture and the annual average total farm wage outlay per farm secured from the annual December survey. The value of room and board provided was calculated from Census of Agriculture data projected according to the changes taking place in the farm labour force and the official index of farm family living costs.

Interest on Farm Indebtedness: This comprises interest paid on farm mortgages, agreements for sale and other indebtedness incurred in the promotion of the farming enterprise by farm operators. Mortgage estimates were calculated from Census of Agriculture data projected according to changes which occurred in institutional holdings of farm mortgages. Other indebtedness estimates were also calculated from Census of Agriculture data, reports on activities carried out under the terms of the Farmers' Creditors Arrangement Act, the Farm Improvement Loans Act, and information gleaned from Appendix 4 of the Royal Commission on Dominion Provincial Relations, 1939, farm management studies, etc. Interest rates were official data.

Feed & Seed: - This item of farm operating expense included only feed and seed purchased through commercial channels and was a calculated estimate. It excluded direct inter-farm transfers

of grain, but included those grains which shipped from West to East and those grains sold to country elevators and later repurchased by western farmers for feed and for seed. Farmers' annual purchases of commercial whole grains were calculated from a supply disposition balance sheet for the period 1926-41; since 1941 they were based on freight assistance shipments of whole grain from West to East adjusted for quantities of these grains used by the feeds industry and on sales out of western country elevators for feed, seed and local gristing. Estimated purchases of processed feeds were based on official statistics of the feeds industry. A supply-disposition balance sheet was used in preparing estimated purchases of millfeeds and high protein feeds. Quantities of seeds used for such crops as sugar beets, turnips and hybrid corn were calculated from official acreages and rates of seeding.

Tractors, Combines & Gasoline Engines: This item was calculated. Numbers on farms were official Census of Agriculture data projected on the basis of annual sales and allowances for depreciation in the case of tractors and combines, and straight-line interpolations for stationary gasoline engines. Average fuel, oil and grease consumption per unit was based on information obtained from the Engineering Department of the Central Experimental Farm, farm management studies and official Bureau surveys. The cost of labour spent exclusively on repairs was calculated as a fraction of total outlay for fuel and lubricants. This fractional relationship was calculated from data obtained from the United States Department of Agriculture; no allowance was made for repair parts as they were included with the expense item machinery repair parts.

Trucks & Automobiles: These estimates were calculated and purport to show farmers' outlays for the use of these vehicles on farm business only. Numbers on farms were Census of Agriculture data projected according to official statistics of motor vehicle registrations.

Consumption of gasoline and lubricants per vehicle was established from information provided on surveys made by the Dominion Bureau of Statistics and the Departments of Agriculture of Canada and the United States. Prices of petroleum products were obtained from official estimates.

License fees were calculated from official registration statistics. Outlays for tires and tubes were calculated from replacement factor data obtained from the United States Department of Agriculture and prices and sizes provided by one of the large Canadian manufacturers. Repairs and insurance were calculated by assuming a direct relationship to estimated total cost of above-mentioned items.

Blacksmithing & Machine Shop Charges: - Estimates were calculated by projection of farm management survey data according to an index of farm machinery repair part costs.

Binder Twine: - Estimates were calculated by projecting Census of Agriculture data according to changes occurring in binder twine prices and the area harvested by binder. Consumption of twine per acre harvested is based on information obtained from the Departments of Agriculture of Canada and the United States.

Baler Twine & Wire: - Numbers of balers on farms are assumed to equal cumulative sales each year since introduction of the pick-up baler. The relationship of balers using twine and those using wire is based on the situation prevailing in the United States and recorded by the United States Department of Agriculture. Data concerning the consumption of twine per baler has been supplied by the Department of Agriculture and dealers handling this commodity. Purchases of baler wire are related to official statistics on baler-wire production.

Fertilizers: - Estimated purchases are based on official statistics of sales of fertilizers for other than manufacturing purposes. Prices were obtained from fertilizer companies. An allowance was made in eastern Canada and British Columbia for purchases of manure.

Agricultural Limestone: - Estimates were prepared for Prince Edward Island, Nova Scotia, New Brunswick, Quebec, Ontario and British Columbia. Provincial Departments of Agriculture provided information regarding quantities purchased and prices paid by farmers.

Fruit & Vegetable Supplies: - This item includes farmers' expenses for pesticides and containers. The estimates were calculated from Census of Agriculture data adjusted for memory bias and projected according to official annual statistics concerning the value of production of pesticides, cooperage, boxes and crates.

Nursery Stock: This item was calculated and covers the amount spent for the purchase of nursery stock for orchards and small fruits. Census of Agriculture data were used and projected with official annual value of sales by nurserymen for the years 1926 to 1942 and 1949 to date. For the intervening years projections were based on trends of prices and quantities sold as reported by the Central Experimental Farm.

<u>Fencing</u>:- These estimates were calculated from official statistics of production, import and export of woven wire, poultry netting, barbed wired, steel posts and wire staples. An allowance was made for the use of wooden posts.

Machinery Repair Parts: - Official statistics of repair part sales were used for the years 1943 to date. For the period 1926 to 1942, estimates were calculated by using the official figures for 1943 and projecting them back by means of information obtained from a partial survey of the industry which was made by the Royal Commission on Dominion-Provincial relations, 1939.

Repairs to Farm Buildings: This estimate covers only buildings on owner-operated farms; the outlay for repairs on rented dwellings is covered in the estimate of gross farm rent. For most of the period 1926-1957 this expenditure was calculated as a fraction of the annual estimate of the value of farm buildings. The annual estimates of the value of farm buildings were based on Census of Agriculture data projected by means of official annual statistics of the value per acre of farm land, including buildings. In more recent years, projections have been made according to information obtained from the Economics Branch of the Department of Trade and Commerce.

Feeder Cattle and Calves: - This item includes only expenditures by Ontario farmers for western feeder cattle and calves. Data required for these estimates were obtained from the Department of Agriculture.

Livestock Registration Fees: - This includes membership fees for purebred livestock associations and the cost of registration and ownership transfer of purebred livestock. Information required for these estimates is obtained from Canadian National Livestock Records and the Holstein - Friesian Association.

Livestock Breeding Fees: - Only farmers' expenditure for artificial insemination are considered. Estimates for Ontario were prepared for the period 1949 to 1956 from information supplied by the Provincial Department of Agriculture. Estimates for the remaining provinces, available only for the years 1955 - 1957, are based on data obtained from the Federal Department of Agriculture.

Electric Power: This estimate of farm expense was prepared only for the years 1941-1957 inclusive and covered only the cost of power from central electric power stations. Total cost of electric power to farm users was derived from the Census of Agriculture and official statistics regarding value of central electric power supplied to farm users. One half of the total estimate was charged to the farm business.

Irrigation Charges: - This item of expense is included only for the two provinces of Alberta and British Columbia in which practically all of the commercial irrigation projects are located. Areas irrigated and charges per acre for the various areas were obtained from the provincial government sources. Costs of private irrigation projects were not considered as it was assumed that these costs were included in other farm expenses.

Miscellaneous: - This item includes farmers' expenses for veterinary services, rope, salt, small tools, hardware and repairs to harness. It was calculated at 5 per cent of total cash operating expenses, excluding interest in all provinces and, in addition, feed and seed in

the Prairie Provinces.


Depreciation Charges

Depreciation is a charge to farming operations for the use of farm buildings and machinery acquired for the promotion of the farm business; this charge is made annually over the estimated useful life of the asset and is in proportion to the number of years it is expected to be in use. The item was intended to cover that part of depreciation and obsolescence which cannot be offset by repairs.

Buildings: This item covering only depreciation on farm buildings on owner-operated farms was calculated on the basis of a 4 per cent rate charged against the estimated annual inventory value of farm buildings. The method of computing the annual value of farm buildings is outlined above for repairs to farm buildings.

Machinery: - The rates of machinery depreciation were those used in the Report of the Royal Commission on Dominion-Provincial Relations, 1939. They were 7 per cent for eastern Canada and British Columbia and 11 per cent for the Prairie Provinces. Annual inventory values of farm machines to which these depreciation rates were applied, were calculated from Census of Agriculture data, adjusted intercensally by annual allowances for depreciation and retail value of new sales.

Value of Inventory Changes: - This item includes the value of physical changes of farmheld year-end inventories of grain and livestock. Physical inventory changes were calculated from official inventory estimates and valued at annual average prices.


