FPCC December meeting

Council members met on December 11 to 13, 2018, and discussed a number of files related to the national marketing and promotion and research agencies, and upcoming 2019 activities and commitments. In addition, members were also briefed by the Assistant Deputy Minister of the Strategic Policy Branch, Mr. Tom Rosser, from Agriculture and Agri-Food Canada on various policy files.

On December 11 and 13, members met the Executive Committee and staff of the Egg Farmers of Canada (EFC) and Chicken Farmers of Canada (CFC). These sessions were great opportunities to have informal and frank discussions on the agencies accomplishments of 2018, as well as their strategic objectives, critical issues and challenges for 2019. Council looks forward to progress reports in the months to come.

On December 12, members participated in a strategic planning retreat with Larimar Strategies, a consulting firm. During this exercise, members consolidated the previous years' strategic gains and reviewed the recent consultation sessions conducted with industry stakeholders and FPCC staff. Council priorities were discussed and the foundations for new initiatives were outlined and developed. The FPCC will continue to keep *FOCUS* readers informed on the progress of this project.

Additionally, during this meeting, the FPCC approved the following agencies proposed regulatory amendments:

Canadian Hatching Egg Producers

Council members approved CHEP's proposed addendum to their Liquidated Damages Agreement to adopt a contingency sleeve as per section (3) (a) of the Federal-Provincial Agreement for Broiler Hatching Eggs. CHEP will approve or revise the contingency sleeve at the same time they approve or revise the allocation for that year. Following the five year period, CHEP will review the impact of the contingency sleeve and determine if the addendum will be continued and for what length of time.

Egg Farmers of Canada

Council members approved the Canadian Egg Marketing Levies Order, which extends the expiry date to March 28, 2020, and the Canadian Egg Marketing Agency Quota Regulations, 1986 (schedules 1, 1.1 and 1.2) for the period of December 30, 2018 to December 28, 2019.
