FPCC January meeting

Council members met on January 15, 2019, and discussed a number of files related to the national marketing and promotion and research agencies.

On January 15, members met the Executive Committee and staff of the Canadian Hatching Egg Producers. This session was a great opportunity to have informal and frank discussions on the Agency's accomplishments of 2018, their 2019 Budget, and critical issues and challenges for 2019. Council looks forward to progress reports in the months to come.

Additionally, during this meeting, the FPCC approved the following agencies proposed regulatory amendments:

Canadian Hatching Egg Producers

Council members considered and approved CHEP's request to amend their Levies Order. This represents two decreases, the first to the national levy from \$0.0032 per broiler hatching egg to \$0.0030, and the second, the levy rate for eggs marketed from a non-signatory to a signatory province from \$0.0127323 to \$0.012399.

Chicken Farmers of Canada

Also during this meeting, Council members considered and approved the Canadian Chicken Marketing Agency Quota Regulations (for periods A-155 and A-156), as well as the Levies Order which maintains the national levy at 0.53 cents/kg.

Turkey Farmers of Canada

Additionnally, Council members considered and approved the Canadian Turkey Marketing Agency Quota Regulations, 1990 request to amend their current quota allocation. This amendment represents an increase of 0.3% over the allocation approved by FPCC in October 2018 and responds to the need to make adjustments to section 1 (whole turkey) and section 2 (planned production) of the export allocation.
