GLOSSARY

Glossary of Terms

Affiliate

A TV (or radio) station which agrees to carry the programming of a network. Also applies to cable systems in carrying specialty and pay programming services.

Affiliation agreement

In conventional broadcasting, the agreement made between an affiliate and the network operator establishing the terms of program carriage, compensation paid to the affiliate for the network's use of the affiliate's air time, and commercial revenue sharing and payments for advertisements aired during the network's programs.

The affiliation agreement made between cable systems and satellite programming service providers is different from the agreement made between conventional networks and over-the-air affiliates. The agreement between a cable system and a specialty service authorizes the cable system to receive and redistribute the service's programming to subscribers in return for a per-subscriber fee paid to the specialty service provider (the wholesale price). Cable systems in turn charge a retail fee to subscribers which includes overhead and a profit margin. Generally, the affiliation agreement also includes a commitment on the part of the cable system to promote and market the specialty service in its licensed territory.

Anik C3

The name given to Telesat Canada's medium-power Ku-Band satellite which carries television signals. Anik C3 was launched in November, 1982 by the space shuttle Columbia. See also Ku-Band.

Anik D1

The name given to Telesat Canada's less powerful C-Band satellite which carries television signals. Anik D1 was launched in August, 1982. See also C-Band.

Available services

Term used to denote satellite programming services that are legally available to individual satellite dish owners. There are two kinds: (i) "free" services, which are available simply by tuning the satellite signal receiver, and (ii) discretionary services, which require the individual to subscribe to the service through the payment of a monthly fee to the service provider.

Authorized services

Satellite programming services that are permitted carriage on Canadian cable systems by the CRTC.

Beam

The directional pattern of a satellite's antenna. The Anik D1 satellite has a single beam covering virtually all of Canada (and northern U.S.). The Anik C3 satellite has two beams, one covering western Canada, and the other covering eastern Canada.

C-Band Satellite

Low-power satellite using the 6/4 GHz frequencies. The 5.925 - 6.425 GHz band is used to transmit signals from earth to the satellite (uplink), while the 3.7 - 4.2 GHz band is used for space-to-earth transmissions (downlink). Susceptible to terrestrial interference, particularly in urban areas. Nonetheless, most satellites used for television distribution today are C-Band. Because of the low power, large dishes of up to three meters in diameter are required to receive signals transmitted by C-Band satellites.

Canadian Satellite Communications (CANCOM)

Licensed by the CRTC in 1981 to provide broadcast services to rural and remote communities (underserved communities) by satellite. The need for such a service had been identified by the Therrien Committee on Extension of Services to Northern and Remote Communities. The Committee had recommended in its report to the Chairman of the CRTC in July, 1980, that the CRTC proceed to licence such a service on an urgent basis. CANCOM also provides U.S. signals to some urban cable systems which would not otherwise receive all U.S. network signals (ABC, CBS, NBC, plus PBS) or which were otherwise receiving poor-quality signals delivered by terrestrial means, such as microwave. As of August, 1987, CANCOM was providing service to 1.4 million households in over 1,000 communities via cable and community rebroadcasting systems, and to 4,200 individual home dish owners (DTH service).

Conventional Broadcasting Signals

Signals transmitted by television and radio stations over-the-air for reception by home antenna. The "original" kind of broadcasting transmission. See also over-the-air transmission and off-air reception.

Core Community

See underserved community.

Direct-to-Home Broadcasting (DTH)

The sale of a satellite-delivered programming services directly to individuals who own satellite dishes.

Descrambler

Also called a decoder. A device used by television viewers to restore a scrambled television signal to a normal TV picture to enable viewing.

Discretionary service

A programming service delivered (usually, but not always, by satellite) to redistribution systems and to individuals for which payment of a fee to allow viewing is required.

Dish

See TVRO.

Downlink

A signal transmitted from a satellite down to receiving dishes on earth.

Footprint

Term used to describe the geographical coverage area of a satellite's transmission.

Geostationary orbit

The circular orbit about 36,000 km above the equator where satellites have an orbital period of 24 hours and therefore appear stationary from any point on earth. That is, the position of the satellite relative to the earth does not change.

Gigahertz (GHz)

A Gigahertz is a unit of frequency in the radio spectrum. One GHz is one billion hertz. The 6/4 GHz and 14/12 GHz frequencies are used by satellites that transmit television programming.

International Telecommunications Union (ITU)

The ITU establishes technical regulations for the operation of telecommunications services across international frontiers, including satellite-delivered television programming. It is a specialized agency of the United Nations with a membership of 161 countries, including Canada.

Ku-Band Satellite

Medium-power, second generation of satellites using the 14/12 GHz frequencies. The 14.0 - 14.5 GHz band is used to transmit signals from earth to the satellite (uplink), while the 11.7 - 12.2 GHz band is used for space-to-earth transmissions (downlink). More powerful and less susceptible to terrestrial interference (save for "rain fade") than C-Band, and a smaller dish of less than 2 meters in diameter is all that is needed to receive TV signals. However, Ku-Band transmission are susceptible to "rain fade", interference caused by heavy rainfall. Many Canadian services transmit on the Anik C3 Ku-Band satellite. It is estimated that only 5% of home dish owners own a Ku-Band dish.

Network Feed

Part of a conventional TV network's programming transmitted in unfinished form to affiliates. Satellites are used by many networks to deliver both taped and live programming to affiliates, where the latter inserts commercials, and either airs the program as received (live), inserting commercials where necessary, or records the program for playback at some other time. While the home dish owner is capable of receiving these signals, they are not intended for reception or viewing by the public, since they do not comprise the complete schedule intended for conventional transmission "over-the-air" by stations affiliated to the network.

Oak Orion

The **encryption** system used by CANCOM and TSN for scrambling their signals.

Off-air Reception

The reception of conventional broadcasting signals by home antenna transmitted by a terrestrial-based TV transmission tower.

Over-the-air Transmission

The transmission of a conventional broadcasting signal by a terrestrial-based transmission tower.

Pay-Per-View

Discretionary programming that is requested and paid for by subscribers on a per-program basis.

Pay-TV Service

A programming service for which viewers pay directly and that generally focusses on a particular type of programming, such as sports or movies, but that also features some variety and premium entertainment specials not available on advertiser-supported television. Pay services are generally distinguished from discretionary specialty services in that they are commercial-free and rely solely on subscriber revenue for revenues. First Choice, Superchannel and Super Écran are the Canadian Pay-TV services.

Private Right of Action

A right of a service provider to launch a civil suit for damages for unauthorized reception and/or redistribution of a programming service which causes a loss, or the right to obtain an injunction against such activity.

Programming Service

A service that is licensed by the CRTC to use the airwaves to provide TV programming to the public.

Redistribution System

Collective term used to denote systems, such as Cable TV and SMATVs, that receive programming service transmissions and redistribute them to subscribers.

Satellite Master Antenna Television (SMATV) System

A redistribution system serving a multiple-dwelling unit (for example, a hotel, an apartment building, or a condominium), with building-top receiving equipment, such as a satellite dish, and a distribution link by wire throughout the building. SMATVs perform essentially the same function as cable systems, but the area of service is generally restricted to the building itself.

Satellite Program Packaging Service

A programming service that groups, or packages, various separate programming services together for distribution as a package. While each individual signal in the package requires a separate satellite channel for both transmission and reception, the package is "kept together" through the use of a scrambling code common to all signals in the package. The package may contain solely conventional television stations, or it may contain some conventional signals and some specialty services, or it may contain only specialty services. The only Canadian satellite programming package service is Canadian Satellite Communications (CANCOM).

Scrambler

A device used by service providers to electronically alter a signal so that it can only be viewed on a TV set equipped with a decoder. The actual process of scrambling the signal is called encryption.

Service Provider

Also referred to as programming service provider. An entity that provides a programming service to the public.

Specialty Service

A programming service featuring one specific kind of programming, such as all-sports or all-music. Most specialty services are discretionary, and rely on both commercials and subscriptions for revenue. Accordingly, the monthly subscription to a specialty service generally costs less than a subscription to a Pay-TV service.

Spillover

Satellite signal coverage pattern beyond the intended primary coverage area. For example, satellite signals consisting of television programming intended for audiences in Canada that are carried by Canadian satellites, also spillover into much of the U.S.

Super station

Local conventional TV station which achieves national distribution through the use of a satellite.

Telecommunications Programming Services Tax

More commonly referred to as the "cable tax". In general, the tax applies to the amount charged for the provision of a television or radio programming service, including installation, where that service is provided by means of telecommunications, and is payable by the person providing the service. The tax also applies to equipment used to receive programming services provided by telecommunications, including satellite dishes and descramblers.

The tax is currently 8%, but will rise to 10% effective January 1, 1988.

The tax applies regardless of whether the service is authorized or not, and regardless of the technology used to provide the service. In addition to cable, pay television and specialty services, the following services are also taxable: SMATV, if a separate charge is made for the provision of that service; and, movies provided on televisions in hotel rooms for a separate charge where the movie is provided by means of telecommunications.

Although the tax was established to help finance the assistance to producers provided by the Broadcast Fund, it is not a dedicated tax. Rather, the revenues flow into the Consolidated Revenues Fund in common with most other taxes.

Telesat Canada

Telesat Canada is the company created by Parliament in 1969 to develop, own and operate a commercial satellite system for national telecommunications. Its ownership is shared by the government of Canada and Canadian telecommunications common carriers. Currently, it is a monopoly: all commercial Canadian satellites are owned and operated by Telesat.

Transponder

The electronic package for one satellite radio channel, typically with a bandwidth of 36 MHz to 54 MHz.

TVRO

TV Receive Only earth station. A parabolic dish capable of receiving TV signals from a satellite. More commonly known as a satellite dish.

Underserved community

As defined by the CRTC, those areas of Canada where there are less than two television stations available "off-air" (i.e., through the use of a conventional TV antenna).

Uplink

A signal transmitted from earth up to a satellite.

VideoCipher II (VC II)

A sophisticated type of encryption system used to scramble television programming transmissions. Used by First Choice in Canada, and by most U.S. discretionary programming services that scramble. It has become the <u>de</u> facto standard of encryption in the U.S.



Annex 3

Recommendations of the Standing Committee on Communications and Culture Proposing Amendments to the Radio Act for a Private Right of Action (Interim Report, April 1987)

Recommendation 18

Section 9(2) of the Radio Act should be amended to require that authorization be obtained for the reception and use of radiocommunication, except where transmissions are by a broadcasting undertaking and are intended primarily for the direct reception by the general public without further authorization or without the payment of a charge therefore.

Recommendation 19

The legislation should incorporate the principles of section 705(a) of the U.S. <u>Communications Act</u> that there be a distinction between persons who breach the section for purposes of direct or indirect commercial advantage or private financial gain, who would be subject to serious penal sanctions and civil remedies, and others, who would be subject to lesser penalties.

Recommendation 20

The legislation should permit aggrieved persons to enforce the section through private legal action, including a cause of action in damages and a claim of relief by injunction against anyone taking a service without authorization.

Recommendation 21

The legislation should make it clear that the term "authorization means an authorization to receive and utilize a radiocommunication at the location and for the purpose for which it was granted.

Annex 4

Recommendations of the Standing Committee on Communications and Culture Concerning New Definitions to be Included in New Broadcasting Legislation*

Recommendation 9

The term "broadcasting" should be defined so as to extend to any radiocommunication in which the transmissions are intended for reception by the public, including not only conventional radio and television stations but also satellite operations, where the signals are intended to be received only by cable television systems or other distribution undertakings that redistribute such signals to their subscribers.

Recommendation 10

The term "broadcasting" should be defined so as to extend to pay television, specialty and other program services intended for reception by the public, where the signals are scrambled and the services is intended to be received only by members of the public paying for such services.

Recommendation 11

The [Broadcasting] Act should state that any person who transmits or distributes by means of telecommunication, other than solely as a telecommunications common carrier, any programming received by radiocommunication, should be considered to be carrying on a broadcasting undertaking.

Recommendation 12

A person should be considered to be carrying on a broadcasting undertaking under the Act regardless of whether the undertaking is carried on for consideration or profit...

Recommendation 14


The power [of the CRTC] to exempt undertakings from the requirement to obtain a licence should be subject to a right to impose terms and conditions, and regulations applicable to licensees should also be able to be applied to exempted persons. This will permit the CRTC, for example, when exempting [S]MATV systems, to require such systems to meet the same obligations or requirements related to the carriage of services or any other matters a s would apply to cable television systems or other comparable licensed undertakings.

Recommendation 15

The term "distribution undertaking" should be defined in the new legislation to mean a broadcasting undertaking that provides a service consisting in whole or in part of the distribution to the public of programming services originating by one or more broadcasters or network operators.
