## EXECUTIVE SUMMARY

## The Commission

The International Boundary Commission (IBC) is a joint organization composed of two Commissioners duly appointed by the United States and Canada to maintain an effective boundary line between the two countries, as per the provisions of the Treaty of 1925. The IBC ensures the maintenance and integrity of a well-defined boundary, contributing to the mutual safety and prosperity of the citizens of both countries.

## Structure

The Commission is organized in two sections, each under the leadership of its respective Commissioner. Each side has its own staff, equipment, and budget. The maintenance work is shared equitably between the two sections, based on a periodically revised long-term plan.

## What we do

To fulfill its mandate, the IBC carries out routine inspections, repairs or replaces damaged boundary monuments, positions new monuments for improved boundary demarcation, maintains open vistas through woods and forests, and keeps boundary coordinates up to date by carrying out additional surveys when required.

## Accomplishments

Efforts were mainly focused in the following categories: vista clearing (North Line, St. Francis River, Southwest and South Lines, Highlands S.W., and Southeast Alaska), monument maintenance and/or inspection (St. John River, St. Francis River, Highlands N.E., West Line, and 49 ${ }^{\text {th }}$ Parallel), and surveys (Highlands S.W. and 49 ${ }^{\text {th }}$ Parallel).

## Measuring Success

The Commission is pleased to report that the work of maintaining the boundary is in line with its 15 -year maintenance plan and the condition of the boundary meets the requirements from both countries.

## The Commissioners

The United States Commissioner is Kyle K. Hipsley, who has long served the U.S. section, most recently as Deputy Commissioner. Jean Gagnon is Surveyor General of Canada Lands and therefore, pursuant to the International Boundary Commission Act (Canada), is also Canada's International Boundary Commissioner.

## INTRODUCTION

The boundary between Canada and the United States was defined and refined through a series of twentysix treaties, conventions, protocols, decisions and awards beginning with the 1783 Treaty of Peace and culminating in the 1925 International Boundary Treaty. In 1794, the first Commissioners were appointed to resolve ambiguities regarding the exact location of the boundary. The tradition of appointing Commissioners to resolve specific issues was carried on until, in the Treaty of 1925, the positions were made permanent and the Commissioners tasked with the ongoing maintenance of the boundary.

## The Mandate of the Commissioners

The Treaty of 1925 set out the responsibilities of the Commissioners as:

1. Inspect the various sections of the boundary line between the Dominion of Canada and the United States and between the Dominion of Canada and Alaska at such times as they shall deem necessary;
2. Repair all damaged monuments and buoys;
3. Relocate and rebuild monuments which have been destroyed;
4. Keep the boundary vistas open;
5. Move boundary monuments to new sites and establish such additional monuments and buoys as they shall deem desirable;
6. Maintain at all times an effective boundary line between the Dominion of Canada and the United States;
7. Determine the location of any point of the boundary line which may become necessary in the settlement of any question that may arise between the two Governments.

The Commissioners were further instructed to submit to their respective Governments from time to time, at least once in every calendar year, a joint report containing a statement of the inspections made; the monuments and buoys repaired, relocated, rebuilt, moved, and established; and the mileage and location of vistas opened. The report is to contain plats and tables certified and signed by the Commissioners, giving the locations and geodetic positions of all monuments moved and all additional monuments established within the year, and such other information as may be necessary to keep the boundary maps and records accurately revised.

This is the 94th Joint Annual Report from the Commissioners to their respective Governments on the state of the U.S./Canada boundary.

## MAINTENANCE ACTIVITIES

The 2018 field season began in May end ended in November. To ensure efficient and orderly management of boundary maintenance activities, the boundary is split into 8 sections and 29 subsections corresponding to areas with homogeneous characteristics. Projects are presented by subsections and activity from east to west, then north.

## North Line (ME/NB) - Vista Clearing

The North Line begins at the source of the St. Croix River and runs approximately 78 miles ( 125 kilometers) northward to its intersection with the St. John River, separating New Brunswick and Maine. Stretched across farms and forests, the rapidly growing vegetation of this boundary line necessitates frequent maintenance. The firm awarded this contract had completed the same project for the IBC in previous years. Overhanging branches, trees, and shrubs were cleared along a 35-mile ( 56.3 kilometer) section of the line to ensure an unobstructed 20 -foot-wide vista.

## St. John River (ME/NB) - Reference Monument Maintenance

The boundary follows the St. John River for 72 miles ( 115 kilometers) starting at the North Line and running west to the mouth of the St. Francis River. This project was a continuation of last seasons' efforts to recover and repair the reference monuments along the river. Reference monuments are land-based markers used to identify the location of turning points along the boundary line when it winds along a watercourse.

The surrounding areas are
developed with roads, towns, and farms. As a result, it was necessary to perform work in the yards of property owners with reference monuments on their land. The crew spent time communicating with them to determine their preferences pertaining to vehicle usage on their properties. The crew's goal was to have the only remaining sign of their presence be a renewed monument. With the cooperation of residents in place, and several weeks of monument recovery using handheld GPS units complete, the multi-step process of repairing monuments began. Trails were sometimes cut to gain access, and trees and brush removed to open an adequate line of sight. All told, 78 reference monuments were repaired and/or painted, marking a completion to this project after several years.

## St. Francis River (ME/QC) - Vista Clearing and Reference Monument Maintenance

The St. Francis River functions as the boundary beginning from its source at Lake Pohenegamook and running southerly for 43 miles ( 70 kilometers) to the St. John River. Dense woods border the U.S. side of the river, while low-lying farmland lines the Canadian side. Last cut five years ago, this section was in need of clearing as substantial tree growth had occurred along the line, including larger trees such as fir, poplar, and spruce. Communication with property owners proved valuable in securing ease of river access. The field crew was first sent out to paint highly visible reference monuments in an effort to be a good neighbor and keep the

Heavy rains had washed away much of the paint on many of these monuments that had just received a new coating within the last few years. Clearing then began in Estcourt, ME/Pohenegamook, QC and continued until the end of the field season near Blue River, QC. The arduous cutting was done by hand with brush saws over a total of 4.2 miles ( 6.8 kilometers). Much time was also spent felling and bucking up the many larger trees on the line.

## Southwest and South Lines (ME/QC) - Vista Clearing and Monument Inspection

The Southwest and South Lines define the boundary between Maine and Quebec starting at Lake Pohenegamook and heading southwest in a straight line to Lac-Frontière, Quebec, then turning south to its intersection with the southwest branch of the St. John River. The heavily forested and sparsely populated Southwest Line can be difficult to access, requiring the use of tracked vehicles on unpaved logging roads. While more accessible, the large swampy areas on the South Line provide its own challenges. A contractor was chosen to clear the vista of underbrush, trees, and overhanging branches along the entire 83.6 miles ( 134.5 kilometers) of this section. Their method of mechanical clearing proved to be efficient and produced a result of fully chipped vegetation. The contractor also inspected and photographed 199 of the 246 monuments encountered along the way.

## Highlands N.E. Section (ME/QC) - Monument Maintenance

This rugged section of the boundary is one of the most challenging to maintain. Inspections completed in the previous two field seasons revealed the need for significant monument maintenance. A new type of monument was used this season which is made of a round iron bar, ribbed like construction reinforcing steel, with an aluminum alloy cap forged to it. These monuments have the potential to last longer than the original century-old rock posts. Some of the bars could be driven into the ground to their full length of 30 inches ( 75 centimeters). Other monuments, where bedrock

## Highlands S.W. Section (ME/QC) - Survey, Inspection, and Vista Clearing

Resurveying of the Highlands is an ongoing effort being conducted to produce higher-accuracy coordinates than what was previously achieved. The aim of this project was to resurvey three of 95 traverses The Highlands are divided into for surveying purposes. With traverses 56,63 , and 66 now complete, only one traverse remains to be resurveyed for the IBC to be able to publish a new set of coordinates for the Highlands. Inspection of the monuments in the resurveyed traverses was also completed.

Vista clearing work was due for this section as part of its six-year vegetation management cycle. The project was assigned to a contractor to remove trees and underbrush so that the line of sight would be unobstructed up to the horizon and for a width of 10 feet ( 3 meters) on each side of the boundary line. A total of 53.4 miles ( 85.9 kilometers) of the vista was cleared. As part of the project, the contractor inspected and photographed 567 boundary monuments along the way.

## West Line (VT/QC) - Monument Maintenance and Densification

The West Line, between Vermont and Quebec, crosses the scenic mountain vistas and gently rolling hills of the Eastern Townships. It also dips into two of the most scenic lakes of the Northeast, Lake Memphremagog and Lake Champlain, where many early chapters of American and Canadian history were written.

Maintenance of this section continued to improve visibility of the boundary line by adding new monuments and refurbishing existing ones. In particular, two new boundary monuments were installed between the municipalities of Derby Line, VT and Stanstead, QC in order to meet the needs of citizens and law enforcement agencies. A total of 55 monuments were inspected, 39 of which were repaired.

## 49th Parallel (ND/MB) - Survey and monument maintenance

An IBC team conducted GPS surveys along multiple sections of the boundary at the 49 ${ }^{\text {th }}$ Parallel. The bulk of the work was done on the North Dakota/Manitoba boundary in an area that had previously not been accessible due to the recent oil boom. A large gap between Monuments 621 and 697 had existed, which was a critical piece necessary for completion of the comprehensive adjustments of the monuments along the $49^{\text {th }}$ Parallel. Surveys were also conducted in other sections in need of new data, namely The Meridian and the $49^{\text {th }}$ Parallel ( $\mathrm{MN} / \mathrm{MB)}$ ) to the east and the $49^{\text {th }}$ Parallel (MT$\mathrm{ND} / \mathrm{AB} / \mathrm{SK} / \mathrm{MB}$ ) to the west.

Monument recovery and GPS surveys were conducted in this section in order to fill gaps left in previous surveys. The IBC field crew encountered several difficult issues while surveying, adding to their work load. The area they were to begin work in was in flood stage, causing them to relocate and revise their plan in order to give the lower lands time to drain. Once work was under way, a stakeholder informed them of a noxious weed problem in the area, requiring them to take on the added step of washing down all vehicles, trailers, and ATVs so as not to spread the weeds to other locations.

The crew pressed on, though an especially rainy season limited their days. Later in the season, the rain began tapering off and operations were going well until they encountered multiple problems with the Diesel Mule that required time to repair. Rough roads in this area are exceptionally harsh on the vehicle and trailer tires, resulting in a particularly high number of flat tires. Despite the unforeseen challenges, 119 monuments were able to be recovered.

## 49th Parallel (Foothills to West Kootenay River) - Monument maintenance and densification

These monuments are located at the Kingsgate/Eastport Port of Entry. Last year, the POE supervisor requested that Monument 216C be moved from its existing location in the line of traffic. Rather than changing the location of Mon 216C, its above ground structure was removed and a new Monument 216D was established in a better location. This season, the position of Mon 216C was maintained about two feet under this heavy traffic area. As only the base had been set for Mon 216D last season, a pebble roadside monument was installed on the base, completing the project.

## 49th Parallel (Pacific to Columbia Valley) - Monument maintenance and densification

This section of the $49^{\text {th }}$ Parallel extends from the foothills of the Rocky Mountains westward until it reaches Boundary Bay. Because the boundary line intervenes between laborious American and Canadian communities that maintain close relationships, it deserves special attention.

The commission put forth some efforts to improve visibility of the boundary line in this section by refurbishing existing monuments and by adding additional markers at border crossings. A total of 73 monuments were inspected, of which 71 were painted and 58 were surveyed.

## Southeast Alaska (AK/BC) - Vista Clearing

Continuing the vista clearing of several consecutive field seasons in this section, the IBC contracted clearing work for three zones totaling 14.9 miles/24 kilometers. This vista cutting project was located along a rugged, remote segment of the southeast Alaska/British Columbia boundary. The first zone (Katete River Valley) of the contract began at the vegetation line west of Boundary Peak 54 and headed west for 5.2 miles to Monument 58. The second zone (West Fork Katete River Valley) began at Monument 58 and headed west for 2.5 miles to Monument 61 . The third zone (Stikine River Valley) began at the vegetation line north of Monument 62 and headed north for 7.2 miles to vegetation line south of Monument 66. The international boundary monuments along this section are a combination of 24 -inch-high aluminumbronze cones filled with concrete and set in 3-foot square concrete bases, and 8 -inch aluminum-bronze posts set in drill holes. A majority

## COMMISSIONERS' ACTIVITIES

## Commissioners' Meetings

The Commissioners met twice in 2018 to review the status of projects, approve upcoming projects, review and approve comparable expenditures, and discuss various issues brought to their attention. The spring meeting was held May 1-2 in Washington, D.C. The fall meeting was held November 14-16 in Vancouver, British Columbia.

## Field Inspections

Inspections carried out by the Commissioners and their assistants ensure that the work performed in the field, under their direction, meets the Commission's standards and was done in accordance with the Treaty. Throughout the year, the Commissioners made the following inspections:

- In July, Commissioner Hipsley and Deputy Commissioner Moore along with Commissioner Gagnon visited areas along the West Line in the vicinity of Derby Line, VT/ Stanstead, QC to see line houses and potential locations for new monumentation. The inspection also covered portions of Halls Stream to see changes in the river flows and impacts of accretion in the southern end of the section. In the same trip, areas along the St Francis and the St. John River were inspected.
- During the month of August, Commissioner Hipsley visited the U.S. field party of Phil Hargrove while the crew was conducting GPS surveys along sections of the $49^{\text {th }}$ parallel.
- On November 14, the Commissioners visited the Fraser Valley area and met with officials of Puget Sound Energy, WA. They also inspected the BC Hydro works and the Envirocorp recycling plant in Abbotsford, BC.

## PUBLIC RELATIONS

The Commission continues to work closely with provincial governments, local governments, and law enforcement agencies for both the United States and Canada to better manage vista clearing in high traffic areas and other places of concern along the border. This also aids in identifying locations that need additional marking to make the boundary more visible and effective for the general public. The IBC will occasionally be invited to share expertise in boundary related affairs to research and non-profit organizations.

This year, the International Boundaries Research University (IBRU) in Durham, UK again requested the IBC to participate in a workshop designed to help countries manage their shared borders. Daniel Fortin, from the Canadian Section, attended on behalf of the IBC to share our history and provide expertise from what is considered the "grandfather" of all boundary commissions.

Additionally, Deputy Commissioner Moore gave a presentation about the history and workings of the IBC to the Michigan Society of Professional Land Surveyors at their annual convention.

## REGULATORY ITEMS

The Commission monitors the construction of all works within 10 feet ( 3 meters) of the boundary. Thus, all construction - whether a ditch, building, surface, underground structure (telephone, cable, electrical line, or gas pipeline), line of communication, or other - must first be authorized by the Commission. In 2018, the Commissioners processed the following applications:

- Permission was granted to construct a new transmission line beginning near Woodstock, NB and continuing along Route 95 towards the Maine border to a new substation in New Brunswick. From this substation, a new power line will be permitted to cross the international boundary and tie into Houlton Water Company's (Houlton, ME) existing distribution lines.
- Permission was granted to install an underground oil pipeline across the international boundary and the St. Clair River between Turning Points 206 and 207. (MI/ON)
- Permission was granted to Manitoba Hydro to construct and alternating current transmission line crossing the international boundary between Monuments 891 and 892. (MN/MB)
- Permission was granted to undertake construction activities for road widening and paving at the Pembina POE. (ND/MB)
- Permission was granted to construct a new gas pipeline (South Saskatchewan Access Pipeline) near Portal, ND.


## PLANNING FOR 2019

The Commission plans to undertake the following activities in 2019:

## United States Section

The U.S. Section will be responsible for the following projects:

1) North Line (ME/NB) - Vista clearing for approximately 35 miles ( 56 kilometers) from Mon 1 to Mon 49 (south half of the North Line)
2) North Line (ME/NB) - Monument maintenance (north half of North Line)
3) St. Francis River (ME/NB) - Vista clearing and maintenance; survey checks
4) $49^{\text {th }}$ Parallel (ND-MN/MB) - Vista clearing and survey (Turtle Mountains and Meridian)
5) $49^{\text {th }}$ Parallel (MT-ND/AB-SK-MB) - Inspection, maintenance, and survey
6) Southeast Alaska (AK/BC) - Monument maintenance

## Canadian Section

The Canadian Section will undertake the following projects:

1) Halls Stream (NH/QC) - Reference monument densification and carsonite signs
2) Highlands N.E. (ME/QC) - Monument maintenance and survey
3) West Line (NY-VT/QC) - Clearing of Zone 3, monument maintenance, and range marks
4) St. Lawrence River (NY/ON) - Monument maintenance and reconnaissance
5) Lake Ontario and Niagara River (NY/ON) - Monument maintenance
6) $49^{\text {th }}$ Parallel (Pacific to Columbia Valley) - Clearing from Mon 0 to Mon 43

## REPORT ON COMPARABLE EXPENDITURES

This report shows the total amount spent by both sections of the Commission as of March 31, 2018, for maintenance of the boundary line under Section IV of the Treaty of Washington 1925.

The cumulative total represents the total spending of each section, since 1925, on expenditures deemed comparable. Comparable expenditures are the subject of an agreement by both Commissioners as to the interpretation of Section IV of the Treaty of 1925, and are revised regularly. The current agreement has been in effect since April 1, 1999. Under the agreement, and according to the Treaty, the expenditures do not include salaries or expenditures by the Commissioner and the Commissioner's assistants, including administrative staff, i.e., the permanent staff of each section. Therefore, this expenditure report is not a financial report, as it does not include all of the expenditures incurred by each section.

The purpose of compiling cumulative expenditures since the Commission's origins is to demonstrate that the efforts of both governments are shared equally. Although the cumulative total shows a lag in terms of the expenditures of the U.S. Section, this gap is not a concern, as the U.S. Section's budget currently exceeds the Canadian budget. This is expected to continue, so that the U.S. Section should catch up and close the gap within three or four years.

Given that each country's fiscal year spans two calendar years, the divisible expenditure report does not always reflect all costs associated with current year projects and shows some costs associated with the previous year's projects.

Expenditures are shown in each country's respective currency.
