The present report covers only the industries comprised in the "Vegetable Products Group". Statistics relating to specific products are, therefore, not to be regarded as the total for Canada since some of the commodities listed here are also produced in industries grouped under other classifications. Also, this report does not cover all food products but only such food products as are of vegetable origin. Food products of animal origin are grouped in the "Animal Products Group" which is treated separately. Beverages also are not complete as aerated waters are grouped with non-metallic mineral products.

THE VEGETABLE PRODUCTS GROUP, 1934.

The vegetable products group of industries ranked first in importance in 1934 with regard to gross value of production and cost of materials used, while in the amount of capital invested, number of persons employed and amount of salaries and wages paid it ranked fourth.

Reports were received from 5,656 establishments in 1934 with a capital investment of \$506,714,365 in fixed and current assets. The employment reported totalled 77,464 persons who received \$71,389,376 in salaries and wages. Products made were valued at \$480,314,618, materials used \$260,491,348 and the value added by manufacture \$210,899,507.

Considerable progress was made by the group as a whole during 1934. Compared with the previous year, there was an increase of \$58,464,746 or 13.9 per cent in the gross value of production, 6 per cent in the number of persons employed, with an increase of 8 per cent in the amount of salaries and wages paid. The value added by manufacture, out of which must come the manufacturers' selling and overhead expenses, as well as his profits, advanced 11.6 per cent over the 1933 figures. In spite of the increased output, the capital invested was .6 per cent lower, this being due to current charges for depreciation.

From the standpoint of production the flour and feed milling industry was the leading one of the group in 1934. This is one of Canada's oldest industries and it has taken care of the domestic requirements for more than three hundred years. At present, the mills, which include many of the most modern type and highest efficiency, have attained a capacity far beyond the local demand and for their surplus production have obtained a market in all parts of the world where wheat flour is consumed. This movement reached its peak in 1928 when 10,737,266 barrels valued at \$63,973,066 were exported. In 1934 only 5,053,732 barrels worth \$18,577,483 were shipped.

Reports were received in 1934 from 1,310 flour and feed mills. These mills reported a gross value of production of \$95,746,183 and a capital investment of \$59,293,426. They furnished employment to 5,633 persons who were paid \$5,135,312 in salaries and wages and spent \$74,048,243 for materials, most of which are of Canadian origin. This industry is, therefore, of considerable importance to the agricultural economy of Canada. Conditions in the industry improved materially in 1934. Compared with the previous year, there were increases of 14.9 per cent in the value of production and 17 per cent in the cost of materials used, while small increases were also reported in the capital invested, persons employed and salaries and wages paid.

The bread and other bakery products industry ranked second in importance from the standpoint of value of production in 1934 when 3,173 establishments reported a gross value of products of \$57,295,522, an increase of \$6,051,360 or 11.8 per cent as compared with 1933. The capital investment, \$44,196,221, in 1934 showed a decrease of \$895,580 or about 2 per cent. Employment was furnished to 18,562 persons, an

increase of 1,085 persons or 6.2 per cent. The amount of salaries and wages paid was \$15,794,117, an increase of \$893,905 or 6 per cent over 1933 and the cost of all materials used in 1934 was \$26,681,559, an increase of \$3,253,936 or 13.9 per cent.

The rubber industry, which is of considerable importance in the industrial life of Canada, is also included in the vegetable products group of industries. In 1934, 51 establishments reported a gross value of production amounting to \$55,250,381, an increase over 1933 of \$13,718,825 or about 33 per cent. The amount of capital invested in this industry in 1934 was \$66,047,471, an increase of \$732,999 or 1.1 per cent. Employment was furnished to 11,079 persons, 1,321 or 13.5 per cent more than in 1933. They were paid \$10,858,637 in salaries and wages, which represented an increase of \$1,948,513 or 21.8 per cent. The cost of all materials used was \$18,439,498, an increase of \$5,524,818 or 42.8 per cent.

This industry forms an adjunct of considerable importance to the cotton yarn and cloth industry which supplies it with tire fabrics for canvas boots and shoes. The export market is also of considerable importance and in 1934 shipments abroad were valued at \$11,923,739. In that year Canada also ranked seventh in imports of raw rubber.

The alcoholic beverages industry, including breweries, distilleries and wineries, has had a large expansion in the last decade until now it ranks fourth in value of production in the vegetable products group. In 1934 reports were received from 145 establishments reporting a gross value of production of \$52,151,470 which was an increase of \$8,101,260 or 18.4 per cent over 1933. The amount of capital invested, \$114,837,104, declined by \$3,567,373 or 3 per cent. There were 6,486 persons given employment in 1934, which is an increase of 485 over 1933, and the salary and wage bill, \$8,019,004, showed an increase of \$541,217 or 7.2 per cent, while the cost of raw and other materials was \$16,610,088, an increase of \$2,227,309 or 15.4 per cent.

The tobacco industry includes the manufacture of tobacco, smoking and chewing, snuff, cigars and cigarettes as well as the preliminary operations which consist of the processing and packing of raw leaf tobacco.

In view of the fact that the importance of an industry is measured by the value of its production, the Bureau has found it advisable to deduct the excise taxes paid in determining the value of production of this industry, since the inclusion of these taxes enhance the importance of this industry, an importance which is not warranted by either the amount of employment furnished or the salaries and wages paid.

In 1934 the net value of production amounted to \$43,053,856 reported by 149 establishments with a capital investment of \$55,382,378. Employment was furnished to 9,508 persons who were paid \$7,806,601, while the cost of all materials used was \$22,784,513.

While there are only eight sugar refineries operating in Canada, they had a gross value of production of \$36,007,208 in 1934. This represented a decrease of \$1,182,752 from the value in 1933. The amount of capital investment, \$35,151,249, also showed a decrease of \$2,606,825 or 7.3 per cent from the 1933 investment, 2,080 persons were given employment, twelve less than in 1933 and they were paid \$2,919,662 in salaries and wages, a decrease of \$129,155 or 4.2 per cent. The cost of all materials used in 1934 was \$24,098,994, representing an increase of \$1,253,521 or 5.5 per cent.

THE VEGETABLE PRODUCTS GROUP, 1934.

The manufacture of biscuits, confectionery, cocoa, chocolate and chewing gum has developed into an important industry and in 1934 the 237 establishments engaged in such manufactures reported a gross value of production of \$40,076,917. This was \$4,900,823 or 13.9 per cent higher than in 1933. Capital investment amounted to \$40,476,440, a decrease of \$934,461 or 2.3 per cent from 1933. Employment was furnished to 10,304 persons, 413 more than in 1933 and the amount of salaries and wages paid them was \$8,862,934, an increase of \$748,700 or 9.2 per cent in comparison with 1933. The cost of materials used in 1934 was \$18,257,191, an increase of \$2,531,644 or 16.1 per cent.

In the fruit and vegetable canning, evaporating, preserving, pickling, etc., industry, 287 establishments reported operations in 1934. They had a gross value of production of \$35,330,577, which was \$5,349,177 or about 18 per cent over the 1933 production. The capital investment, \$39,266,310, showed an increase of \$1,979,486 or 5.3 per cent. Employment was given to 7,524 persons, an increase of 994 or 15.2 per cent, the salaries and wages, \$4,704,518, increased by \$861,943 or 22.4 per cent, while the cost of materials used, \$20,466,907, increased by \$4,005,152 or 24.3 per cent.

Reports were received from 71 establishments in the coffee, tea and spice industry for the year 1934 advising a gross production valued at \$22,667,013. This represented an increase of \$2,747,369 or 13.8 per cent. The amount of capital invested in this industry in 1934 was \$13,837,780, a decrease of \$166,657 or 1.2 per cent from the 1933 investment. Both the number of employees and the amount of salaries and wages paid them showed increases in 1934. The former with 2,015 persons increased by 130 and salaries and wages, amounting to \$2,429,626, increased by \$53,356. The cost of materials used in 1934, \$16,598,466, increased by \$2,556,597 or 18.2 per cent.

The principal statistics for 1933 and 1934 of all other industries comprised in the vegetable products group are contained in tables 4 and 5.

^xIn accordance with the recommendations of the Conference of British Commonwealth Statisticians, 1935, the net value of production, or value added by manufacture, is now computed by subtracting the cost of materials and the value of fuel and electricity from the gross value of products. However, since the value of electricity is not available prior to 1924, the net values as shown for the years preceding that date are still computed by the old method of subtracting the cost of materials only.


