The present report covers only the industries comprised in the "Vegetable Products Group". Statistics relating to specific products are, therefore, not to be regarded as the total for Canada since some of commodities listed here are also produced in industries grouped under other classifications. Also, this report does not cover all food products but only such food products as are of vegetable origin. Food products of animal origin are grouped in the "Animal Products Group" which is treated separately.

Commencing with 1936, "aerated waters" are included in the "Vegetable Products Group" and all figures have been revised in accordance with this change. Statistics published prior to 1936 are for this reason not comparable with those contained in the present report.

THE VEGETABLE PRODUCTS GROUP OF INDUSTRIES, 1940.

The production of commodities based on vegetable products as a raw material constitutes an important branch of Canadian manufacturing production. In gross value of products the vegetable products group normally ranks first. In 1940, however, due to demands for metals and wood needed for war production, this group dropped to third place with 16.3 per cent of the total value of production, being exceeded by the "iron and steel" and "wood and paper products" groups. In number of employees and salaries and wages paid this group ranked only fourth, with 13.6 per cent and 12.2 per cent respectively, while in capital investment, it occupied third place with 14.3 per cent of the total.

This group also contributes materially to the foreign trade of Canada. During the calendar year 1940, exports of manufactured products of vegetable origin totalled over \$75,000,000. Wheat flour, whiskey, rubber tires, rubber footwear, cereal foods, oatmeal and rolled oats, bran, shorts and middlings, canned fruits and vegetables, malt, rubber clothing and macaroni were the main products exported.

In 1940 reports were received from 5,861 establishments with a capital investment of \$586,790,195 in fixed and current assets. They furnished employment to 103,634 persons who received \$111,915,850 in salaries and wages, and produced goods with a selling value at the factory of \$738,432,443. The leading industries of the group with the number of employees and value of production in 1940 are given in the table below.

Ontario with 48 per cent of the capital, 50 per cent of the employees and 50 per cent of the value of the products was the dominant producer of manufactured products of vegetable origin. Quebec was second with 31 per cent of the capital, 31 per cent of the employees and 28 per cent of the value of production. British Columbia was in third place in value of production, followed by Manitoba, Alberta, Saskatchewan, New Brunswick, Nova Scotia and Prince Edward Island.

In Ontario, flour and feed mills headed the list with \$70,145,829, followed by rubber goods, bread and other bakery products, fruit and vegetable preparations, biscuits, confectionery, cocoa and chocolate, miscellaneous foods, breweries, tobacco processing and packing, etc. The importance of Ontario as a manufacturer of products based on raw materials of vegetable origin is illustrated by the percentages that some of its industries contribute to the total Canadian production. The industries in which Ontario is pre-eminent with the percentages that each bore to that of the Dominion totals in 1940 were as follows: starch, 97 per cent; breakfast foods, 95 per cent; tobacco processing and packing 91 per cent; wine, 85 per cent; rubber goods, 81 per cent; distilled liquors, 67 per cent; fruit and vegetable preparations, 63 per cent; biscuits and confectionery, 59 per cent and flour 52 per cent.

In Quebec, the production of tobacco, cigars and cigarettes was the dominant industry with an output valued at \$42,504,146. This represents 86 per cent of the total Canadian output of tobacco products. Quebec also produced 64 per cent of the linseed oil and 48 per cent of macaroni and kindred products.

THE VEGETABLE PRODUCTS GROUP OF INDUSTRIES, 1940.

The production of bread and other bakery products ranked second, followed by miscellaneous foods, breweries, rubber goods, biscuits and confectionery, etc. Sugar refining is also a leading industry, statistics, however, cannot be published as there are only two plants operating.

In British Columbia, the production of miscellaneous foods, which includes coffee, tea and spices, headed the list with an output valued at \$7,708,297. Fruit and vegetable preparations ranked second, followed by bread and other bakery products, breweries, stock and poultry foods, etc. The refining of sugar also forms an important branch of production, figures, however, cannot be published as there is only one plant in operation.

The chief industries in the Maritime Provinces are: sugar refining, miscellaneous foods, including coffee, tea and spices, biscuits, confectionery, cocoa, chocolate, bread and other bakery products and fruit and vegetable preparations. These five industries account for about 84 per cent of the total production of these provinces.

The production of flour and feed mills dominates the output of the vegetable products group of industries in the Prairie Provinces, the output in 1940 being valued at \$36,173,570 or 44 per cent of the total production of these provinces. Bread and other bakery products came second, followed by breweries, sugar refining, miscellaneous foods, including coffee, tea and spices, aerated waters, malt, and biscuits and confectionery.

For detailed statistics of the industries in each province see Table 6.

The index of the physical volume of production for the vegetable products group of industries, given in Table 7, shows an increase of 19.4 per cent since 1929, the pre-depression peak. Fluctuations in the physical volume of production varied from industry to industry, some industries reporting substantial increases, some only minor increases, while others reported declines over the basic period, 1935-39. The greatest advance in the volume of production was made by the aerated waters industry, with an increase of 68.4 per cent. The wine industry came second with 44.5 per cent, followed by linseed oil, with 39.6 per cent, macaroni 39.4 per cent, tobacco processing 33.2 per cent, distilleries 28.3 per cent, stock and poultry feeds 25.6 per cent. Declines in the volume of production were reported by the breakfast foods and rice milling industries, with decreases of 16.7 per cent and 6.7 per cent respectively.

Average annual earnings of male wage-earners advanced from \$895 in 1935 to \$1,048 in 1940, an increase of 17 per cent. Weekly earnings rose from \$18.85 to \$21.25, while hourly earnings rose from 36 cents to 41.1 cents per hour.

Average annual earnings of female wage-earners in 1940 totalled \$593, an increase of \$65 or 12.3 per cent over 1935. Weekly earnings at \$12.02 were 87 cents higher while hourly earnings at 25.5 cents per hour were 1.3 cents higher.

Detailed statistics of annual, weekly and hourly earnings as well as hours worked per week are given by industry, province and sex in Tables 11 to 15.

1/ The value added by manufacture is obtained by subtracting from the gross value of production, the cost of materials, fuel and electricity.

2/ A change in method of computing the number of wage-earners in the years 1925-30, increased the number somewhat over that which the method otherwise used would have given. In 1931, however, the method used prior to 1925 was re-adopted. The figures for 1931 and later years are, therefore, comparable with those for 1924 and earlier years.


