The act provides a modern legislative framework that enables cost-effective delivery of services and, through better reporting to Parliament, improves transparency and oversight.

Last year, a detailed listing of individual fees under the department's authority, along with anticipated increases, was added to the reporting requirements.

This year's report provides more detail on each fee, such as the type and rate of adjustment, the service standard and the performance result. This information provides additional context on each fee, in the spirit of open and transparent fee management.

I welcome the increased transparency and oversight that the *Service Fees Act* embodies, and I am pleased to oversee the transition to this modern framework.

Chief Commissioner and Deputy Head's message

As Chief Commissioner, I invite you to read our 2018 to 2019 Fees Report. This report details the changes we have made to ensure that our fees better reflect the cost of providing Canadian Grain Commission services.

I am proud of the work done by the Canadian Grain Commission to benefit grain farmers, the grain sector, and all Canadians. Our service standard performance results reflect the commitment and dedication of all Canadian Grain Commission employees.

The Canadian Grain Commission is funded largely through a revolving fund, which is based on charging fees for our services. Our fees are fixed in Schedule 1, Fees of the Commission in the Canada Grain Regulations.

In 2018-19, we implemented a new model for forecasting annual grain volumes and revenue projections that uses an updated analysis model. On April 1, 2018, a new fee schedule and service standards took effect. Fees for many of our services are lower, while several other fees were combined or eliminated. The Canadian Grain Commission is committed to review its fees on a five-year cycle in order to ensure that fees remain aligned with the costs of service provision.

The amended fees align revenues with the cost of delivering programs and services, and factor in projected increases in grain volumes inspected and weighed by the Canadian Grain Commission. We expect that these changes will save the grain sector approximately \$15.5 million per year on an annual basis.

Starting in 2019-2020, the Canadian Grain Commission will adjust fees for inflation each year on April 1 in accordance with the new *Service Fees Act*. The adjustment will be based on the percentage change over 12 months in the April All-Items Consumer Price Index for Canada, for the previous fiscal year.

The Canadian Grain Commission is committed to clear and transparent reporting to Parliamentarians and Canadians through the *Service Fees Act*.

About this report

This report, which is tabled under section 20 of the *Service Fees Act*ⁱⁱ and section 4.2.8 of the *Directive on Charging and Special Financial Authorities*, contains information about the fees that the Canadian Grain Commission had the authority to charge in the 2018 to 2019 fiscal year.

For fees set by act, regulation or fees notice, the report provides totals for fee groupings, as well as detailed information for each individual fee.

Although the fees charged by the Canadian Grain Commission under the *Access to Information Act* are subject to the *Service Fees Act*, they are not included in this report. Remissions

A remission is a partial or full return of a fee to a fee payer who paid for a service for which a department deemed that the service standard was not met.

Under the *Service Fees Act*, departments must develop policies for determining whether a service standard has been met and for determining how much of a fee will be remitted to a fee payer. This requirement does not take effect until April 1, 2020. This report therefore includes **only** those remissions issued under the Canadian Grain Commission's enabling legislation. It does not include remissions issued under the *Service Fees Act*.
