EXECUTIVE SUMMARY

The project goal of SPCI evaluation background study number two was the assembly of existing cultural data and creation of a computerized data base for use in the evaluation analysis. The primary focus was on pre-SPCI data, although information such as arts funding levels was captured for the time period covering the duration of the program as well. With the exception of such funding data, the dominant concern throughout the exercise was to assemble comparable information that would also be collected in surveys and data collections associated with the post-SPCI evaluation.

Data was collected, assembled or aggregated for capture at two levels of analysis; the cultural organisation and the Canadian community. Thirty-one communities which figured prominently in a previous major federal study of the arts in Canada were chosen as the study communities.

At the community level, the following data were included in the final file; 1981 census data from Statistics Canada, touring facilities data from the Canada Council Touring Office Facilities Directory, 1979 performing arts and heritage survey data from the Statistics Canada Cultural Statistics Program, various measures from the Canada Council's Performing Arts Database, funding data from Annual Reports of National Museums of Canada, funding data from the survey reports of the Council for Business and the Arts in Canada, cultural participation measures from two major 1978 arts surveys sponsored by the Department of Communications, community cultural supply measures from a previous major arts study, and finally, some other federal agency funding data.

At the cultural organisation level, the existing data assembly and capture was limited to data from the 1979 performing arts and heritage surveys supplied by Statistics Canada and the Canada Council.

All data was coded, keypunched and processed so as to optimize accuracy. Computer processing was performed using the Statistical Package for the Social Sciences (SPSS) on the client-supplied computer account at the Department of Communications' Shirley's Bay installation. Descriptive statistics were generated to validate all data items and files. Missing data was rarely a problem, for either community or organisation level data.

SOMMAIRE-RECOMMANDATION

La deuxième étude de documentation du PSIC visait à colliger les données existantes en matière de culture et à créer une base de données informatisées aux fins d'analyse de l'évaluation. L'accent a surtout été placé sur les données préalables à l'instauration du PSIC, même si certains renseignements comme les niveaux de financement des arts concernent aussi la durée du programme. A l'exception de ces données sur le financement, la principale préoccupation tout au long de l'exercice a été de colliger des données comparables obtenues dans le cadre d'enquêtes et de collectes de données relatives à l'évaluation des données postérieures à l'instauration du PSIC.

La collecte, le regroupement et la synthèse des données ont été faits à deux niveaux d'analyse : l'organisation culturelle et la société canadienne. A titre d'échantillon, on a choisi trente et une collectivités ayant occupé une place importante au cours d'une étude fédérale d'envergure sur les arts au Canada.

Au niveau de la société canadienne, les données suivantes ont été incluses dans le dossier final : données du recensement de 1981 (Statistique Canada), données sur les installations pour les tournées (Annuaire des installations de l'Office des tournées du Conseil des arts du Canada), données du sondage de 1979 sur les arts d'interprétation et le patrimoine (Programme de la statistique culturelle de Statistique Canada), divers indicateurs de la base des données sur les arts d'interprétation (Conseil des arts du Canada), données sur le financement (Rapports annuels des musées nationaux du Canada), données sur le financement (Rapports d'enquête du Conseil pour le monde des affaires et des arts au Canada), indicateurs sur la participation culturelle (deux importantes études sur les arts menées en 1978 par le ministère des Communications), indicateurs des services offerts par le milieu culturel (importante étude antérieure sur les arts), et, enfin, certaines données sur le financement accordé par d'autres organismes fédéraux.

Au niveau de l'organisation culturelle, le regroupement et la collecte des données existantes ont été limités aux données des études de 1979 sur les arts d'interprétation et le patrimoine (Statistique Canada et Conseil des arts).

Toutes les données ont été codées, introduites par clavier et traitées de façon à en optimaliser l'exactitude. Le traitement informatique a été effectué à l'aide du progiciel statistique pour les sciences sociales, sur le compte des services d'ordinateur fournis par le client dans les locaux du ministère des Communications à Shirley's Bay. Des statistiques descriptives ont été générées afin de valider tous les éléments et tous les fichiers de données. Il manquait rarement des données au niveau de la société canadienne ou de l'organisation culturelle.

1.0 INTRODUCTION

The complexity of the research design for the evaluation of the Special Program of Cultural Initiatives required data from a variety of sources for several distinct levels of analysis. For reasons of both economy and timing, it was imperative that pertinent existing cultural data be assembled for use in the evaluation. An impressive amount of energy and resources have been spent in recent years, and is being spent on an ongoing basis, to collect and compile cultural data. The multiplicity of actors collecting data and the number of studies that have been conducted have not made this data assembly an easy task. Generally speaking, the existing data assembly has been a highly successful exercise, providing a wealth of background data for the evaluation analysis.

Our effort at existing data assembly focussed on the cultural organisation and the community and this report will discuss data collection for each of these two levels of The final results of this background study were two separate data files that were designed to be components of the comprehensive data base to be integrated under SPCI background study number seven. The existing data assembly primarily involved the collection of pre-SPCI data, although not all data is restricted to the pre-program period. Finally, it is perhaps needless to say that this project involved a great deal of coordination with the cooperation project authorities, other agencies and other contractors to successfully define assemble the data.

2.0 DATA ASSEMBLY

2.1 Data Sources

This section identifies and presents a brief description of each of the sources of data that contributed to the final data files. They are as follows:

1. Statistics Canada: 1981 Census of Canada

The Statistics Canada publications based on 1981 census data provided a wealth of information on the 31 evaluation study communities.

2. <u>Canada Council Touring Office: Facilities</u> Directory

This four-volume facilities directory published by the Canada Council Touring Office provides an inventory of all performing arts facilities which are registered as available for rent to touring arts groups. Detailed information is provided on approximately five hundred facilities across Canada. Originally published in 1980, there have been two further updates in 1981 and 1983.

3. Statistics Canada: Cultural Statistics Program

The Cultural Statistics Program of Statistics Canada conducts annual surveys of performing arts organisations and periodic surveys of heritage institutions. The most recent available and useable data for the SPCI evaluation were the two surveys conducted in 1979.

4. Canada Council: Performing Arts Data Base

The Canada Council Research and Evaluation Division maintains a performing arts database on ongoing basis. The database contains an information on the cultural sector including expenditures, revenues, performances, attendance, public and private support and numbers of groups. The data is acquired from a variety of sources including various levels of government, Canada Council records and the Cultural Statistics Program.

5. Canada Council: Organisation Grant Inventory

This document contains specific and detailed documentation of Canada Council Funding to individual performing arts groups.

6. National Museums of Canada: Annual Reports 1979-1983

These annual reports contain details of funding under different programs to individual heritage institutions in Canada.

7. The Council for Business and the Arts in Canada: Annual Surveys of Performing Arts Organisations and Visual Arts Organisations 1979-1983

The Council for Business and the Arts in Canada is an organisation of approximately 110 business corporations whose purpose is to encourage corporate support for the arts. Published reports of their annual surveys contain detailed financial

information for individual arts organisations. In the case of performing arts organisations, this information is limited to organisations with annual expenditures of \$100,000 or more.

8. Community Infrastructure and Participation in Culture (CIPC) Technical Report*

Secretary of State sponsored CIPC thirty-one Canadian communities. The major components from this study that were used in the SPCI data assembly include the 1978 Readership Survey, the 1978 Canadians and the Arts Survey and statistical indices of cultural composite facilities and participation presented in the final CIPC Technical Report. These indices were based in part on a community-level database compiled by the Department of Regional Economic Expansion which was integrated into the database. The thirty one Canadian communities of the CIPC study defined the study communities for the SPCI evaluation

9. Other Federal Arts Funding Data

Other federal agencies contacted for arts funding information included the Department of External Affairs (Cultural Relations Program) and the National Arts Centre Corporation.

2.2 Variable Selection and Data Capture

2.2.1 Community-Level Data

The complete list of variables captured for the community-level data file are identified in Appendix A. This appendix is presented in the form of a record layout in which the variable number, number of fields, record number, field position, SPSS variable name and any relevant comments are listed for each variable. The information source for each of the variables is also identified.

The variable selection and data capture exercise varied for each data source. Brief descriptions follow in approximate arder in which the variables appear in the data file.

1981 Census of Canada

All data originates from Statistics Canada publications which present data at the community level. Nineteen of the thirty-one study communities are Census Metropolitan Areas (CMA) while the remaining twelve are parts of Census Agglomerations (CA) Census figures for the CA's were used in these cases. The number of variables captured represent aggregations and a condensed list of available community level variables.

Canada Council Touring Office Facilities Directory

Individual facilities information was aggregated and coded to provide community level measures. For each community we captured the number of facilities available for touring groups, as well as the number of fixed and moveable

seating for eight different types of facilities. These data were captured for both the pre-program period (1980) as well as for the post-program period (1983) by using the two directory updates.

Canada Council: Organisations Grant Inventory

Canada Council total grants to individual cultural organisations were aggregated and coded at the community level for the fiscal years from 1979-1980 to 1981-1982.

Council for Business and the Arts in Canada

The Council for Business and the Arts in Canada reports total revenues and expenditures for individual cultural organisations as well as the individual revenue components such as earned revenue, Canada Council funding, total federal, provincial and municipal governments funding, private donations, corporate and foundation funding. figures were aggregated at the community level and captured individually for both the pre-program (1979-80) and late program (1982-83) periods. Later analysis determined that an average of approximately eighty percent of the total arts revenues per study community was captured with organisations with expenditures of \$100,000 or more. Modest descrepancies reported by the Canada Council in an analysis of the proportions of earned revenue and private and corporate donations for individual organisations become negligible at the community level.

National Museums of Canada: Annual Reports

The annual reports were used to calculate the total funds dispersed through Museum Assistance Programs to the thirty-one study communities. These programs included Public Programming Assistance, the Upgrading and Equipment Assistance Program, the Registration Assistance Program, the Exhibitions Assistance Program, the Special Activities Assistance Program, the Training Assistance Program and the Specialized Museums Program. Total funding levels aggregated by community was captured for the fiscal year from 1979-1980 to 1982-1983.

Statistics Canada: Cultural Statistics Program

Information for performing arts organisations and heritage institutions was obtained by requesting special tabulations from Statistics Canada from the 1979 Performing Arts Organisation and Heritage Institution Surveys. All information was requested at the level of individual cultural organisations and obtained where problems of authorization or residual disclosure did not prohibit the release of the data.

The community level aggregations of this data were captured from the Canada Council Performing Arts Data Base, of which these surveys form a part.

Canada Council Performing Arts Data Base

The Canada Council provided community level aggretations of the 1979 performing arts organisation survey data for the nineteen Census Metropolitan Areas in the study. The data for the other twelve Census Agglomerations were aggregated from the 1979 Performing Arts and Hertage Survey statistics presented at the organisation level. Variables for performing arts organisations included a variety of measures of performances and attendance, as well as a variety of financial measures including breakdowns of revenues and expenditures. In addition, nine performance indicators computed by the Canada Council were captured at the community level.

Community Infrastructure and Participation in Culture: Technical Report

The variables captured from this study were a selection of the final factor scales for cultural infrastructure and participation for the thirty-one study communities. These measures represent the products of analysis of hundreds of variables and would have required a massive and unnecessary effort to reproduce. The most useful of these were coded directly as data.

1978 Readership and 1978 Canadians and the Arts Surveys

Information from these two surveys was available in machine readable format and was processed directly using SPSS software rather than first being coded as data. The raw data and SPSS command files for these two surveys were obtained from the Department of Communications via direct transfer into the computer account used for the data base

3.0 DATA BASE MANAGEMENT

3.1 Translation to Machine-Readable Format

Once the data capture was completed, a final check was made to ensure that all data were coded in the proper fields and that all records were properly sequenced. keypunching firm was selected and provided with the data and a set of specifications based on the record format presented in Appendices A and B. All data were 100% verified to guarantee accuracy. This means that all items keypunched twice and a program was subsequently run to identify discrepant items for correction and re-entry. final output of this process was a high speed magnetic tape containing the community-level and organisation-level data files. Both data files were created in card image and written in ASCII characters to simplify compatibility with the Department of Communications Honeywell installation.

3.2 SPSS System File Creation and Report Generation

SPSS sytem files were created using the two data files and two SPSS command files on the CP-6 Honeywell computer account provided. All the appropriate variable names input format statements, variable and value labels, missing values and variable transformations were specified. Descriptive statistics were generated to validate both the data and file creation exercise. After some corrections, revised and final system files were generated.

4.0 CONCLUSIONS

As the record layouts of Appendices A and B demonstrate, the two completed data files provide a very extensive source of data to be used in creating the integrated data base and performing the evaluation analysis in later background studies. Missing data for selected variables was generally not a problem. The overlap of information soruces is of such a degree that where an item was unavailable from one source, it was often available from another. In general, we must conclude that both the extent and quality of data captured in this existing data assembly fulfills all the requirements for the evaluation analysis.
