## Overview:

This bulletin provides a monthly update on estimates of recreational fin fishing effort and catch in the marine waters of southern British Columbia, within Pacific Fishery Management Areas 11 through 29 and 121 to 127 . These estimates are generated from data collected by the DFO's South Coast Creel Survey. A brief overview of the survey, the study area and methods used to collect data and generate these estimates is provided in the first bulletin of 2014, available on the DFO ExtraNet:

## Improvements and Participation:

In 2014 DFO is working with the Sports Fish Advisory Board, recreational fishing guides and avid anglers to improve recreational catch monitoring information by collecting detailed fishing information from some fishery participants. This detailed information includes reports of fishing activity, through logs, and the collection of biological samples. This information is used to improve catch monitoring as well as our understanding of the distribution of fish stocks. This project includes some fishing lodges, individual guides, and selected avid anglers within the South Coast area. We would like to thank all of the individual participants in this project along with the staff and management of the following lodges for their important contributions of catch monitoring information (partial list):

Canadian Princess Resort, Dent Island Resort, Nanook Lodge, Ritchie Brothers, and Sonora Resort.

## Creel Survey Data:

A summary of survey statistics and preliminary recreation effort, measured in boat trips, by Pacific Fishery Management Area (PFMA) are presented in Table 1. ## Recreational Catch Estimates:

A summary of preliminary kept and released catch estimates for key species by PFMA are presented in Tables 2 through 5. Table 6 presents kept Chinook catch estimates by Pacific Fishery Management Area, divided into Aggregate Abundancebased Management and Individual Stock-based Management groupings.
