## Overview:

This bulletin provides a monthly update on estimates of recreational fin fishing effort and catch in the marine waters of southern British Columbia, within Pacific Fishery Management Areas 11 through 29 and 121 to 127 . These estimates are generated from data collected by the DFO's South Coast Creel Survey. A brief overview of the survey, the study area and methods used to collect data and generate these estimates is provided in the first bulletin of 2015, available on the DFO ExtraNet: http://www-ops2.pac.dfo-mpo.gc.ca/xnet/content/salmon/sc_creelbulletins The estimates presented in this bulletin are based on in-season data and should be interpreted as preliminary and subject to revision as the data are finalized.
