Under the authority of the <u>Pest Control Products Act</u>, Health Canada's Pest Management Regulatory Agency (PMRA) has concluded that the addition of new uses on hops to the product label of KANEMITE 15 SC Miticide, containing technical grade acequinocyl, is acceptable. The specific uses approved in Canada are detailed on the label of KANEMITE 15 SC Miticide, <u>Pest Control Products Act Registration Number 28641</u>.

The evaluation of this acequinocyl application indicated that the end-use product has value and the human health and environmental risks associated with the new uses are acceptable.

Before registering a pesticide for food use in Canada, the PMRA must determine the quantity of residues that are likely to remain in or on the food when the pesticide is used according to label directions and that such residues will not be a concern to human health. This quantity is then legally established as a maximum residue limit (MRL). An MRL applies to the identified raw agricultural food commodity as well as to any processed food product that contains it, except where separate MRLs are specified for the raw agricultural commodity and a processed product made from it.

Consultation on the proposed MRL for acequinocyl is being conducted via this document (see Next Steps). A summary of the field trial data used to support the proposed MRL can be found in Appendix I.

To comply with Canada's international trade obligations, consultation on the proposed MRL is also being conducted internationally by notifying the <u>World Trade Organization</u>, as coordinated by the <u>Canada's Notification Authority and Enquiry Point</u>.

The proposed MRL, to be added to the MRLs already established for acequinocyl, is as follows.

MRLs established in Canada may be found using the <u>Maximum Residue Limit Database</u> on the <u>Maximum Residue Limits for Pesticides</u> webpage. The database allows users to search for established MRLs, regulated under the *Pest Control Products Act*, both for pesticides or for food commodities.

International Situation and Trade Implications

MRLs may vary from one country to another for a number of reasons, including differences in pesticide use patterns and the locations of the crop field trials used to generate residue chemistry data.

Table 2 compares the MRL proposed for acequinocyl in Canada with the corresponding American tolerance. American tolerances are listed in the <u>Electronic Code of Federal</u> <u>Regulations</u>, 40 CFR Part 180, by pesticide. Currently, there are no Codex MRLs¹ listed for acequinocyl in or on any commodity on the Codex Alimentarius <u>Pesticide Index</u> webpage.

Appendix I

Summary of Field Trial Data Used to Support the Proposed Maximum Residue Limit

Residue data for acequinocyl in hops were submitted to support the domestic use of KANEMITE 15 SC Miticide on hops.

Maximum Residue Limit

The recommendation for a maximum residue limit (MRL) for acequinocyl was based upon the submitted field trial data, and the guidance provided in the <u>OECD MRL Calculator</u>. Table A1 summarizes the residue data used to calculate the proposed MRL for hops (dried).

Following the review of all available data, the MRL as proposed in Table 1 is recommended to cover residues of acequinocyl. Residues of acequinocyl in this crop at the proposed MRL will not pose an unacceptable risk to any segment of the population, including infants, children, adults and seniors.
