I. Introduction

The Access to Information Act (Revised Statutes of Canada, Chapter A-1, 1985) was proclaimed on July 1, 1983.

The Access to Information Act gives Canadian citizens and individuals present in Canada a broad right of access to information contained in government records subject to certain specific and limited exceptions.

Under Section 72 (1) of the *Access to Information Act*, the head of every government institution is required to prepare an annual report to Parliament on the administration of the respective Act within the institution during each fiscal year.

II. CGC's Mandate:

The Canadian Grain Commission is responsible for establishing grades for Canadian grain and standards of quality for those grades, as well as implementing a system of grading and inspection for Canadian grain. The Commission regulates Canada's grain handling system, including the handling, transportation and storage of grain, and licensing of elevators and grain dealers. It has authority to conduct investigations and hold hearings on matters within the jurisdiction of the Commission. The Commission also undertakes, sponsors and promotes research in relation to grain and grain products.

Access to Information

Within the Canadian Grain Commission (CGC) the Chief Operating Officer (COO) is responsible for the coordination and implementation of policies, guidelines and procedures to ensure compliance with the *Access to Information Act* and the *Privacy Act* (the COO is ADM level). The head of the CGC is the Chief Commissioner and a copy of the designation order for the CGC with respect to the *Access to Information Act* is included as Appendix A.

Administration:

Access to Information requests are monitored by the CGC's Regulatory Coordinator, who assists with coordinating responses within the CGC and consults as required with other government institutions. All Access to Information matters are ultimately reviewed by the COO.

Training Activities:

During fiscal year 2016-2017 there was information shared with employees during Security Awareness Week. There were no training activities undertaken. The CGC continues to review and develop information management practices and procedures within the organization as part of a records and information management project which is ongoing.


