This Labour Market Bulletin provides an analysis of Labour Force Survey results for all three of Canada's territories, including the Northwest Territories, Nunavut and Yukon.

OVERVIEW

Employment

The Territories' labour market continues to recover from the impact of the initial outbreak of novel coronavirus (COVID-19) last year. In fact, employment in each of the three territories is higher on a monthly basis, with Yukon seeing the most significant increase. The number of people employed in the Territories increased 900 to 57,300 in February.

On an annual basis, employment in the Territories is 1.4% lower (-800). The number of people employed is down both in Yukon (-3.5%) and in Nunavut (-4.7%). Northwest Territories was the only territory to see an increase in employment (+2.7%) due to significant growth in its services-producing sector over the past year.

Unemployment

The unemployment rate for the combined Territories increased from January, up 0.7 percentage points to 6.7% in February. Year-over-year, the unemployment rate decreased in Northwest Territories and Nunavut, falling to 6.9% and 6.5% respectively. Meanwhile, Yukon's unemployment rate increased 2.6 percentage points to 6.8%.

The youth (15 to 24 years) unemployment rate for the combined Territories was 15.9% in February, a decrease of 2.4 percentage points from the same time last year. The unemployment rate for young men fell 0.8 percentage points to 22.9% year-over-year, while the unemployment rate for young women decreased 0.5 percentage points to 8.6%.





EMPLOYMENT BY INDUSTRY

There were 7,200 people employed in the **goods-producing sector** in February, down 10.0% (-800) compared to a year ago. The largest declines were in forestry, fishing, mining, quarrying, oil and gas and construction.

The COVID-19 pandemic has negatively affected the goods-producing sector across the North, particularly the mining industry. Almost all companies either reduced or shut down production at their mines in mid-March of 2020. Although several mines restarted operations and recalled staff in June and July of last year, productivity disruptions at these mines affected the overall profitability of the northern mining sector in 2020.¹ The Northwest Territories government reports that they did not receive any revenue from mining royalties in 2020 due to financial losses in the sector caused by the pandemic.²

Looking forward, the outlook is optimistic for the goods-producing sector over the short-term, as a number of major mining remediation and construction projects are slated to begin in the next few years. For example, the Giant Mine Remediation Project located north of Yellowknife will begin clean-up work this summer. The 10-year project is expected to employ approximately 200 people this year and just over 300 people in 2022.³

Meanwhile, the federal and Yukon governments are providing \$39 million in joint funding to build an 84-unit seniors independent living complex in Whitehorse. Construction on the new Normandy Manor development has already begun and the facility is anticipated to open in 2022.⁴

In addition, the Yukon government and the Na-Cho Nyäk Dun First Nation are collaborating on a \$63 million road reconstruction project. This upgrade to the Silver Trail is expected to provide training, employment and business opportunities for the Na-Cho Nyäk Dun community.⁵

Employment climbed higher in the **services-producing sector** – increasing 0.4% (+200) to 49,200 on an annual basis. Despite this slight increase, the COVID-19 pandemic has had a substantial impact on the Territories' services-sector, particularly in Yukon.



To cope with the fallout from COVID-19, all levels of government have pledged funding to support residents and businesses across the North. For example, the Yukon government is extending several financial support programs for businesses affected by the pandemic. This includes an extension of the \$4 million Tourism Accommodation and Non-Accommodation sector supplements and Yukon Business Relief Program to September 30, 2021.⁶

The Government of Northwest Territories also extended its Wage Top-up Program to August 31 of this year, increasing wages to \$18/hour to assist low-income workers during the pandemic.⁷ The territorial government is also providing COVID-19 relief funding to tourism operators in the Northwest Territories. The initiative will provide up to \$50,000 to eligible operators to cover their operating expenses until April 2021.⁸

Moving forward, the services-producing sector should continue to see steady growth over the short-term as major public and private construction projects get underway across the North. These projects are expected to provide spin-off benefits for construction-related industries such as transportation and warehousing; trade; and professional, scientific and technical services. For example, the Canadian Foundation for Innovation is providing \$1.69 million to Aurora College to help construct a warehouse at its Western Arctic Research Centre in Inuvik, NWT. The expansion will be used for training, storage, and workspace.⁹

Meanwhile, the federal government is providing \$2.5 million in funding to the Tlingit Homeland Energy Limited Partnership and Yukon Energy for a hydro expansion project. The project is anticipated to add 8.5 megawatts of capacity to Yukon's grid and will generate about 45 gigawatt hours of hydroelectricity for 3,750 Yukon homes per year. The Atlin Hydro Expansion project is expected to be complete in 2024.¹⁰

In addition, the federal government and Yukon Energy are jointly funding a \$31 million battery storage facility to be located at the intersection of Robert Service Way and the Alaska Highway. The facility will be in service by the end of 2022 and has a lifespan of about 20 years.¹¹
