OVERVIEW

The NNHPD Quarterly Drug Submission Performance Report reflects Non-Prescription and Disinfectant Drug submission review activity over five consecutive quarters from October - December 2019 to October - December 2020. Statistics are provided by Submission Type and show the number received, the number in workload and the number of licensing decisions issued over that period.

Several significant events occurred during the spring of 2020 including the COVID-19 Pandemic and the implementation of revised fees in accordance with the *Fees in Respect of Drugs and Medical Devices Order (SOR/2019-124)*.

- Health Canada employees shifted from working in their offices to working remotely from home. Fortunately in 2019, HPFB had implemented new forms to take advantage of the gateway for transmission of regulatory transactions in electronic format.¹ This method is more efficient than sending transactions on physical media by courier and is mandatory as of October 1, 2020.
- The publication of the Quarterly Drug Submission Performance Report was cancelled for two quarters (there were no reports published for Q4 Jan-Mar 2020 and Q1 Apr-June 2020), however figures for the past three quarters are provided in this report.
- There was a significant increase in the volume of <u>Drug Identification Number</u> Applications for Disinfectant products (DIND) received.
- An Interim Order Respecting Clinical Trials for Medical Devices and Drugs Relating to COVID-19 was approved and on August 13, 2020 the Minister of Health approved an order to temporarily extend the default period to review clinical trial applications and amendments from 30 days to 45 days to allow Health Canada to expedite the influx of COVID-19 related clinical trial applications. (see the Quarterly Drug Submission Performance Reports for the Therapeutic Products Directorate (TPD) and the Biologic and Radiopharmaceutical Drugs Directorate (BRDD)).

- The Interim Order Respecting the Importation, Sale and Advertising of Drugs for Use in Relation to COVID-19 (ISAD Interim Order) was approved by the Governor in Council on September 25, 2020. This interim order was introduced, in part, to create a new authorization pathway to help expedite the authorization of drugs and vaccines for COVID-19. The number of applications and amendments filed, the number of applications and amendments in review, and the number of authorizations issued under the ISAD Interim Order are included in this report. (see the Quarterly Drug Submission Performance Reports for the Therapeutic Products Directorate (TPD) and the Biologic and Radiopharmaceutical Drugs Directorate (BRDD)).
- On April 1, 2020, revised fees were implemented in accordance with the *Fees in Respect of Drugs and Medical Devices Order (SOR/2019-124)*. In addition, submissions based only on clinical or non-clinical date, in support of safety updates to the labelling materials for a new drug are now submitted as an SNDS or SANDS (and not as an NC).

Some of the highlights of the January - December 2020 report are:

Non-prescription Drug Submissions:

- There was a 55% decrease in the number of DINA submissions received in Q2 2020-2021 (26) compared to Q1 2020-2021 (58), and a 96% increase when comparing Q3 2020-2021 (51) to Q2 2020-2021.
- There was a 3% increase in the number of DINF submissions received in Q2 2020-2021 (80) compared to Q1 2020-2021 (78), and a 50% decrease when comparing Q3 2020-2021 (40) to Q2 2020-2021.
- There was a 10% increase in the number of PDC submissions received in Q2 2020-2021 (125) compared to Q1 2020-2021 (114), and a 14% decrease when comparing Q3 2020-2021 (107) to Q2 2020-2021.
- There was a 100% decrease in the number of NDS submissions received in Q2 2020-2021 (0) compared to Q1 2020-2021 (9), and no change when comparing Q3 2020-2021 (0) to Q2 2020-2021.
- The was a 50% increase in the number of SNDS submissions received in Q2 2020-2021 (12) compared to Q1 2020-2021 (8), and a 58% decrease when comparing Q3 2020-2021 (5) to Q2 2020-2021.
- There was a 100% increase in the number of ANDS submissions received in Q2 2020-2021 (2) compared to Q1 2020-2021 (1), and no change when comparing Q3 2020-2021 (2) to Q2 2020-2021.
- There was a 175% increase in the number of SANDS submissions received in Q2 2020-2021 (21) compared to Q1 2020-2021 (8), and a 10% decrease when comparing Q3 2020-2021 (19) to Q2 2020-2021.
- There was a 233% increase in the number of NC submissions received in Q1 2020-2021 (10) compared to Q4 2019-2020 (3), and none were received in Q2 and Q3 2020-2021 as this fee line was discontinued.

Overall, the total non-prescription drug submissions received decreased by 3% in Q2 2020-2021 (267) when compared to Q1 2020-2021 (276), and decreased by 16% from Q2 2020-2021 to Q3 2020-2021 (224).

The decrease in overall submissions from Q2 2020-2021 to Q3 2020-2021 reflects a continued decrease in non-prescription drug hand sanitizer submissions. The complex submission streams (SNDS, ANDS, and SANDS) were either stable or decreased through Q3 2020-2021 when compared to Q2 2020-2021.

The numbers in Q1, Q2 and Q3 2020-2021 bring the total number of non-prescription drug submissions received to its highest to date per quarter. For Q1, Q2 and Q3 2020-2021 specifically, the increase in the number of submissions is mainly due to a high volume of submissions received for compliance with the plain language labelling requirements as well as the high demand for non-alcohol based antiseptic skin cleansers.

Of note, in the last 4 fiscal years (2016-2020), the numbers of non-prescription drug submissions received were 699, 658, 616 and 926. The number of submissions received in the first three quarters of the 2020-2021 FY is 767, representing 106% of the average number of submissions received in totality in each of the last four FYs. Assuming a similar trend for the last quarter of 2020-2021, upwards of 1000 submissions will be received, breaking yet another all-time high for the non-prescription drug submission workload.

Disinfectant Drug Submissions:

- There was a 8% decrease in the number of DIND submissions received in Q2 2020-2021 (244) compared to Q1 2020-2021 (264), and a 13% decrease when comparing Q3 2020-2021 (214) to Q2 2020-2021.
- There was a 54% decrease in the number of PDC-D submissions received in Q2 2020-2021 (25) compared to Q1 2020-2021 (54), and a 17% increase when comparing Q3 2020-2021 (30) to Q2 2020-2021.
- The number of NDS-D remained the same in Q3 2020-2021 (1) compared to Q2 2020-2021 (1) and Q1 2020-2021 (1).
- There were no SNDS-D or NCs received for Q2 2020-2021 (0) and for Q1 2020-2021 (0), and 1 SNDS-D received for Q3 2020-2021 (1).

Overall, the total disinfectant drug submissions received decreased by 15% in Q2 2020-2021 (270) when compared to Q1 2020-2021 (319), and decreased by 9% from Q2 2020-2021 to Q3 2020-2021 (246). This maintains the total number of disinfectant drug submissions received to the highest it has ever been and is mainly attributed to the ongoing pandemic. For some submission types, such as DINDs and PDCs, the numbers received in each of the last three quarters are representative of the total numbers received for previous full FYs.

The number of PDCs spiked in Q1 2020-2021 then decreased by approximately half in Q2, which is explained by applications filed for the addition of indirect SARS-CoV-2 claims to the labels of existing disinfectants as a first line response to the COVID-19 pandemic. The number of PDCs in Q3 2020-2021 remained consistent with Q2.

Similarly, the number of DIND submissions (Labelling Standard) spiked in Q2 2020-2021, and has remained very high over Q3 2020-2021 and Q4 2020-2021 (an average 100-fold increase compared to previous quarters). This is explained by applicants continuing to submit these types of submissions in high numbers to address the continued need for general disinfectants as part of the ongoing COVID-19 response.

The significant increase observed for DIND submissions (Full Reviews with efficacy data) in Q2 2020-2021 is explained by the lack of availability of a test strain for SARS-CoV-2 testing during Q1 2020-2021, in addition to the lock-down of non-essential services (i.e. laboratories). This was followed by a significant increase of applications during Q2 2020-2021 when a test strain became available and laboratories were no longer in lock down. Overall, during Q3 2020-2021 a sustained increase in the volume of applications was observed compared to pre-COVID volumes maintained (a 366% increase for data submissions in Q3 2020-2021 compared to Q3 2019-2020). As a result, the active submission queue volume remains high, given that these DIND submissions have more complex review requirements, and therefore have longer performance standards often spanning multiple quarters.

Of note, in the last 4 fiscal years (2016-2020), the numbers of disinfectant drug submissions received were 179, 228, 218 and 234. The number of submissions received in the first quarter of the 2020-2021 FY alone is more than the number of submissions received for the totality of the 2016, 2017, 2018 and 2019 FYs. The total number of submissions received in Q1, Q2 and Q3 2020-2021 is 847, which represents more than three times the total number of submissions received in the totality of the 2016, 2017, 2018 and 2019 FYs. Assuming a similar trend for the last quarter of 2020-2021, upwards of 1000 submissions will be received, which is a never before seen surge for the disinfectant drug submission workload.

General Information

There are several steps involved in the drug submission review² and approval process:

- administrative processing,
- regulatory and scientific screening and
- in-depth scientific review.

When deficiencies or non-compliance issues are found, a company may submit responses before a final decision can be reached and thus multiple review cycles may be required. A submission's approval time can vary depending on the number and type of review cycles needed.

Submissions Received are counts of submissions received during the year using the filing date (CR date) which is the date the submission is considered administratively complete by Health Canada.

Workload is the number of submissions "under active review" on the last day of the quarter. "**Backlog**" is the proportion of the workload that is over target. Often the term workload is used to mean the amount of work received over a period of time and is a common source of confusion.

For new drugs, **approvals** are Notice of Compliances (NOC) Issued or Issuable which are reported in the Decisions' section. An NOC issuable is when a submission's NOC is placed "on hold" awaiting authorization to market, due to changes from Prescription to Non-Prescription or due to Patented Medicines (NOC) Regulations.

A **review cycle completion**³ is counted upon the conclusion of an in-depth scientific review that then results in a decision of approval or non-approval. The time taken to complete a cycle (excluding any pause days⁴) is compared to a set <u>performance standard</u> which is based on the type of submission, class and cycle (status).

Performance for all submissions or applications filed after April 1, 2020 is tracked individually.

² For further clarification refer to the <u>Guidance for Industry: Management of Drug Submissions</u>.

³ Review cycles include all types e.g. Review 1, Review 2, Review QN. The total number of "review decisions" may surpass the total number of review cycle completions as they include cancellations/withdrawals that occur while the submission is 'inactive'. For example, a withdrawal can be issued when a company fails to respond to a notice of non-compliance within the allotted time frame. A 'Cancelled by Company' is counted as a review decision when a company sends a cancellation letter after the submission's original materials have been accepted for review.

⁴ In the event that the review clock has been paused, the duration of the pause will be deducted from the total review time when calculating performance. That is, the days during which the clock is paused will not count when measuring performance (effective date: April 1, 2020).




DINA: Screening Cycle Completions


DIND-Disinfectant Products: Review Workload



DIND-Disinfectant Products: Screening Workload




DIND-Disinfectant Products: Administrative-Screening Workload




DIND-Disinfectant Products: Review Cycle Completions






