## **Operations Under the Act**

The Foreign Investment Review Act requires the Government of Canada to review two types of foreign investment: most acquisitions of control by non-Canadians of existing businesses in Canada; and the establishment of new businesses in Canada by non-Canadians who either do not already have a business in Canada or do not have a business in Canada to which the new business is or would be related.

#### CASELOAD (Table I)

The number of reviewable applications increased from 731 in 1980-81 to 739 in 1981-82. Of the 739 reviewable cases in 1981-82, 577 or 78 percent involved businesses with assets of less than \$2 million and 650 or 88 percent involved businesses with fewer than 100 employees.

What follows is a detailed description of acquisition and new-business cases, including some discussion of the benefits to Canada of investments that were allowed.

#### Acquisitions (Tables II to XI)

The number of reviewable applications rose in 1981-82 to 338, from 330 in the previous fiscal year. Of the 338 reviewable acquisition cases in 1981-82, 166 involved Canadian-controlled acquiree businesses and 172 involved foreign-controlled acquiree businesses. Acquiree businesses with assets of less than \$2 million accounted for 59.5 percent of the reviewable acquisition applications. Approximately 78 percent of the 338 acquisition cases in 1981-82 involved businesses with fewer than 100 employees.

The total value of assets of acquirees in 1981-82 was more than double that of 1980-81, increasing from \$4 billion to \$8.5 billion. This increase was due entirely to one case which alone involved assets of more than \$5.5 billion.

The distribution of cases by industrial sector remained much the same as in previous fiscal years, with services accounting for more than half (57 percent) of all reviewable acquisition cases, followed by manufacturing (39 percent) and the resource sector (4 percent). Of the 132 manufacturing cases, 47 percent were in four industrial sectors: metal fabricating, machinery, electrical products, and chemical products. The distribution of acquiree assets by sector changed substantially in 1981-82. The manufacturing sector share rose to 61 percent in 1981-82 from 43 percent in 1980-81, the service share decreased from 45 percent to 34 percent, and the resource sector share fell from 13 percent to 5 percent in 1981-82. (These figures exclude the very large case mentioned earlier.)

The pattern of provincial distribution has become well-established and did not change in 1981-82. Ontario accounted for 57 percent of the reviewable acquisition cases, followed by Quebec with 17 percent, British Columbia with 11 percent and Alberta with 8 percent. The other provinces and the territories accounted for only 7 percent of acquisition cases. The pattern of distribution of assets also remained consistent with that set in previous years. Excluding the \$5.5-billion case, Ontario was first with 71 percent, followed by the western provinces and the territories with 15 percent and Quebec with 13 percent.

The United States' share of cases dropped from 64 to 58 percent, while the Western European share increased from 31 to 34 percent in 1981-82. Also noteworthy is the decline in the U.S. share of the total value of assets, from a record high of 74 percent in 1980-81 to 65 percent in 1981-82. The Western European share, at 25 percent, remained close to the level set the previous year.

Most U.S. cases involved Ontario (65 percent), British Columbia (11 percent) and Quebec (10 percent). The distribution of Western European cases was similar, with Ontario involved in 47 percent and Quebec and British Columbia each involved in 19 percent. The service sector was involved in 55 percent of U.S. cases and in 58 percent of Western European cases. Only 3 percent of U.S. cases and 5 percent of Western European cases were in the resource sector.

Of the 314 acquisition cases resolved during 1981-82, 284 were decided and 30 were withdrawn before a decision was reached by the Governor in Council. Of the decided cases, 87 percent were allowed and 13 percent were disallowed. These rates are comparable to those registered in 1979-80 and 1980-81.

#### New Businesses (Tables XII to XXI)

As in previous years, in 1981-82, the vast majority of the 401 reviewable applications (94 percent) involved businesses with an indicated investment of less than \$2 million. The total projected value of assets decreased to \$704 million in 1981-82 from \$1.3 billion in 1980-81, a year in which there had been a sharp increase in cases involving initial investments of \$25 million or more.

The service sector share of new business cases was 69 percent in 1981-82, the manufacturing sector share 27 percent, and the primary sector share 4 percent. However, with just 4 percent of the cases, the primary sector accounted for 50 percent of the total projected value of investment. In fact, the average projected investment in the primary sector rose to \$25.3 million, while in the manufacturing sector it was \$890,000 and in the service sector \$911,000. The manufacturing sub-sectors that accounted for the most cases were: machinery, metal fabricating, chemical products and rubber and plastic products.

Ontario was involved in 58 percent of the new business applications, Quebec in 14 percent, British Columbia in 13 percent, and Alberta in 8 percent. The other provinces and territories accounted for 7 percent. However, when ranked according to share of projected investment by dollar value, British Columbia was first with 50 percent, followed by Ontario (30 percent), Alberta and Quebec (9 percent each).

The United States' share of applications was 57 percent, the Western Europe share 28 percent, and other countries' share 15 percent. Despite their comparatively small share of the number of cases, investment proposals submitted by applicants of "other countries" accounted for 50 percent of the total projected value of assets, Western European applicants accounted for 30 percent and U.S. investors for 20 percent.

A few sizeable resource sector cases explain the unusually large share of planned investment destined for British Columbia (50 percent) and the position of "other countries" as the primary source of investment (50 percent).

Most U.S. cases involved Ontario (64 percent), or the western provinces (27 percent). Western European investors proposed investments mainly in Ontario (54 percent) and Quebec (27 percent). Close to half of the applications from "other countries" also involved Ontario (45 percent) and almost as many involved the western provinces (40 percent).

The number of new business cases resolved increased sharply, from 293 last year to 405 in 1981-82. The increase is in some measure attributable to the operation in the last four months of the fiscal year of a small-business group, which was established within the Assessment Bureau of the Agency to expedite the review of small-business investments. Of the 405 resolved cases, 310 were decided and 95 were withdrawn by the applicant before a decision was reached by the Governor in Council. Of the decided cases, 85 percent were allowed and 15 percent were disallowed. Of the 95 withdrawn cases, 25 were from foreign individuals who intended to invest in Canada only after becoming permanent residents of Canada. Accordingly, since their investments would not then be subject to review under the Act, the investors were advised to apply under the Entrepreneurs and Self-Employed Persons programs of the Canada Employment and Immigration Commission.

#### Significant benefit

Only those cases which, in the opinion of the Government, offer significant benefit to Canada according to the factors set out in subsection 2(2) of the Act can be allowed. The weight given to each of the factors that is relevant to a particular case necessarily varies according to the nature of the proposal, the sector in which the investment is to occur, the region in which it is to be made, the kinds of undertakings, if any, offered by the applicant, and other factors and circumstances unique to each case. To provide some illustration of the variety of benefits that will result from cases allowed in 1981-82, there follow descriptions of three allowed proposals, one in each of the three broad industrial sectors. (In each case the permission of the applicant to release this information — which otherwise may not legally be divulged — was sought and obtained.)

One was the allowed establishment of a new business by Nippon Kokan Kabushiki Kaisha, Kobe Steel, Ltd., Nippon Steel Corporation, Kawasaki Steel Corporation, Sumitomo Metal Industries, Ltd. and Nisshin Steel Co. Ltd., which are all primarily manufacturers of steel, and the trading company, Mitsui & Co. Ltd., all of Tokyo, Japan. The new business will explore for, develop and produce coal. As their first project together in Alberta, the Japanese companies will participate in a joint venture, through their wholly owned Canadian subsidiaries, with Gregg River Coal Ltd., a subsidiary of 100 percent Canadian-owned Manalta Coal Ltd., to develop and mine a metallurgical coal property near Hinton, Alberta. Gregg River Coal Ltd. will hold a 60 percent interest in the property and the Japanese group a 40 percent interest. The project will be managed by another Canadian subsidiary of Manalta Coal Ltd. The Japanese steel companies have agreed to buy 2.1 million tons of coal annually for 15 years commencing in 1983.

Approximately \$215 million will be spent over the next two years to develop the property and construct the mine, and between 300 and 500 Canadians will be employed during this period. When the mine is in full production, it will employ some 672 Canadians. In addition, the applicants have undertaken not to allow the Canadian ownership of the Gregg River project to fall below 50 percent and not to participate in any other coal-mining projects where aggregate Canadian ownership would be less than 50 percent. Finally, the Japanese companies have undertaken that any coal production in excess of the quantities required to fulfill the contract with the Japanese steel companies will be made available to Canadians on competitive terms.

Another example was the allowed proposal by Amdahl Corporation of Sunnyvale, California, U.S.A., to acquire control of Tran Communications Limited of Mississauga, Ontario, a wholly-owned subsidiary of Tran Telecommunications Corporation of the U.S.A., a business engaged in the design, manufacture, sale and support of electronic digital data communications networks and equipment. The combined operations of Amdahl Limited (Amdahl Corporation's Canadian subsidiary) and Tran will employ at least 30 additional people within one year, including 10 additional employees to be involved in R&D activities in Tran (at present 15 people are employed by Tran in this capacity). Also, after the first year the R&D personnel will be increased by one person for each \$1 million of additional sales above Tran's 1980 sales level, up to 50 such persons. The R&D expenditures will represent a significant percentage of Tran's existing sales in Canada. Within 12 months, Amdahl will establish a centralized hardware and software support facility in Canada, staffed by not less than 12 professional technicians. The establishment of this support facility will involve capital expenditures of approximately \$100,000 and its operating budget for the first two years will be approximately \$800,000 and \$1 million, respectively. Tran will also have a world product mandate for a particular line of time-division multiplexer products as well as for all other products designed and developed in Canada. In this respect, Tran will have the responsibility for the production and worldwide marketing of these products.

A third example was the allowed acquisition by Stihl International GmbH of the Federal Republic of Germany, to acquire control of Timberland Supply Co. Ltd. of Kamloops, British Columbia, a business which distributes chain saws and accessories.

In support of its proposal Stihl undertook to cause all officers and at least two-thirds of the directors to be resident Canadians and to allow the Canadian management freedom to manage the day-to-day operations of the investment. Within one year after the end of the fiscal year in which Timberland's sales reach 10,000 units of a defined group of Stihl chain saw models, Stihl will establish an assembly/light-manufacturing facility in Canada to assemble approximately 10 chain saw products with Canadian

valued-added of 40 percent. The company has set an objective of beginning to manufacture, within five years, additional chain-saw products for both Canadian and export markets. In addition, the company undertook to export Canadian-made parts, components, materials and supplies totalling no less than \$2.5 million in 1982 and \$3 million per year thereafter (in 1982 constant dollars). Furthermore, the company will invest \$1.5 million for the establishment of new offices and warehouses in Toronto and in Vancouver, and will restrict Timberland's distribution activities to Manitoba, Saskatchewan, Alberta, British Columbia and most of Ontario.

The three examples cited are only an illustration of the range and value of the benefits associated with allowed cases. Increased employment, new investment and increased resource processing or use of Canadian parts and services are among the most common benefits. Other benefits of foreign investments have included enhanced research and development, increased Canadian participation, penetration of new export markets and improved competition. The reader may refer to appendices B and C of this report for a more complete list of the benefits associated with resolved cases.

#### **OPINIONS**

Two types of opinion are provided to foreign investors on request: first, subsection 4(1) of the Act authorizes the Minister to give opinions as to whether or not an investor is a "non-eligible person" and as to whether or not a new or acquired business is, or would be, related to a non-eligible person's existing business in Canada; second, the Agency gives its own opinions, under certain circumstances, on whether or not a proposed or actual investment is reviewable under the Act. Ministerial opinions are formally binding on the Minister for a period of two years, provided that all material facts were disclosed at the time the application was made and that these facts remained substantially unchanged. Agency opinions are informal and are not binding on the Minister or the Government.

In 1981-82, 16 ministerial opinions were given on the question of whether or not an applicant was a non-eligible person under the Act. Fifteen of these opinions were to the effect that the applicants were not non-eligible persons, and one opinion was given to the effect that an applicant was a non-eligible person. In addition, five applicants withdrew their applications when it became apparent that a favourable opinion could not be given. Of the opinions given, 12 were renewals of earlier opinions, following the expiry of the two-year period.

The Minister also gave four favourable opinions on "relatedness". Five applications were withdrawn when it became evident that the proposed new business could not be considered related to an existing Canadian business carried on by the same applicant. (The establishment of a business in Canada by a non-eligible person is not reviewable if the new business is related to a business already being carried on by that person in Canada.)

The number of Agency opinions on reviewability remained high in 1981-82. This indicates that investors are well aware of the usefulness of this more informal type of contact with the Agency.

#### **SURVEILLANCE**

The Foreign Investment Review Act empowers the Minister to require that a notice in the prescribed form be filed when a non-eligible person proposes to make or has made an investment which is subject to review and has failed to file notice.

In 1981-82, numerous reports from the news media and unsolicited information from individuals and companies resulted in 278 detailed investigations concerning proposed or actual acquisitions of Canadian business enterprises or the establishment of new businesses in Canada, where no notice had been filed. These investigations led directly to the filing of 47 acquisition and new-business notices.

#### **ENFORCEMENT**

In 1981-82, in accordance with established procedures, the Enforcement Division monitored the implementation of plans and undertakings provided by investors in 1198 proposals that had been allowed. In addition, 85 disallowed applications were monitored to ensure compliance with the decision of the Governor in Council.

In the great majority of disallowed cases, investors had complied with the decision of the Governor in Council or were taking the steps to do so. And most investors, by far, whose proposed investments had been allowed, had met their undertakings. In some few cases economic circumstances made it necessary to renegotiate certain undertakings.

#### LEGAL PROCEEDINGS

The Foreign Investment Review Act authorizes the Minister to initiate legal proceedings in any case where the investor fails to file notice as required by the Act, or fails to comply with an order of disallowance or with the terms and conditions of his investment as set out in his notice or in the plans and undertakings.

On April 9, 1981, the Trial Division of the Federal Court of Canada dismissed on jurisdictional grounds an application by Central Cartage Co. to permit the sale of its shares of the Canadian Transit Company to Cambridge Holdings Limited, an Ontario corporation, all the voting shares of which were owned by Mr. T. J. Maroun, who is now a permanent resident in Canada. By order dated May 25, 1981, the Federal Court of Canada, Appeal Division, ruled that, if Central Cartage sold the shares to Mr. Maroun, as outlined in the application, it would not be in breach of an injunction order made by the Federal Court against Fallbridge Holdings and Central Cartage Co. in 1979 and extended indefinitely on March 31, 1980. That injunction enjoined the two companies from, among other things, taking certain actions in relation to their acquisition of the Ambassador Bridge connecting Detroit and Windsor. The Court declared, however, that its ruling was not to be construed in any way as expressing an opinion as to whether such a transaction was or was not reviewable under the Foreign Investment Review Act, or as precluding its review under the Act. On December 8, 1981, the Federal Court extended for a further period of 180 days the time within which the transaction contemplated was to be completed.

On May 11, 1981, the Supreme Court of Canada refused an application by Dow Jones & Co. Inc. for leave to appeal the March 20, 1981 Federal Court of Canada, Appeal Division, order dismissing Dow Jones' appeal against a decision of the Trial Division, which had held that the acquisition by Dow Jones of Irwin Dorsey Limited did constitute an acquisition of control within the meaning of the Foreign Investment Review Act.

During the year under review, the Attorney General of Canada instituted legal proceedings against Trio-Kenwood Canada Inc. under subsection 24(2) of the Foreign Investment Review Act, for failing to file notice under the Act following a demand to do so by the Minister. On March 3, 1982, this case was heard in the Provincial Court (Criminal Division) in Ottawa, and the company was acquitted. The Attorney General has launched an appeal. This appeal is an appeal on the record and will be heard by the County Court. No date has yet been set.

In addition, on December 24, 1981, the Minister responsible for the Act instituted proceedings against Trio-Kenwood Canada Inc. and Trio-Kenwood Corporation in the Trial Division of the Federal Court of Canada, seeking an order to render their investment in Canada nugatory. This application, which was to have been heard March 31, 1982, was postponed to a date to be agreed upon by both parties after service of the notice of motion on Trio-Kenwood Corporation.

On November 2, 1981, British Columbia Forest Products Limited (BCFP) and Western Forest Products Limited (Western) made applications to the Trial Division of the Federal Court of Canada (under section 18 of the Federal Court Act), to obtain a declaration as to their status under the Act, whether eligible or non-eligible. On November 10, 1981, these companies also sought and obtained an interim order against the Minister and the Commissioner (the defendants), enjoining them from taking any action under the Act against these companies in respect of investments they had made, until their status was

determined by the Court. The companies made their applications to the Court after having received demands from the Minister pursuant to subsection 8(3) of the Foreign Investment Review Act requiring BCFP and Western to file notices of certain investments for review under the Act. No date has yet been fixed for the hearing of the application for a declaration. These applications are being defended and the Government of Canada has appealed the interim injunction to the Federal Court of Canada, Appeal Division.<sup>1</sup>

In addition, on November 2, 1981, BCFP and Western applied to the Federal Court of Canada, Appeal Division, to question, under section 28 of the Federal Court Act, the Minister's decision to issue demands under the Foreign Investment Review Act. The Federal Court of Appeal, on March 23, 1982, heard a motion on behalf of the Government to dismiss these proceedings and rendered a unanimous judgment to the effect that the decision of the Minister to issue section 8(3) demands was not subject to review under the terms of section 28 of the Federal Court Act, and therefore the motion to dismiss the proceedings was successful.

#### ADMINISTRATION

For fiscal year 1981-82, the Agency was assigned a budgetary allotment of \$5,159,000 and 125 person-years. The actual expenditure was \$5,252,695, and 124 person-years. During the year, efforts were continued to meet the requirements of the Official Languages Act, and this objective has now been substantially reached. Also in 1981-82, a reorganization of Administrative Services was undertaken to improve the effectiveness of the Agency's finance, personnel, and administrative services.



## Organization of the Agency

The Foreign Investment Review Agency, whose sole responsibility is to advise and assist the Minister responsible for the administration of the Act, has three operational units: Compliance Branch, Assessment Bureau and Policy, Research and Communications Branch. Their functions and responsibilities are described below.

#### COMPLIANCE BRANCH

The Compliance Branch is responsible for the legal, enforcement and general administrative functions of the Agency.



The Rulings Division receives and verifies notices from investors who submit their investment proposals for review under the Act. It provides informal advice to investors, their counsel and Agency officials on the applicability of the Act and assists the Minister in discharging his statutory responsibility for issuing formal opinions on the eligibility status of applicants and on whether or not the proposed new business activities are related to existing activities of a business.


The Enforcement Division regularly monitors the implementation of plans and undertakings offered by investors whose applications have been allowed. It also ensures that investors whose proposals have been disallowed by the Governor in Council comply with the orders of disallowance within a reasonable period of time. This may involve making sure that new businesses which may have already been established cease operating; causing and monitoring the divestiture of an acquired Canadian business enterprise; and making certain that investment proposals that are disallowed are not implemented. The Enforcement Division also conducts investigations and inspections, informally or formally under the authority of the Act, into apparent instances of failure to comply with the Act, including implementation of investment proposals without Governor in Council approval, or on terms different from those contained in the proposal. And, it advises the Minister to invoke, when necessary, the remedial provisions of the Act (injunction, nugatory order, or an order to comply with undertakings).

The Personnel and Administration Division is responsible for the provision of all personnel, financial and general administration services required by the Agency. It also implements the various personnel management and financial control policies and programs of the Government of Canada and responds to the reporting requirements of the central agencies.

The Compliance Branch also coordinates the activities of the Department of Justice representatives assigned to the Agency who, in addition to providing general counsel and advice, represent the Department of Justice in matters relating to the Foreign Investment Review Act, specifically its interpretation, applicability and enforcement.

#### ASSESSMENT BUREAU


The Assessment Bureau, which is at the heart of the Agency's operations, analyses investment proposals against the criteria for the assessment of benefit to Canada. It has three branches, each carrying out the same functions in relation to one of the three broad sectors of the economy, namely: Construction and Services; Manufacturing Industries; and Resource Industries. During the past year a small-business group was established to provide a specially rapid analysis and assessment of small business proposals in the manufacturing and service sectors.



In all four units the analysis is based primarily on information provided by the investor in his notice or further information on companies and sectors provided by federal departments and agencies with policy responsibilities and expertise in the industry sectors involved. In addition, the Bureau maintains direct contact with provincial governments in order to determine how investment proposals relate to their industrial and economic policy objectives and to obtain their views on the proposals. Following this analysis, the Bureau advises the Minister and assists him in his own assessment of the proposals. The sections in this report on the caseload and significant benefits provide further insight into the work of the Assessment Bureau.

### POLICY, RESEARCH AND COMMUNICATIONS BRANCH

The Policy, Research and Communications Branch is responsible primarily for research and analysis in support of Agency operations and the development of government policy related to foreign investment. It reviews results achieved through the administration of the Act and helps to develop new approaches to improve the effectiveness of the program.



The Corporate Information and Surveillance Division investigates reports from the news media and unsolicited information from individuals and companies concerning acquisitions of Canadian businesses or the establishment of new businesses with a view to ensuring that the requirements of the Act are met and notices of reviewable transactions are filed with the Agency. In addition to its investigative functions, the division provides a key information service by maintaining a comprehensive data base on all investment proposals which come before the Agency. This data base is the cornerstone for the Agency's information program, including publications and responses to Parliament and the public and private sectors. It also underlies operational and administrative decisions made by senior management and is the basis for a variety of research projects undertaken within and outside the Agency. Furthermore, the division maintains a fairly comprehensive information network on Canadian and foreign companies in support of its surveillance activities as well as in support of a number of activities carried on by the Assessment Bureau and Compliance Branch.

The Policy Research Division maintains an information base on a number of areas, including the following: federal, provincial and foreign government policies on foreign investment; federal and provincial industrial policies; and international investment flows and balance of payments. Other information functions include responding to questions from MPs and senators and from the general public, preparing and giving briefings on FIRA for a variety of Canadian and foreign groups and receiving visitors at the Agency who seek information on the program and the Act. Policy research is the centre of the Division's work and, to this end, it participates in the federal Interdepartmental Committee on International Investment Policies, contributes to the development of federal policies related to foreign investment, reviews legislation that can have an impact on foreign investment and participates in the work of the Committee on International Investment and Multinational Enterprises of the Organization for Economic Co-operation and Development. The Division also carries out a wide range of research projects. In 1981-82, these projects covered issues such as Canada's international obligations under the GATT, the regulation of foreign investment in the United States, and why governments regulate foreign investment.

The Evaluation and Industrial Analysis Division is responsible for advice and analysis on industrial and corporate performance in support of the assessment and enforcement functions of the Agency. Equally important is the advice it provides in the determination of whether or not proposed acquisition or new business investments would be related to the existing business of applicants. The Division also provided the economic analysis for 73 enquiries on relatedness, as a complement to the legal considerations involved. In 1981-82, the Division carried out more than 150 studies in support of the Agency's assessment and enforcement roles.

The objective of the Communications Division is to ensure that foreign investors, their governments, their advisors and the general public fully understand the nature, objectives and requirements of the Foreign Investment Review Act, through publications and other means of communication. Among the publications are a biannual magazine, a quarterly report on activities under the Act, various working papers and an information kit for foreign investors and their legal advisors. The Division also participates in the development of the Agency's communication programs.


#### REVIEW PROCESS

As soon as a notice outlining an investment proposal is received by the Foreign Investment Review Agency, it is scrutinized by the Compliance Branch to determine whether or not the proposal is prima facie reviewable and whether the notice contains the information prescribed by the Foreign Investment Review Regulations. If the proposal is judged reviewable, it is passed on to the Assessment Bureau for evaluation based on the benefit criteria outlined in the Act. Frequently, during this stage, information additional to that contained in the notice is sought and obtained through contacts with the applicant and consultations with appropriate federal departments. The notice is also circulated to the province or provinces significantly affected by the proposal for their views and comments. Once all the necessary information has been assembled the case is then referred to the Minister, together with an assessment by the Agency of the perceived effects of the investment by reference to the factors prescribed in subsection 2(2) of the Act. If the Minister concludes that the investment is likely to result in significant benefit to Canada he must make a recommendation to the Governor in Council that the investment be allowed. If not, he must so inform the Agency, which informs the applicant accordingly. The applicant then

has the opportunity to make further representations. When those representations are completed the case is referred to the Minister a second time for a final decision as to what his recomendation will be.

Following is an illustration of the review process and the role played by the different branches of the Agency.


