he early years of children's lives are critical. The educators who teach and nurture young children in those years have an impact that will last for the rest of the children's lives. For most children, at least one educator will stand out as someone who encouraged, enabled and inspired them to be their very best when they were very young.

The Prime Minister's Awards for Excellence in Early Childhood Education honour outstanding and innovative early childhood educators who excel at fostering the early development and socialization of the children in their care, and at helping build the foundation children need to meet life's challenges.

First Ministers affirm their commitment to the well-being of children by setting out their vision of early childhood development as an investment in the future of Canada. Canada's future social vitality and economic prosperity depend on the opportunities that are provided to children today. Federal/Provincial/Territorial Early Childhood Development Agreement

### Awards

Up to six Certificates of Excellence, each including a financial award of \$5000.

Up to 15 Certificates of Achievement, each including a financial award of \$1000.

A Certificate of Excellence is awarded to the top-ranked early childhood educator in each of five regions: one in British Columbia and Yukon; one in the Prairies, Northwest Territories and Nunavut; one in Ontario; one in Quebec; and one in Atlantic Canada. In addition, one Certificate of Excellence is awarded annually to the top-ranked Aboriginal early childhood educator.

The next 15 top-ranked nominees each receive a Certificate of Achievement. At least one of the Certificates of Achievement is awarded annually to an Aboriginal early childhood educator.

Financial awards are provided directly to recipients. Award funds may be used for professional development, equipment, resource materials or other tools to improve developmental programming and children's experiences related to the educator's work.

### Recognition

All recipients receive a certificate, pin and letter of congratulations from the Prime Minister.

Certificate of Excellence recipients also receive a three-day, all-expenses-paid trip to Ottawa involving tours and best practice sessions, and culminating in the presentation of award certificates by the Prime Minister at a special event. Families are welcome and some activities are organized for them; however, please note that the Prime Minister's Awards program covers only recipients' travel costs.

Certificate of Achievement winners are honoured at local events involving children, supervisors, colleagues and local Members of Parliament or local leaders, as appropriate.

Each recipient's early childhood education setting, when applicable, also receives a certificate, signed by the Prime Minister, recognizing its support and contribution to the educator's achievement.

### Promotion

The achievements of all recipients are promoted both nationally and in the educators' home communities. Certificate of Excellence recipients will be profiled (with permission) in the Prime Minister's Awards program's publication *Exemplary Practices*, in print for educators across Canada and on the Internet for educators around the world. (The Certificate of Achievement recipients will also be mentioned in this publication.)

Corporate partner Canadian Learning Television will visit the early childhood education settings of Certificate of Excellence recipients to produce video snapshots of these winning early childhood educators and the children in their care. These clips will be shown at the awards ceremony on Parliament Hill and as public service announcements on Canadian Learning Television.

## Eligibility

- Nominees must be Canadian citizens or permanent residents.
- Nominees must work a minimum of 2.5 days a week providing direct education and care to young children in a licensed early childhood education setting (as defined by provincial or territorial government regulations<sup>1</sup>). Nominees who work in licensed early childhood education settings but who do not provide direct education and care to young children are not eligible for the award.
- Nominees must provide evidence of training in early childhood education and care in the form of one of the following:
  - ▲ degree, diploma or certificate in early childhood education and care;
  - official certification as an early childhood educator in the province or territory where the nominee is working; or
  - proof of completion of a training program in family child care.
- Nominees must have worked in a licensed Canadian early childhood education setting for at least three years.

Posthumous nominations are not accepted.

 This requirement is waived for nominees who work in Aboriginal Head Start sites on and off reserve or in early childhood education settings on reserve where there is no applicable provincial or territorial government licensing. Access to early childhood learning can strengthen the foundations of lifelong learning for all children and support the broad-based education and social needs

of families.

The Prime Minister's Awards are designed to honour the overall accomplishments of a single educator or a team of up to three educators. The program is not intended to recognize the achievements of an entire early childhood education setting or staff. Each member of a team must meet the eligibility requirements described above. Any cash award is to be shared equally among the team members.

Nominators may be any person or group with direct knowledge of the nominee's contribution.

### Renomination

Recipients of a Certificate of Achievement may be renominated for a Certificate of Excellence in a subsequent year, but are ineligible for a second Achievement award. Unsuccessful nominees may be renominated in a subsequent year. In all cases, complete and updated nomination packages must be submitted. Previous recipients of a Certificate of Excellence are not eligible.

### How Recipients Are Chosen

A committee of early childhood education and care practitioners and stakeholders from across Canada selects award recipients.

### Selection Criteria

Award recipients are selected based on their innovative approaches and outstanding ability to engage and support the development of the children in their care, and on their overall commitment to the development of children and the early childhood education and care profession. While an exemplary project or practice may form part of a nomination, nominees are judged on their overall merits as educators.

In selecting award recipients, the committee looks for clear evidence that nominees have excelled in the four areas described below.

#### Support of Child Development

The nomination text should describe how the educator provides daily experiences that support and promote each child's physical, emotional, social, cognitive, ethical and creative development, such as the following:

- optimizing each child's unique development
- encouraging children's interest and participation
- providing stimulating and engaging learning environment(s) for all children
- developing and maintaining warm, caring and responsive relationships with each child and with the group of children
- using observation to assess children's skills, abilities, interests and needs
- using developmentally appropriate "best practices."

#### Innovation

The nomination text should describe the educator's use of innovative and creative approaches to encouraging and supporting child development, such as the following:

- capturing and maintaining child interest
- exploring new or different ideas with children
- recognizing and adapting to children's special needs (including physical, emotional, social, cognitive and creative needs)
- recognizing and including diverse economic, cultural, linguistic and regional perspectives in the learning environment
- respecting and promoting children's home language and cultural heritage

- incorporating events and activities occurring in children's lives in the learning environment
- incorporating international, national, local and community events and activities in the learning environment.

#### Involvement with Parents, Families and the Community

The nomination text should describe the educator's efforts to involve and engage parents, families and the community in children's education and care, such as the following:

- developing and maintaining open, cooperative relationships with each child's family
- encouraging active parent, family and community involvement in children's learning
- developing and using innovative approaches to engaging and supporting parents and families
- fostering community contacts or partnerships that encourage or complement children's learning and activities
- developing and maintaining relationships with others in the early childhood education setting (such as colleagues) or with other community services involved with the children.

#### Commitment and Leadership in the Field

The nomination text should show the educator's ongoing professional development and commitment to improving the early childhood education and care field and to enhancing the ability of others in the profession, such as the following:

- engaging in ongoing personal professional growth and learning
- organizing or delivering professional development courses, workshops or other development activities
- developing and disseminating learning materials, resources and best practices
- providing support or training to other professionals in the field (such as mentoring and training of students)
- being actively involved in a professional organization, network or association related to early childhood education and care.

# How to Apply

- Use the attached nomination form to submit your nomination. This form is also available on the Internet (http://www.pma-ppm.ca/ece-e.asp).
- Forms must be signed by the nominee and the nominator, as well as by the nominee's supervisor, when applicable.
- When there is more than one nominee, please copy and complete a separate form for each.
- When more than one nomination package is received for an educator, nominators will be asked to combine their packages.

### Nomination Deadline

The deadline for nominations is February 14, 2003.

## Assembling a Nomination Package

An effective nomination package illustrates the outstanding achievements of the nominee and clearly explains why she or he should receive one of Canada's highest honours for early childhood educators. As a nominator, you are "painting a picture" of a nominee's achievements for a selection committee that reviews many applications, so the package should be compelling.

Your complete nomination package must not exceed 20 pages and should include the following items. You must submit an original and five copies of your nomination package.

- Signed nomination form (2 pages).
  - Nomination text (maximum 5 pages).
  - **Evidence of nominee's training in early childhood education and care** (such as a copy of a degree, diploma or certificate showing completion of training).

**Evidence of nominee's experience** (a minimum of three years in a licensed early childhood setting).

Letters of support (three required). Letters of support should provide evidence of the nominee's excellence and achievements under any or all of the four selection criteria. The selection committee looks at the picture painted in both the nomination text and the letters of support. Letters should not exceed one page and must be signed by the author. To reduce repetition, ask writers to focus on one or two specific things about the educator that make her or him exceptional. Letters may come from anyone with direct knowledge of the nominee's accomplishments; however, letters from parents, children, peers and professional associations are often particularly effective in demonstrating a nominee's impact.

Additional support materials (optional; maximum 5 pages). These could include, but are not limited to CD-ROMs, videotapes or Web sites with information about the nominee's work, relevant photos with captions, samples of children's work and activities, media reports, additional letters of support or a curriculum vitae. Please make copies of support materials, as they will not be returned.

Here are a few hints to help you prepare the nomination text.

**Follow the criteria set out in the nomination guidelines.** Provide adequate detail for each of the four categories of selection criteria. You may wish to organize your text using the same headings.

Provide concrete examples and details to show how the nominee has met the selection criteria and explain the impact of the educator's efforts. Describe any special projects or activities, philosophies, unique learning environments, or child reactions, outcomes or achievements that make this educator stand out.

Focus on the nominee's overall achievements. Show that the nominee is well rounded in her or his overall work, not just in one particular project. Include activities the nominee participates in to support the development of the children in her or his care, the setting in which she or he works, colleagues and the early childhood education and care field (such as volunteer work, professional development, advocacy or social events).
