

INTRODUCTION

This report covers the fiscal year ended March 31, 1971, and shows the statistics for bankruptcies and proposals in respect to the twelve months up to December 31, 1970. In addition, the report refers to certain other Branch activities which occurred after March 31, 1971

Chapter 4 of the report contains the annual statistical tables for bankruptcies and proposals, as well as a commentary on some of the highlights.

Appendix II shows the Tables of Contents of previous annual reports for the four years ending March 31, 1970.

Chapter 1

HIGHLIGHTS OF THE ACTIVITIES OF THE OFFICE OF THE SUPERINTENDENT OF BANKRUPTCY

Regional Offices

A major objective of the Bankruptcy Branch is to develop expertise and responsibility in its regional and sub-regional offices, with a view to the decentralization of certain Head Office activities. To help achieve this objective, emphasis is placed on professionalism in bankruptcy staff. This policy is reinforced with training and research programs.

Some functions have already been decentralized in regard to the western provinces, and this experience will aid in further deconcentration of activities, so as to give the public a speedier and more direct service.

Another objective of the Branch is to maintain, as much as is possible and practical, uniform standards of administration across Canada. This has been achieved by staffing an increasing number of sub-offices with trained bankruptcy officers acting as both official receivers and investigators.

A number of regional sub-offices were opened in 1970⁽¹⁾, and in the early part of 1971. Those opened in 1971 are:

Also, from April 1971, the Vancouver regional office assumed responsibility for all official receiver duties for the five remaining divisions in the District of British Columbia, that is, Prince Rupert, Victoria, Vernon, Nelson and Prince George. The Montreal Regional Office assumed responsibility, at the same time, for the Iberville district in Quebec.

There were 30 federally-employed official receivers as at April 30, 1971, appointed in 21 divisions across Canada.

Proceedings filed at Regional Offices

The schedule on the following page shows the percentage of proceedings filed at these regional offices and sub-offices.

Federally-employed official receivers filed 3,163 estates, or 53% of all bank-ruptcies and proposals recorded in 1970, compared to 45% in 1969. The deficiency in these estates amounted to \$101,540,000, or 62% of the total deficiency reported in Canada.

Research and Development

Report of the Study Committee on Bankruptcy Legislation

The Department of Consumer and Corporate Affairs received many submissions following the publication of the Committee's report in 1970. It made a careful study of the representations, and they are taken into consideration in the drafting of a bill revising the Bankruptcy Act.

Bulletins to Trustees and Others

The subjects for future bulletins cover the administration of proposals, sales of bankruptcy assets, conflict of interest situations, and various other administrative procedures under the Bankruptcy Act.

A Handbook for Inspectors is in final preparation and will shortly be available to the public. Its objective is to give inspectors a better understanding of their responsibilities and duties in a bankruptcy.

Training and Development

Annual Bankruptcy Branch Seminar

The Bankruptcy Branch seminar, held in March 1971 for employees of the Branch, dealt with the official receiver's examination of the bankrupt, the trustee's initial administration of an estate, preferential payments, secured creditors and legal aspects of investigations.

Experts in these fields lectured at the seminar and led discussions for the participants.

In-House Training

Seminars in regional offices were continued during the past year. These discussions, which help staff appreciate Branch objectives, are to receive greater emphasis in Branch training programs.

Chapter 2

COMPLAINTS, INVESTIGATIONS AND PROSECUTIONS

Total Number of Investigations

From January 1, 1966 to July 31st, 1971, a total of 1,909 complaints were registered, of which 1,177 warranted field investigations. The remaining 732 complaints were of an administrative nature, and were settled by means of routine correspondence. Since January 1, 1967, prosecutions have been initiated in 138 cases, involving a total of 594 charges under both the Bankruptcy Act and the Criminal Code.

Results For The Year Ended December 31, 1970

Complaints registered in 1970

Three hundred and one (301) complaints were registered in 1970. Of these, 131 were closed during the year; desk reviews or field investigations were in progress for the remaining 170 complaints at the close of the year.

Chapter 3

LICENSING OF TRUSTEES IN BANKRUPTCY

Table B shows the numbers of licences issued and withdrawn during the calendar years 1950 to 1970.

Since 1967, when the current licensing policy was established, 180 applicants for licences were asked to appear before Boards of Examination. Of this number, a total of 57 applicants met the desirable standards, and were issued licences during the years 1968, 1969 and 1970.

Chapter 4

STATISTICAL TABLES

Highlights

A total of 5,659 bankrupt estates, and 315 proposals⁽¹⁾ were reported in the calendar year 1970. The estimated total loss to creditors is reported at \$164,388,000, an increase of \$52,112,000 over 1969 (46%).

A deficit of \$120,550,000 is reported in business bankruptcies, and \$33,047,000 in non-business bankruptcies. Combined losses in these estates is estimated at \$153,597,000. (See below for proposals).

Of the 5,659 bankrupt estates reported, 51.7% were businesses (2,927 estates), accounting for 78.5% of the deficiency for bankruptcies.

Non-business bankruptcies (2,732 estates) represented 48.3% of the bankrupt estates reported, showing 21.5% of the deficiency for bankruptcies.

During 1970, 315 proposals were filed. The court ratified 216, including 49 proposals held over from 1969. The deficiency estimated by debtors for proposals approved in 1970 was \$10,791,000. This deficiency accounts for 6.6% of the total reported loss (both bankruptcies and proposals) to creditors for the year 1970.

Table G-5 shows that the wholesale and retail trades accounted for the largest percentage (51.2%) of industrial and commercial failures during 1970.

⁽¹⁾ Ninety-three (93) proposals were later rejected. These, deemed bankruptcies, are included in the 5,659 bankrupt estates reported.

Other Comments on Statistics

Table C — This table shows the number of estates administered under the Bankruptcy Act for the years 1933 to 1970. Bankruptcies increased by 1,580 estates over 1969 (38.7%) with proposals increasing by 49.

Table D — This table shows the 12 Bankruptcy districts in Canada and lists the divisions into which districts are divided. The table also shows the location of Bankruptcy Branch offices as at April 1971.

Table E — This table shows that in the district of Quebec, division number 1 (Montreal area) handled 1,392 estates or 57% of all estates filed in that Province. No estates were reported in divisions numbered 11 and 14 (Gaspé, Bonaventure, Iles de la Madeleine) showing no change from 1969.

In Ontario, division number 9 (Toronto area) handled 957 estates or 36% of all estates filed in the province, (no change from 1969); division number 7 (Hamilton area) handled 392 estates or 15%, (13% in 1969); division number 5 (London area) shows 219 estates (135 in 1969) or 8% of the Province, (no change from 1969).

In British Columbia, the Vancouver area (division number 3) shows 248 estates or 76% of the total estates filed in that Province, compared to 151 estates and 79% in 1969.

Table F — This table shows that corporations made up 17% of the total bankrupt estates reported. Of the 2,927 business bankruptcies, 244, or approximately 8% were initiated by receiving orders.

In the 2,732 non-business estates, 13 or less than 1% were initiated by receiving orders.

Graph I — This graph illustrates the number of bankruptcies and proposals reported for the whole of Canada, and those in the districts of Ontario and Quebec, during the past fourteen years.

Table G — This table shows the total number of estates reported in each Bankruptcy district during the year. The Province of Quebec accounts for 41.0% of the number of estates reported (48.6% in 1969) and 43.1% of the deficiency estimated by debtors (49.6% in 1969). The Province of Ontario accounts for 44.6% (38.6% in 1969) of the reported number of estates and 36.3% (35.5% in 1969) of the estimated deficiency, (see also Table G-7).

Tables G-1, G-2, G-3 — These tables provide a breakdown of Table G into Business Bankruptcies Reported in 1970 (Table G-1), Non-Business Bankruptcies Reported in 1970 (Table G-2), and Proposals in 1970 (Table G-3).

Table G-4 — This table gives an analysis, by district, of persons who had acted as guarantors for corporate, business or personal debts, and who subsequently made assignments themselves, or were petitioned into bankruptcy. These statistics have been incorporated into Table G, as well as into supporting tables G-1 or G-2.

Table G-5 — This table gives a breakdown of the business bankruptcies by 7 major types of industries and 27 sub-types.

Table G-6 — This table shows the number of bankruptcies classified by size of declared liabilities.

Of the 946 bankrupt corporations, 388 (41%) reported liabilities of \$100,000.00 and over; 393 corporations (42%) reported their liabilities as between \$25,000.00 and \$100,000.00, and 165 corporations (17%) reported liabilities of up to \$25,000.00.

One thousand nine hundred and eighty-one (1,981) non-incorporated businesses reported their liabilities as follows:

95 (5%) - \$100,000.00 and over 729 (37%) - \$25,000.00 to \$100,000.00 1,157 (58%) - up to \$25,000.00

Tables G-7, G-8, G-9 — These tables provide a comparative percentage, or commonsize analysis, by district, of the number of estates, total assets, total liabilities and total deficiency for bankruptcies reported in 1970.

Graph II – This graph illustrates the number of estates reported, and the estimated deficiency in 1970, as noted in Table G.

Table H — This table shows the total realizations by trustees, as well as administrative expenses and dividends for bankrupt estates and proposals closed in 1970.

Tables H-1, H-2, H-3 — These tables provide the detailed amounts for bankruptcies and proposals summarized in Table H.

Tables H-4, H-5, H-6, H-7 — These tables show the various administrative expenses as percentages of realizations by trustees, as well as the dividend payments in relation to the liabilities owing to unsecured creditors. In addition, percentages are calculated for realizations in relation to liabilities.

For all estates closed in 1970 (bankruptcies and proposals), trustees realized \$25,112,000 from available assets, as compared to total reported unsecured liabilities of \$166,728,000. Trustees therefore realized 15.1% of the amount of the declared unsecured liabilities.

Administrative expenses amounted to 44.7% of the realizations, with trustees' fees accounting for 21.7%, and legal fees, 5.3% of these proceeds. Dividends were calculated at 8.3% of unsecured liabilities. (See Table H-8 for more detailed calculations.)

Looking at Table H-5 (estates closed under the general provisions of the Act), 1,975 estates were involved. Trustees realized 16.2% of the amount declared owing to unsecured creditors. Administrative expenses were 48.9% of realizations. Trustees' fees accounted for 20.3% of these proceeds, and legal costs for 6.6%. Dividends paid to unsecured creditors in these estates amounted to 8.3% of declared liabilities.

Table H-6 shows the position for summary administrations. Trustees realized 6.6% of the amount declared owing to unsecured creditors in the 2,917 estates closed.

The administrative expenses in summary administrations were 76.3% of realizations, trustees' fees being 59.4%, and legal costs, 2.9%. Dividends paid to unsecured creditors amounted to 1.6% of the declared liabilities.

Table H-7 shows the same type of information for proposals. In all, trustees received \$5,707,000 or 20.6% of the amount declared owing to unsecured creditors. Administrative expenses were 20.0% of these proceeds, with trustees receiving 11.5% and solicitors 2.4%. Dividends amounted to 16.5% of the amount of unsecured liabilities declared by debtors.

Tables H-8, H-9, H-10, H-11 — These tables show the dividend split between preferred and other unsecured creditors, and the calculation of the percentage return for both classes of creditors. In all estates (bankruptcies and proposals), preferred creditors received 28.3%, and others, 6.8%.

Part X of the Bankruptcy Act

Part X of the Bankruptcy Act may be proclaimed by the Governor General in Council to be in force in any province at the request of the Lieutenant Governor in Council of the province concerned. It has been in force in the Province of Alberta since April 17, 1967, and in the Province of Manitoba since June 1, 1967. The Province of Saskatchewan adopted Part X on April 1, 1969; the Province of British Columbia on June 1, 1970, and the Province of Nova Scotia on July 1, 1970. It was proclaimed in Prince Edward Island on March 28, 1968, and activated in April 1971.

The following are the number of consolidation orders granted in each province, since the proclamation of Part X, to December 31, 1970.

REPORTED FOR THE CALENDAR YEARS 1957 to 1970



REPORTED IN THE CALENDAR YEAR 1970










