## South Coast Assessment Bulletin 2021 Final Creel Survey Update Recreational Fishery South Coast Tidal Waters

## Overview:

This bulletin provides a preliminary review of the 2021 estimates of recreational fishing effort and fin-fish catch by month in the marine waters of southern British Columbia (Pacific Fishery Management Areas 11 through 29 and 121 to 127). These estimates are generated from data collected by DFO's South Coast Creel Survey, paper and electronic logbooks and lodge manifests. A brief overview of the survey, the study area and methods used to collect data and generate these estimates are provided in the first bulletin of 2021 available on the Federal Science Library

## Creel Survey Data:

The number of angling trip interviews and effort flights conducted by month and area are presented in Table 1 and 2, respectively. Estimates of recreational effort, measured in boat trips, by area and month are presented in Table 4. A map of Pacific Fishery Management Areas is in the British Columbia Tidal Waters Sport Fishing Guide.

## Recreational Catch Estimates:

Final post season estimates of kept and released catch for key finfish species (or groups of species) are presented in a series of Tables attached to this document. Each of the tables presents catch estimates partitioned by both creel area and month as well as rolling up the estimates into regional totals. The regional groupings are 1.) North Island (PFMAs 11, 111, 12) 2.) West Coast of Vancouver Island - WCVI (PFMAs 20-1 to 20-4, 21, 121, 23-27, 123-127), 3.) Strait of Georgia (PFMAs $13-18,19-7$ to 19-12, 28, 29) and 4.) Juan de Fuca (PFMAs 19-1 to 6, 20-5). In addition these tables sum the 2019 estimates by creel area and regional grouping and provide the 5 -year average estimate for the same areas for comparison. The tables containing blank cells indicate areas and times not surveyed. Percent standard error (\%SE, a measure of uncertainty) is presented for estimates where it is calculated. Tables present kept and released catch estimates for: Chinook (Tables 5 and 6; Chinook kept catch is also partitioned to aggregate abundance-based management (AABM) and individual stock-based management (ISBM) groupings in Table 3), Coho (7 and 8), Chum (9 and 10), Pink (11 and 12), Sockeye (13 and 14), Halibut (15 and 16), Lingcod (17 and 18), combined China, Copper, Quillback, Tiger and Yelloweye rockfish (19 and 20), and other rockfish (including identified rockfish other than the five in Table 19 and 20 as well as those unidentified to species; Tables 21 and 22).

## Update:

As of March 2022, catch and effort estimates for the creel sub-areas within the management corridor along the west coast of Vancouver Island (i.e. 1 nm seaward from the surfline, from Barkley to Quatsino) are now included as part of the associated offshore PFMA, with the exception of Chinook AABM/ISBM catch estimates (Table 3) as per the Pacific Salmon Treaty.
