## INTRODUCTION

---

Each year, parliamentary committees undertake numerous studies based on the permanent or specific mandates given to them by the House of Commons. For instance, they study bills and may amend them before sending them back to the House of Commons. They are involved in the review of the government's spending by examining departmental estimates, reports on plans and priorities (departmental plans) and performance reports. They also participate in the review of Order in Council appointments by calling nominees to appear. Furthermore, committees may initiate their own studies on issues related to the subject areas of their mandates. In conducting these studies, committees will hear from witnesses and, in most cases, will present a report of their findings and recommendations back to the House of Commons. Given the number and scope of their studies, it is clear that committees play an essential role in the work of the House of Commons.

The [Liaison Committee](#), composed of the Chairs of all standing committees and the House Co-Chairs of standing joint committees, is empowered to deliberate on administrative matters relating to the standing committee system. Its main responsibility is to apportion funds to standing committees from the money allocated for that purpose by the Board of Internal Economy. To this end, a global envelope in the amount of \$4 million for the 2021-22 fiscal year, is available to committees for their activities.

The [Reports on Committee Activities and Expenditures](#), which are usually prepared three times per fiscal year by the Liaison Committee, present cumulative financial information on committees' expenditures and the work they are doing. When required, they also include information on special committees, which are normally funded by the Board of Internal Economy. They serve as essential reporting and accountability mechanisms, not only for activities, but also for the use of the resources at committees' disposal. By summarizing and consolidating statistics regarding the number of meetings, meeting hours, reports and witnesses for each committee, these reports, presented in a format intended to help readers better understand the work of committees, provide readers with a concise summary of committee mandates, activities and expenditures. Finally, they complement other reports and disclosure tools available to Canadians on the Board of Internal Economy [website](#).

It is worth noting in this report that the measures taken by the House of Commons in the context of the COVID-19 pandemic have had an important impact on committees and their activities. Since April 2020, the House of Commons has adopted special orders authorizing committees to hold hybrid meetings. Committee members could attend



meetings in person or via videoconference while witnesses were required to participate remotely. In December 2021, the House adopted a motion ordering that Members, Senators and departmental and parliamentary officials appearing as witnesses before committees may do so in person. Hybrid committee meetings have led to many changes in work methods and logistical processes, especially with the additional preparations of witnesses in advance of their remote appearance before a committee. Details are available in Appendix A of this report.

Due to the 44th federal election period having occurred during this fiscal year, the present report will cover the periods from April 1, 2021 to August 15, 2021 (dissolution of Parliament) and from November 22, 2021 (resumption of Parliament) to December 31, 2021. During these periods, committees held a total of 510 meetings, heard from 2,179 witnesses and presented 99 reports to the House.

In May 2021, during the 2nd Session of the 43rd Parliament, the House of Commons adopted a motion amending the Standing Orders to create the Standing Committee on Science and Research, effective at the beginning of the 44th Parliament. As a result, information about this new standing committee appears for the first time in this report.

We hope this report provides helpful and concise information on the activities of committees, thus giving a better sense of their important work on behalf of Canadians.

## NOTE TO READER

---

This is the second report for the 2021-22 fiscal year. In this report, information about each committee's activities and expenditures is presented through a combination of descriptive text and tables containing statistical and financial information. The section for each committee includes a short overview of committee activities, tables on committee expenditures, travel expenditures (if applicable) and statistical information on the number of committee meetings, witnesses and reports. This "Note to Reader" provides contextual information to assist the reader in interpreting the information in each table.

### EXPENDITURES

The "Expenditures" table summarizes committee expenditures for the period from April 1, 2021 to December 31, 2021. Committee studies are listed in chronological order. Expenditures are broken down by "Witness Expenses," "Videoconferences," "Working Meals," "Hospitality" and "Other." "Other" may include expenditures such as reports, professional services, audio-visual equipment and minor miscellaneous expenses. The row "Operational Budget" contains expenditures for which no separate funding request was made in relation to a study or an activity of a committee. Differences in totals are due to rounding.

### TRAVEL EXPENDITURES

The "Travel Expenditures" table summarizes committee travel expenditures for the period from April 1, 2021 to December 31, 2021. Expenditures are broken down by "Transportation," "Accommodation," "Per Diems," "Working Meals," "Hospitality" and "Other." "Other" may include expenditures such as audio-visual equipment, meeting rooms, passport and visa processing, conference fees and other minor miscellaneous expenses. This table is only included for committees that incurred travel expenses in the specified period. If a trip was cancelled, this is noted instead of dates of travel. Expenses for cancelled travel include only those expenses incurred prior to cancellation that could not be reimbursed or made available as credits for future travel, including travel by other committees. Differences in totals are due to rounding.

In relation to travel expenditures, following a decision of the Liaison Committee at its meeting of June 5, 2019, detailed travel expenditure reports are now prepared and published consistent with the manner provided for in Bill C-58, An Act to amend the



Access to Information Act and the Privacy Act and to make consequential amendments to other Acts. Bill C-58 received Royal Assent on June 21, 2019. Detailed travel expenditure reports, broken down by travel activity and by individual or group, when available, are found at

It should be noted that, pursuant to a decision of the Board of Internal Economy concerning preventative measures in the context of the COVID-19 pandemic, committee travel has been suspended during the entire period covered by this report.

## **MEETINGS, WITNESSES AND REPORTS**

The “Meetings, Witnesses and Reports” table contains information about committee meetings, witnesses and reports presented to the House for the period from April 1, 2021 to December 31, 2021. In addition to the total number of committee meetings in this period, the table identifies the number of committee meetings that were televised and the number of meetings that were webcast (audio or video of public meetings is available on an archival basis through the committees website), the number of meetings where videoconferencing technology was used to allow the committee to hear from witnesses appearing remotely and the number of meetings video recorded by members of the Canadian Parliamentary Press Gallery. Statistics for the standing committee and, if applicable, each of its subcommittees, are presented in separate rows. In practice, most committees create a subcommittee on agenda and procedure, commonly referred to as a “steering committee,” to help them plan their work. The establishment of subcommittees is usually designed to relieve parliamentary committees of planning and administrative tasks or to address important issues relating to their mandate. Subcommittees are not empowered to report to the House; they only present reports to their standing committee.

## STANDING COMMITTEES

### STANDING COMMITTEE ON ACCESS TO INFORMATION, PRIVACY AND ETHICS (ETHI)

#### Mandate

The Standing Committee on Access to Information, Privacy and Ethics studies matters related to the Office of the Information Commissioner of Canada, the Office of the Privacy Commissioner of Canada and the Office of the Commissioner of Lobbying of Canada, and certain issues related to the Office of the Conflict of Interest and Ethics Commissioner.

#### Summary of Committee Activity

During the period of April 1 to August 15, 2021, the committee continued to meet in a hybrid format and continued its studies of questions of conflict of interest and lobbying in relation to pandemic spending and of protection of privacy and reputation on platforms such as Pornhub. The committee held four additional meetings with one witness in this period concerning the study of questions of conflict of interest and lobbying in relation to pandemic spending and held five additional meetings with an additional 19 witnesses in relation to the study of the protection of privacy and reputation on online video platforms such as Pornhub. The committee commenced consideration of the Main Estimates 2021-22, as well as a study on the use and impact of facial recognition technology with an opening meeting with the Privacy Commissioner. Additionally, the committee endorsed the reappointment of the Privacy Commissioner of Canada following the referral of the certificate of nomination to that effect. Finally, the committee presented three reports to the House in this period, with the first to report the Main Estimates 2021-2022, the second on the study of questions of conflict of interest and lobbying in relation to pandemic spending and the third concerning the study of protection of privacy and reputation on platforms such as Pornhub.

During the period of November 22 to December 31, 2021, the committee held its first meeting of the 44th Parliament on December 13. At that meeting, Pat Kelly was elected Chair of the committee. The committee agreed to undertake a study on the use and impacts of facial recognition technology.

## **STANDING COMMITTEE ON AGRICULTURE AND AGRI-FOOD (AGRI)**

### **Mandate**

The Standing Committee on Agriculture and Agri-Food studies bills, government activities and expenditures, and issues related to Canada's agriculture and agri-food industry.

### **Summary of Committee Activity**

From April 1 to August 15, 2021, the committee held 17 meetings. It completed its study of processing capacity and presented its fourth report, entitled *Room to Grow: Strengthening Food Processing Capacity in Canada for Food Security and Exports*, to the House on May 4. The committee continued its consideration of Bill C-206, An Act to amend the Greenhouse Gas Pollution Pricing Act (qualifying farming fuel) and reported it back to the House with amendments on May 12. Pursuant to the order of reference of the House of March 10, the committee considered Bill C-205, An Act to amend the Health of Animals Act. It held five meetings, heard from 28 witnesses, received 72 briefs on the topic and reported the bill back to the House with amendments on June 21. During this period, the committee also considered the Main Estimates 2021-22 and undertook a study of the environmental contribution of agriculture.

During the period of November 22 to December 31, 2021, the committee met two times. The organization meeting was held on December 16. At this meeting, Kody Blois was elected Chair of the committee. The committee met a second time on December 21, for a briefing on the interim suspension of certification of all potatoes originating from Prince Edward Island to the United States.

During this period, the committee completed its consideration of Bill C-10, An Act to amend the Broadcasting Act and to make related and consequential amendments to other Acts, with a further 21 meetings on the subject, including appearances from the Minister of Canadian Heritage and the Minister of Justice. The committee reported the Bill to the House with amendments on June 14. The committee presented its fourth report on April 27, for the study of the challenges and issues faced by the arts, culture, heritage and sport sectors during the COVID-19 pandemic. One meeting each was also allocated to the subjects of funding to locate the remains of Indigenous children buried on the grounds of former residential schools and educational publishing in Canada.

During the period of November 22 to December 31, 2021, the committee met once, on December 13, and the Hon. Hedy Fry was elected Chair of the committee.

Bill C-230, An Act respecting the development of a national strategy to redress environmental racism, on which it held three meetings and heard from 14 witnesses, was reported back with amendments to the House on June 22.

During the period of November 22 to December 31, 2021, the committee met once, on December 14, and elected Francis Scarpaleggia as Chair of the committee.

## **STANDING COMMITTEE ON FINANCE (FINA)**

### **Mandate**

The mandate of the Standing Committee on Finance is to study and report on all matters relating to the mandate, management and operation of selected federal departments and agencies, including the Department of Finance and the Canada Revenue Agency, and to conduct pre-budget consultations.

### **Summary of Committee Activity**

During the period of April 1 to August 15, 2021, the committee continued its study of COVID-19 spending, programs, and related monetary policy. The committee held seven additional meetings and heard from 50 additional witnesses. The committee also studied the Monetary Policy Report and the Economic and Fiscal Outlook, hearing evidence from the Governor of the Bank of Canada and the Parliamentary Budget Officer. During its study of Canada Revenue Agency's efforts to combat tax avoidance and evasion, the committee held six meetings and heard from 20 witnesses, including the Law Clerk and Parliamentary Council, the Department of Finance and the Canada Revenue Agency. Furthermore, the committee considered Bill C-30, the Budget Implementation Act, 2021, No. 1 and reported it back to the House with amendments on June 7. In August, the committee held two meetings to study coming into force of Bill C-208, An Act to amend the Income Tax Act (transfer of small business or family farm or fishing corporation), hearing evidence from officials from the Department of Finance as well as from the Law Clerk and Parliamentary Counsel, a former Speaker of the House of Commons, a former Member of Parliament, the Canadian Federation of Agriculture and the Fédération de la relève agricole du Québec.

During the period of November 22 to December 31, 2021, the committee held 10 meetings. On December 6, at the committee's first meeting of the 44th Parliament, Peter Fonseca was elected Chair. Furthermore, the committee considered Bill C-2, An Act to provide further support in response to COVID-19. The committee reported the Bill to the House with amendments on December 14. The committee agreed to commence Pre-budget Consultations for the 2022 Budget during the week of January 31, 2022.

The Standing Committee on Fisheries and Oceans studies and reports on matters related to the federal role in the management of Canada's fisheries and the safeguarding of its waters.

### **Summary of Committee Activity**

From April 1 to August 15, 2021, the committee held 16 meetings. The committee also undertook a study of corporate offshore licences which lasted two meetings.

The Standing Committee on Foreign Affairs and International Development studies matters related to international affairs, including Canada's foreign policy and development assistance. The government department under the committee's scrutiny is the Department of Foreign Affairs, Trade and Development.

### **Summary of Committee Activity**

During the period of April 1 to August 15, 2021, the committee continued its study of the vulnerabilities created and exacerbated by the COVID-19 pandemic and on June 10, the Chair presented the committee's seventh report, which was an interim report on the rights of children. The committee completed its study of the granting of arms export permits, with the Chair presenting report number nine on the subject on June 21. The Chair also presented reports on the impact of COVID-19 on displaced persons from Venezuela and Myanmar and on the role of the Canadian Ombudsperson for Responsible Enterprise. In addition, the committee held several briefing sessions which included the current situation of Alexei Navalny, the current situation in Ukraine, the COVAX initiative and the current situation in Israel, the West Bank and Gaza. Finally, the committee held one meeting on the Main Estimates 2021-22.

During the same period, the Subcommittee on International Human Rights (SDIR) held 11 meetings. It undertook six briefings on the current human rights situations in six different regions: Hong Kong, the Philippines, Colombia, Turkey & Northern Syria, Iran and Afghanistan. The subcommittee initiated and held two meetings on a study of impacts of COVID-19 on human trafficking and modern slavery. During this period the subcommittee also held five meetings on its study of the role of the Canadian Ombudsperson for Responsible Enterprise, adopting a report in relation to this study on June 1.

During the period of November 22 to December 31, 2021, the committee met once. On December 13, the committee held its organization meeting where Sven Spengemann was elected Chair. The subcommittee on agenda and procedure also met on December 22 in order to discuss the future work of the committee.

During this period, the committee also dedicated one meeting for each of the following studies: 2014 Centennial Flame Research Award, the rapid housing initiative and the Order in Council appointment of Romy Bowers to the position of President of the Canada Mortgage and Housing Corporation. Pursuant to the order of reference from the House of May 26, the committee also considered Bill C-265, An Act to amend the Employment Insurance Act (illness, injury or quarantine) and reported it back to the House, without amendments, on June 21.

During the period of November 22 to December 31, 2021, the committee held three meetings. On December 13, it held its first meeting of the 44th Parliament during which it elected Robert J. Morrissey as Chair. During this period, the committee considered Bill C-3, An Act to amend the Criminal Code and the Canada Labour Code, and reported the Bill back to the House, with amendments, on December 15.

## **STANDING COMMITTEE ON JUSTICE AND HUMAN RIGHTS (JUST)**

The Standing Committee on Justice and Human Rights studies the bills, policies, programs and spending of the Department of Justice and the six federal agencies related to its portfolio.

### **Summary of Committee Activity**

During the period of April 1 to August 15, 2021, the committee completed its study of controlling or coercive conduct within intimate relationships and presented its ninth report on April 27. The committee then studied the impact of COVID-19 on the judicial system, holding two meetings in which it heard from 14 witnesses. Afterwards, the committee studied the Canadian victims bill of rights, holding two meetings and hearing from 12 witnesses. At the request of four members of the committee (S.O. 106(4)), the committee met to discuss their request to invite the Minister of Justice to respond to questions about the vetting of judicial appointments. The committee then studied the nomination of the Honourable Mahmud Jamal to the Supreme Court of Canada and heard from the Minister of Justice and the Right Honourable Kim Campbell. Finally, on June 23, the committee presented its 10th report, entitled *Elder Abuse: Identifying the Issue and Combatting All Types of Abuse* after holding seven meetings and hearing from 34 witnesses.

During the period of November 22 to December 31, 2021, the committee met for the first time in the 44th Parliament. It held its organization meeting on December 16 to elect its Chair, Randeep Sarai.

The committee also heard from the National Defence and Canadian Armed Forces Ombudsman and the former National Security and Intelligence Advisor to the Prime Minister. A few meetings were suspended and then resumed over a period of several weeks. Three meetings were held to consider draft reports, but no reports were presented to the House during this period. Three meetings were held in response to a request by four members of the committee, pursuant to Standing Order 106 (4).

During the period of November 22 to December 31, 2021, the committee met once. On December 15, at the committee's first meeting of the 44th Parliament, John McKay was elected Chair of the committee.

During this period, the Subcommittee on Private Members' Business (SMEM) met once to determine the votability of items recently placed on the order of precedence, upon which the committee presented its 16th report on June 11. The report was deemed concurred in by the House upon its presentation.

The committee held three meetings during the period of November 22 to December 31, 2021. It was created by the House on December 2. At its first meeting of the 44th Parliament, on December 3, the committee elected the Hon. Bardish Chagger as Chair. On December 14, it received a briefing from the Conflict of Interest and Ethics Commissioner.

## **STANDING COMMITTEE ON PUBLIC SAFETY AND NATIONAL SECURITY (SECU)**

### **Mandate**

The Standing Committee on Public Safety and National Security reviews legislation, policies, programs and expenditure plans of government departments and agencies responsible for public safety and national security, policing and law enforcement, corrections and conditional release of federal offenders, emergency management, crime prevention and the protection of Canada's borders.

### **Summary of Committee Activity**

During the period from April 1 to August 15, 2021, the committee met 16 times. The committee continued its study of systemic racism in policing in Canada, meeting six times and culminating in the presentation of its sixth report to the House on June 17. Following a briefing on the final report on the implementation of the Merlo Davidson settlement agreement in the previous period, the committee held one meeting to study the report and concurred the findings and recommendations contained therein as its seventh report presented to the House on June 22. The committee also concluded its study of the Parole Board of Canada and the circumstances that led to a young woman's death, holding three meetings and presenting its eighth report to House on June 22. On May 5, the committee held a meeting at the request of four members of the committee (S.O. 106(4)) and agreed to undertake a study of ideologically motivated violent extremism. The committee commenced this study and held three meetings on this matter. Finally, the committee began a study of the current situation in federal prisons in relation to Correctional Service Canada's response to COVID-19, the implementation and operation of structured intervention units and reports of sexual coercion and violence in federal prisons, holding two meetings.

During the period from November 22 to December 31, 2021, the committee met three times. The organization meeting was held on December 8, following the adoption of a motion in the House calling for the committee to be convened on a priority basis. The Hon. Jim Carr was elected Chair of the committee. Pursuant to the same House motion, the committee commenced a study of gun control, illegal arms trafficking and the increase in gun crimes committed by members of street gangs. The committee was convened a second time on December 14, at the request of four committee members pursuant to Standing Order 106(4), to discuss the organization of its proceedings. On December 16, the Minister of Public Safety appeared before the committee accompanied by officials from the Department of Public Safety and Emergency

Preparedness, the Canada Border Services Agency and the Royal Canadian Mounted Police.

### SPECIAL COMMITTEE ON CANADA-CHINA RELATIONS (CACN)

#### Mandate

The House of Commons appointed a special committee with the mandate to conduct hearings to examine and review all aspects of the Canada–China relationship, including, but not limited to, consular, economic, legal, security and diplomatic relations on December 10, 2019. On September 23, 2020, the House reestablished the special committee.

#### Summary of Committee Activity

During the period of April 1 to August 15, 2021, the committee continued its study of Canada-China relations with a special focus on national security issues for a total of nine meetings. It heard from 41 witnesses including the Minister of National Defence, the Minister of Foreign Affairs as well as the Minister of Health. On May 26, the committee presented its third report to the House. This report recommended that the House adopt an order for the production of documents regarding the transfer of viruses to the Wuhan Institute of Virology in China in March 2019 and the subsequent departure of two employees from the National Microbiology Laboratory. The House considered this report on June 23. The committee ceased to exist as of dissolution on August 15, 2021.

The special committee shifted focus during this time to examine “Buy America” procurement policies and heard from the Minister of Small Business, Export Promotion and International Trade as well as the Minister of Foreign Affairs, various business leaders and academics. On June 16, the Chair of the special committee presented the second report, as required in the House Order. The committee ceased to exist as of dissolution on August 15, 2021.

### **SPECIAL JOINT COMMITTEE ON MEDICAL ASSISTANCE IN DYING (AMAD)**

#### **Mandate**

The special joint committee was appointed to undertake a review of the provisions of the Criminal Code relating to medical assistance in dying and their application, including but not limited to issues relating to mature minors, advance requests, mental illness, the state of palliative care in Canada and the protection of Canadians with disabilities.

#### **Summary of Committee Activity**

During the period of April 1 to August 15, 2021, the committee held its first meeting on May 17 and elected the Honourable Yonah Martin and the Honourable Hedy Fry as Joint Chairs of the committee. During the period of June 7 to June 21, pursuant to the orders of reference from the House of Commons on April 16, 2021 and from the Senate on April 20, 2021 and subsection 5(1) of An Act to amend the Criminal Code (medical assistance in dying), the committee undertook the statutory review of the provisions of the criminal code relating to medical assistance in dying and their application. The committee held three meetings and heard from six witnesses. The committee ceased to exist as of dissolution on August 15, 2021.

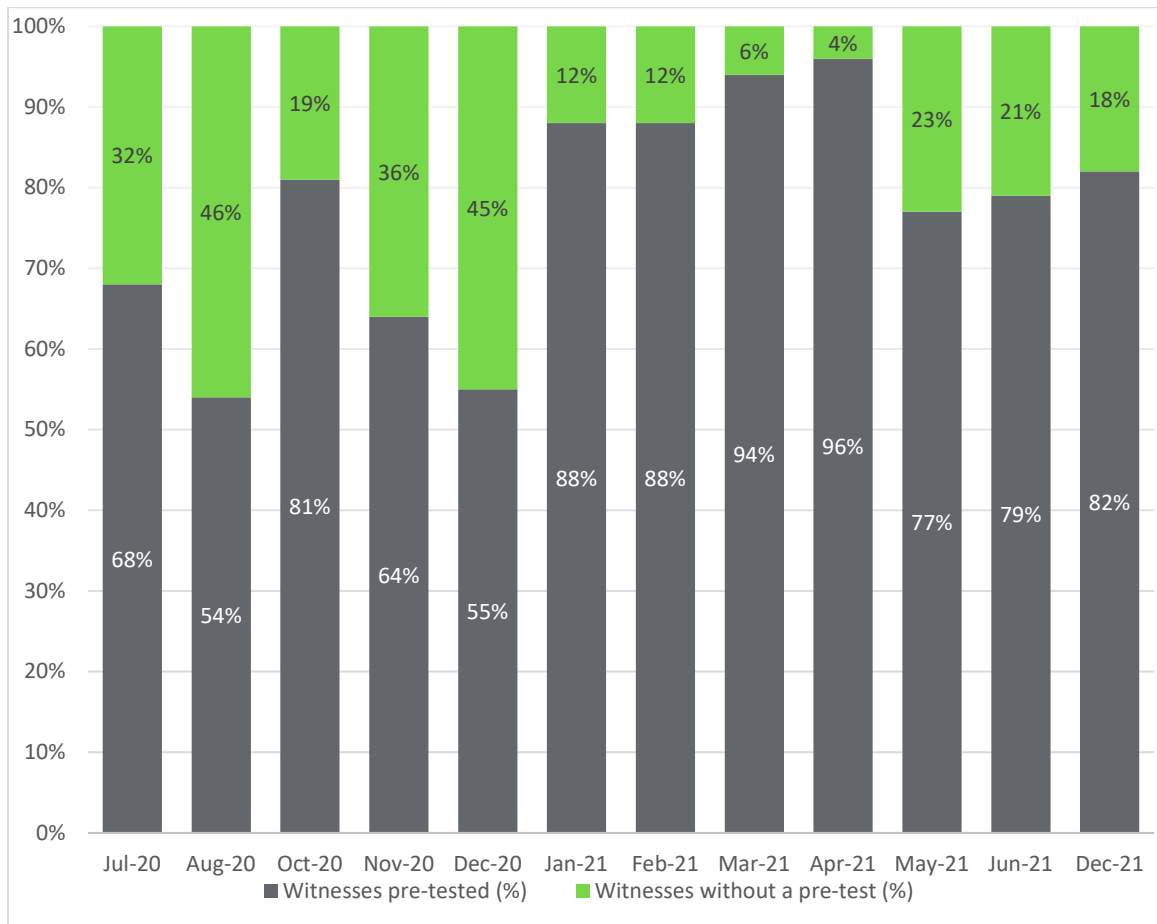

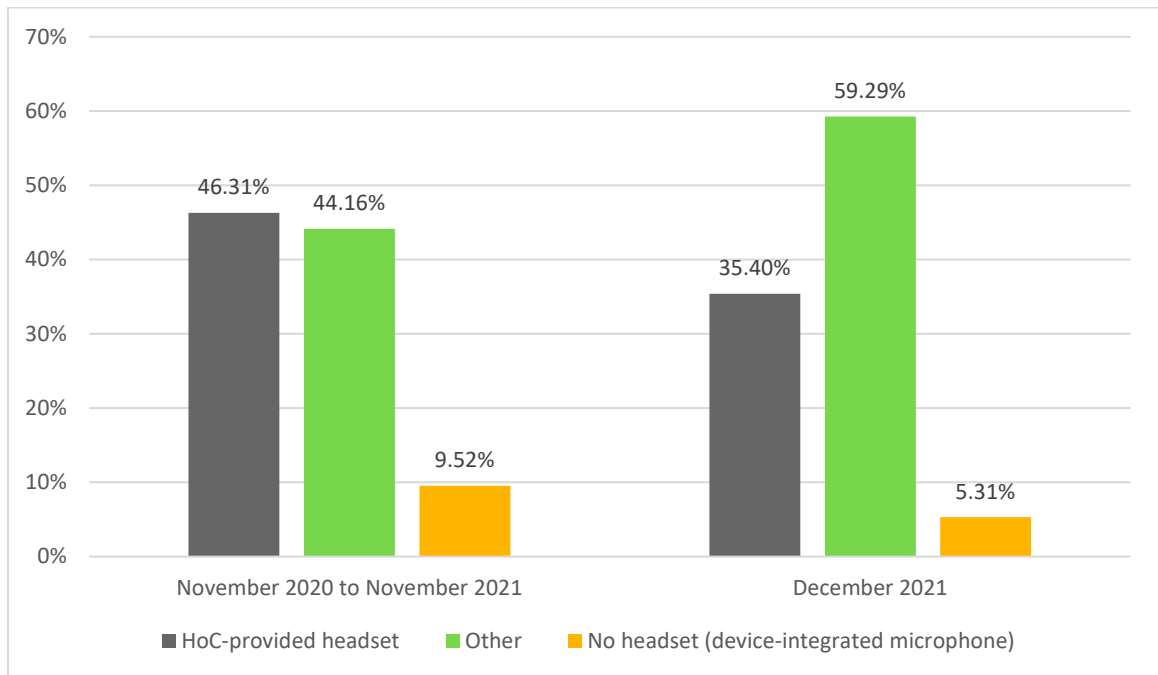

(July 2020 to December 2021)**

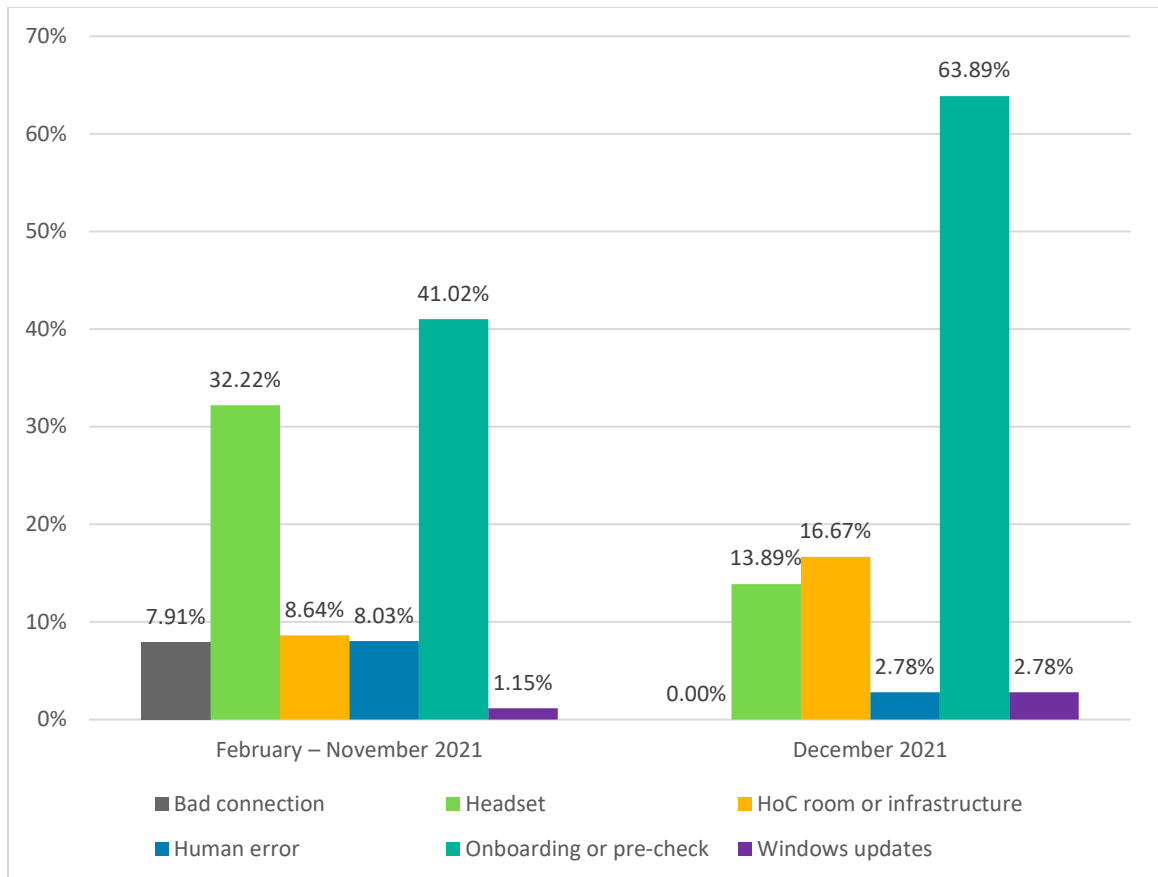

**Figure 3: Reasons for audio-quality issues experienced by committee witnesses (December 2021, as compared to February to November 2021)**



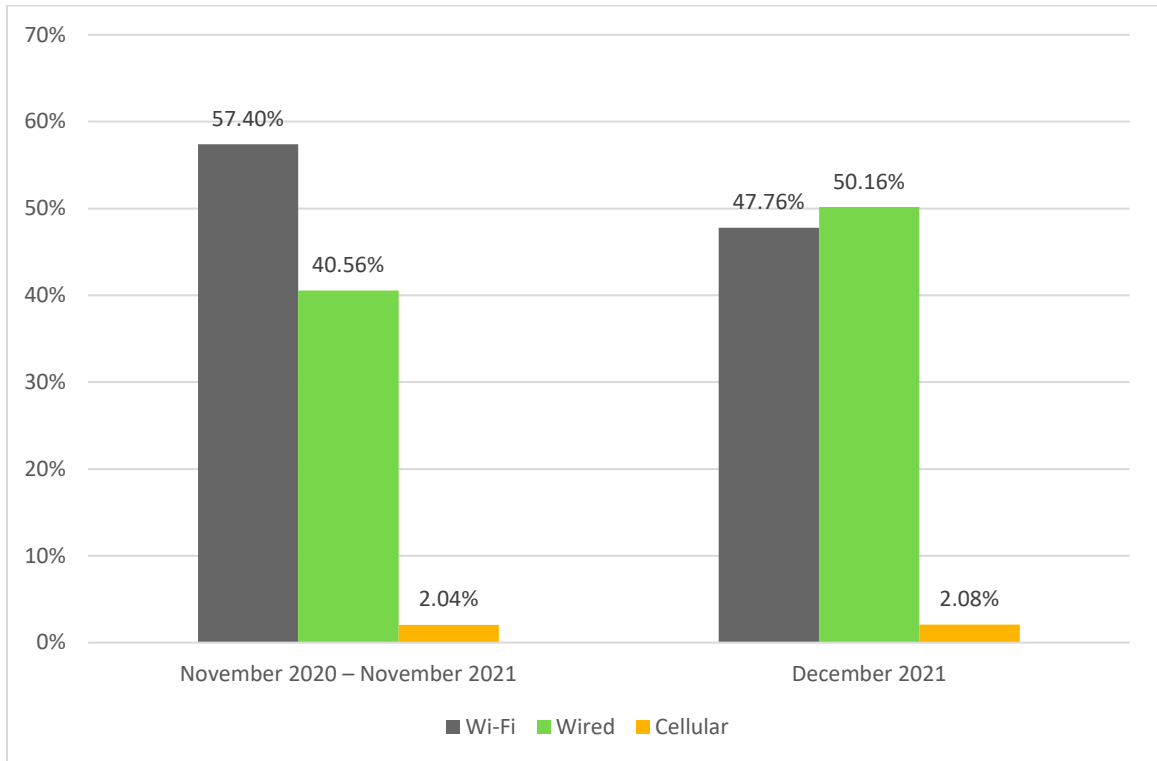
