1. Introduction

(i) Purpose of the Access to Information Act

The purpose of the *Access to Information Act* is to provide a legal and enforceable right of public access to records that are under the control of those government institutions that are listed in its Schedule 1. The First Nations Tax Commission (FNTC) was added to that Schedule as part of the process that led to the adoption of the *First Nations Fiscal Management Act* (FMA) on March 23, 2005. The *Access to Information Act* is intended to complement and not replace existing procedures for access to government information. It is not intended to limit in any way access to the type of government information that is normally available to the general public.

(ii) Preparation of the Annual Report

This annual report has been prepared in accordance with section 94 of the *Access to Information Act*, and outlines how FNTC has fulfilled its responsibilities under the *Access to Information Act* for the reporting period from April 1, 2020 to March 31, 2021.

(iii) Tabling of the Annual Report

The FNTC's 2020-2021 Annual Report on the *Access to Information Act* will be tabled in Parliament in accordance with section 94 of the *Access to Information Act*.

(iv) Mandate of the First Nations Tax Commission

The FNTC was established by federal legislation, the *First Nations Fiscal Management Act* (FMA), to provide for the regulation of First Nation property taxation. This Act, Bill C-20, was passed on March 23, 2005, and also created two other institutions: the First Nations Financial Management Board (FNFMB) and the First Nations Finance Authority (FNFA). At this time consequential amendments were made to the *Access to Information Act* to allow its application to the FNTC and the FNFMB. As such, the FNTC maintains openness, promotes transparency and assists any Canadian citizen in the exercise of the right to access FNTC's information.

In 1988, amendments to the *Indian Act* extended the taxing powers of First Nations to their interests in conditionally surrendered or "designated" lands. This First Nation-led change to the *Indian Act* gave First Nations broad new powers to tax the interests within the reserve, thereby establishing their jurisdiction, creating economic development opportunities and providing a basic tool for self-government. The FMA builds upon this work.

The FNTC's primary objective is to ensure that the First Nation property tax system is administratively efficient, harmonized with the various regions in the country, and considers the

interests of on-reserve taxpayers. The FMA establishes the FNTC as a statute-based service agency for First Nations exercising the approval of local revenue laws.

The FNTC represents the collective interests of First Nations and taxpayers and promotes economic development by enhancing the administrative efficiency and stability of the First Nation property tax system. The FNTC's chief aims are to expand First Nation taxation jurisdiction and increase investment on First Nations lands. It also ensures the effective administration of the tax system while protecting its integrity by reconciling the interests of First Nation tax authorities and taxpayers, thus creating benefits to all.

2. Administration/Structure

To fulfill the FNTC's responsibilities with respect to the *Access to Information Act*, the FNTC has developed an infrastructure (information management, security and Access to Information and Privacy policies and procedures) to support the FNTC's general operations and the administration of its Access to Information program.

The FNTC Access to Information and Privacy (ATIP) Office is part of the Corporate Services business line. There are three full-time employees who are dedicated part-time to Access to Information activities and one consultant who provides assistance and guidance when required.

There were no service agreements under section 96 of the *Access to Information Act* to which the FNTC was a party during the reporting period.

3. Delegation Order

FNTC's Delegation Order for the *Access to Information Act* and *Privacy Act* authorizes certain officers and employees of the FNTC to exercise signing authorities or to perform certain of the Chief Commissioner's powers, duties or functions under the Acts. A copy of the FNTC's Delegation of Authority is included in this report as Appendix A.

4. Interpretation of the Statistical Report 2020-2021

The FNTC's Statistical Report on the *Access to Information Act* for 2020-2021 can be found in Appendix B.

During the reporting period, the FNTC received one formal request under the Access to Information Act.

The key data for the past five reporting periods is presented in the summary table below (Figure 1).

Further interpretation of the FNTC's 2020-2021 statistical report is as follows:

i) Requests under the Access to Information Act

One formal request was received during the reporting period under the *Access to Information Act*. The formal request was from an individual that declined to identify which was abandoned and closed during the reporting period within 16-30 days.

(ii) Requests closed during the reporting period

One formal request was abandoned and closed during the reporting period.

Disposition and completion time

During this reporting period one request was closed within 16 to 30 days after being abandoned by the requester.

Exemptions

During this reporting period no exemptions were claimed.

Relevant pages processed and disclosed

During the reporting period one formal request was received with 0 pages processed prior to the abandonment of the request.

(iii) Extensions

No extensions were taken during the reporting period.

(iv) Fees

During the reporting period no fees were collected.

(v) Consultations received from other institutions and organizations

During the reporting period, the FNTC received two consultation requests from other Government of Canada institutions and organizations. 29 pages were reviewed and disclosed. One consultation request was completed within 1 to 15 days and disclosed entirely. One consultation request was completed from 16 to 30 days and disclosed entirely. 100% of the consultations records from other institutions and organizations were all disclosed.

(vi) Completion time of consultations on Cabinet confidences

There were no consultations on Cabinet confidences during the reporting period.

(vii) Complaints and investigations

FNTC received no complaints and no investigations during the reporting period.

(viii) Court action

There were no court actions during the reporting period.

(ix) Resources related to the Access to Information Act

During the reporting period, the costs related to the administration of the *Access to Information Act* incurred by the ATIP Office totalled \$35,125. \$23,079 was paid for salaries of three full-time employees dedicated part-time to ATI activities, and \$12,046 for goods and services that included training and policy and procedures development.

(x) Impact of COVID-19

In March 2020, the FNTC took measures to mitigate the impact of COVID-19. During this period, the FNTC was operating with a significantly reduced on-site workforce. The majority of the workforce transitioned to remote work and all staff were setup with secure access to the FNTC's networks. As a result, there was no impact on the administration of ATIP during the period where the majority of staff were working remotely.

5. Access to Information Training and Education

During the reporting period, three formal training sessions were held for new FNTC employees on their roles and responsibilities with respect to the administration of *Access to Information Act* and the *Privacy Act*.

6. Policies, Guidelines and Procedures

During the reporting period, no new or revised institution specific policies, guidelines or procedures were implemented.

7. Key Issues Raised as a Result of Complaints and/or Investigations

No complaints were received, and no audits or investigations were concluded during the reporting period.

8. Monitoring of Time to Process Access to Information Requests

During the reporting period, the FNTC did not conduct any monitoring of time to process access to information requests.
