Canadian manufacturers' shipments increased in October after declining for three months. The increase was mainly due to transportation equipment industries, notably motor vehicle industries, following large decreases in August and September and to an increase in the value of shipments in the refined petroleum and coal products industries, reflecting price increases as a result of the Middle East crisis. October manufacturing shipments excluding transportation equipment and refined petroleum and coal products showed no change from the previous month. The increase in inventories, the second in a row, also reflected price increases for refined petroleum and coal products industries.

The short term trend for shipments remained at the same level for a second consecutive month. Increases in the trends for refined petroleum and coal products and transportation equipment industries were offset by declines in 13 of the 20 remaining major groups. The trends for inventories, unfilled orders and new orders continued to decline.

Highlights

Preliminary estimates indicate that Canadian manufacturers' shipments increased 2.6% to \$24.9 billion in October 1990. Increases in transportation equipment, refined petroleum and coal products, chemicals, food and wood industries accounted for most of the increase. The largest decrease was recorded in electrical and electronic products industries.

The **trend** for shipments remained stable for a second month in a row, following small increases for May, June and July 1990. The trend for transportation equipment industries continued to increase, though at a slower pace. The trend for manufacturing shipments excluding transportation equipment declined gently during the last five months at a much slower pace than at the beginning of the year.

Inventories (owned) increased 0.3% to \$37.3 billion, the second increase in a row. Increases in refined petroleum and coal and chemical industries were partly offset by decreases in

electrical and electronic products, fabricated metals and machinery industries.

- The inventories to shipments ratio decreased from 1.53 in September to 1.50 in October. The trend, which had been declining since April 1990, remained unchanged at 1.50 for the third consecutive month.
- Unfilled orders decreased by 1.2% to a level of \$27.3 billion, a second consecutive decline. Decreases in transportation equipment, fabricated metal and machinery industries accounted for most of the decline. The trend for unfilled orders continued to decline, but at a slower pace than at the beginning of 1990.

Unfilled orders are the stock of orders which will generate future shipments, assuming that orders are not cancelled.

New orders are defined as the sum of shipments for the current month (i.e. orders received this month and shipped within the same month) plus the change in unfilled orders.

New orders increased 2.2% to a level of \$24.6 billion, following three months of decline. The trend fell at a slightly faster pace for the second month in a row.

Year-to-date


Cumulative shipments for the first 10 months of 1990 were estimated at \$246.3 billion, 2.7% lower than the value for the corresponding period in 1989.

Crude Petroleum and Natural Gas Industry – Volume and Value of Marketable Production

1990 Preliminary and 1989 Final

Highlights

- Preliminary figures indicate that production of crude oil in Canada during 1990 is expected to amount to 89 607.6 thousand cubic metres, a 1.1% decrease from 1989, with a value of \$13,841.8 million, a 27.4% increase from 1989.
- Natural gas production during 1990 should be 98 333.6 million cubic metres, a 2.3% increase from 1989, valued at \$5,597.9 million.
- Production of natural gas by-products should reach 23 316.7 thousand cubic metres, a 1.1% increase from 1989, with a value of \$2,208.7 million, up 36.3% from 1989.

Provincial Government Finance – Financial Management System Basis 1987-88 (Actual)

On a Financial Management System (FMS) basis, actual provincial government expenditure for the fiscal year 1987/88 totalled \$119.4 billion, an increase of 5.8% over 1986/87, while total revenues were at \$112.6 billion or 11.8% higher than the previous fiscal year.

Provincial government revenues and expenditures on a Financial Management System Basis have been historically revised for the period 1974/75 to 1987/88 to reflect the exclusion of the revenues and expenditures of the Quebec Pension Plan and the Toronto Area Transit Operating Authority as well as other minor revisions. These data are now comparable with previously released estimates for the years 1988/89 to 1990/91.

Note to Users:

The Financial Management System (FMS) provides a standardized presentation of government accounting for the federal, provincial and local governments in Canada. The individual governments' accounting systems are not directly comparable because the policies and structure of governments differ. The FMS adjusts data from government budgets, estimates, public accounts and other records to provide detailed, intergovernmentally comparable data as well as compatible national aggregates that are consistent over time. In other words, FMS statistics may not accord with the figures published in government financial statements.

A detailed reconciliation of FMS data to Public Accounts data is available for each province and territory.

Fabricated Structural Steel Price Indexes Third Quarter 1990

Price indexes for the third quarter of 1990 for fabricated structural steel-in-place are now available. These indexes, at a Canada level, show an increase of 0.2% from the second quarter of 1990 and an increase of 2.2% from one year ago.

The Fabricated Structural Steel Price Indexes have now been converted to a 1986 = 100 reference base. Figures for the third quarter 1990 will be published as 1986 = 100.

Canadian firms produced 164 966 cubic metres of construction type plywood during October 1990, a decrease of 13.6% from the 191 040 cubic metres produced during October 1989.

January to October 1990 production totalled 1 722 091 cubic metres,a decrease of 4.5% from the 1 803 470 cubic metres produced during the same period in 1989.
