Introduction

The *Privacy Act* (Revised Statutes of Canada, Chapter A–1, 1985) was proclaimed on July 1, 1983. The *Privacy Act* extends to individuals the right of access to information about themselves held by federal institutions, again subject to specific and limited exceptions. The law also protects the individual's privacy by preventing others from having access to personal information and gives individuals substantial control over its collection and use.

Canada Enterprise Emergency Funding Corporation ("CEEFC" or the "Corporation") became subject to the *Privacy Act* on May 11, 2020.

This Annual Report to Parliament on the *Privacy Act* (the "Act") is prepared and tabled in Parliament in accordance with section 72 of the *Act* and covers the period from April 1, 2021 to March 31, 2022.

Mandate and Organizational Structure

CEEFC was incorporated as a subsidiary of Canada Development Investment Corporation ("CDEV") in 2020 to administer the Large Employer Emergency Financing Facility as part of Canada's COVID-19 Economic Response Plan. This program will provide emergency funding support for large Canadian enterprises facing financial challenges in light of the economic impact of the global COVID-19 pandemic. CEEFC has been formed to administer this mandate.

There are service agreements between CDEV and its subsidiaries. CDEV administers the *Act* on behalf of its subsidiaries, excluding TMC.

The Corporation reports to Parliament through the Minister of Finance.

The Corporation has a service agreement in place with CDEV, which includes the provision of Access to Information and Privacy ("ATIP") services. Two full-time CDEV employees are dedicated part-time to ATIP activities for CDEV and its subsidiaries, excluding TMC. The ATIP department consists of the ATIP Coordinator and one analyst. CDEV retains advice from external legal counsel and independent consultants as needed.

Delegation Order

The Delegation of Authority Order (Appendix A) is reviewed and approved annually by the head of the organization. The authority to approve or deny the release of departmental information requested under the *Act* is shared by the CEO and the ATIP Coordinator of CDEV.

Performance and Highlights of the 2021-2022 Statistical Report

Appendices B and C provide a summarized statistical report on the requests for personal information received under the *Privacy Act* from April 1, 2021 to March 31, 2022.

One new request was received in the reporting period and none were carried over from the previous fiscal year. The request was closed on or before March 31, 2022 and none were carried over to the next reporting period.

One formal request, or 100% of all requests, resulted in no responsive records.

All formal requests were closed within the statutory timeline, resulting in an overall timeline compliance rate of 100%. The closed request was completed within 1 to 15 days (100%).

No active requests are outstanding from previous reporting periods.

No active complaints are outstanding from previous reporting periods.

No consultations for other institutions were completed during this reporting period.

Operations were not impacted by COVID-19 during this reporting period.

A Supplementary Statistical Report is included in this report.

Training and Awareness

CDEV management meet with ATIP administrators to discuss specific requests and consultations as required.

Management are briefed on the status of files and reporting requirements on a regular basis. Summaries of formal and informal ATIP requests for CDEV and its subsidiaries are presented to the board of directors at least annually.

ATIP training was provided to all staff as well as directors of CDEV and its subsidiaries in June 2021. Two sessions were held.

Policies, Guidelines, Procedures and Initiatives

CDEV's privacy policy is reviewed by the board of directors regularly and amended as required. The privacy policy was last reviewed in June 2021.

CEEFC adopted many of CDEV's policies, guidelines and procedures during its first year of operation.

Summary of Key Issues and Actions Taken on Complaints or Audits

No complaints were received and no audits were concluded during the reporting period.

Monitoring Compliance

Outstanding requests are reviewed regularly to ensure the file is current and processing times are met.

Material Privacy Breaches

There were no material privacy breaches during the reporting period.

Privacy Impact Assessments

At March 31, 2022, no required privacy impact assessments have been identified by the Corporation.

Public Interest Disclosures

No public interest disclosure was made under paragraph 8 (2)(m) of the *Privacy Act* in this reporting period.
