Introduction

The Access to Information Act (Revised Statutes of Canada, Chapter A–1, 1985) was proclaimed on July 1, 1983. The Access to Information Act (the "Act") gives Canadian citizens and permanent residents a broad right of access to information contained in government records, including Crown Corporations and Agencies, subject to certain specific and limited exceptions.

This Annual Report to Parliament on the *Access to Information Act* is prepared and tabled in Parliament in accordance with section 72 of the *Act* and covers the period from April 1, 2017 to March 31, 2018.

Canada Development Investment Corporation ("CDEV" or the "Corporation") became subject to the *Access to Information Act* on September 1, 2005.

Mandate of the Institution and Organizational Structure

CDEV was incorporated in 1982 as a federal crown corporation to provide a commercial vehicle for Government equity investment and to manage commercial holdings of the Government in the best interests of Canada, operating in a commercial manner.

CDEV is currently responsible for three wholly-owned subsidiaries: Canada Hibernia Holding Corporation ("CHHC"), Canada Eldor Inc. ("CEI") and Canada GEN Investment Corporation ("GEN"). An Annual Report on the *Access to Information Act* has been prepared for each subsidiary.

The conduct and affairs of CDEV are overseen by the board of directors who are independent of management. The Corporation reports to Parliament through the Minister of Finance.

During the period April 1, 2017 to March 31, 2018, the Corporation did not borrow from the Government nor did it receive any appropriations.

Administration of Access to Information Activity

CDEV is based in Toronto and operates with a small team of six employees. The Access to Information and Privacy ("ATIP") Coordinator is a full-time employee of the Corporation dedicated part-time to ATIP activities. The ATIP office consists of the Coordinator and an ATIP analyst with no other regional offices or employees. CDEV also retains advice from an independent consultant as needed.

The Corporation retains a small amount of commercial information in confidence. In the event of requests for such information, the Corporation will undertake appropriate notification and consultation procedures with relevant parties before disclosing any records.

The Delegation of Authority Order (Appendix A) that was approved on September 11,

2015 remained in effect throughout the reporting period. The Order was renewed on May 24, 2018. The authority to approve or deny the release of departmental information requested under the *Act* is shared by the Executive Vice President and the ATIP Coordinator.

Fees

The Corporation has adopted the Government's basic fee structure and normally requires that applicable fees be paid.

Since the Corporation maintains its own bank accounts, it is unable to process cheques made payable to the Receiver General of Canada. To assist applicants who are not aware of this, a note has been inserted in *Info Source* stating that the fee accompanying requests is to be made payable to the Canada Development Investment Corporation.

During the period, a total of \$30 was collected from six formal request applications.

Information Holdings

The Access to Information and Privacy Coordinator is responsible for providing a full accounting of the Corporation's information holdings to the Treasury Board Secretariat and ensures that updates are provided on a timely basis for inclusion in the *Info Source* publications.

The *Info Source* publications contain a description of the classes of corporate records held by the Canada Development Investment Corporation. The Corporation does not have any exempt banks. The Corporation publishes its *Info Source* chapter on its website at www.cdev.gc.ca.

Website

The Canada Development Investment Corporation maintains a public website: www.cdev.gc.ca. The website provides information on ATIP matters for CDEV and its subsidiaries. Completed Access to Information request summaries are published on the website's Access to Information section.

As of the first quarter of 2018, completed request summaries are also available on the Open Government website and included in the searchable database.

Reading Room

Canada Development Investment Corporation does not maintain a formal reading room as it occupies only minimal office space. However, in accordance with the *Access to Information Act*, the Corporation will make arrangements to provide facilities for viewing material on an as required basis.

Training and Awareness

In April 2017, an independent consultant provided a one day information session on the *Access to Information* and *Privacy Acts* to all six CDEV employees, including two ATIP staff.

Policies, Guidelines, Procedures and Initiatives

There were no changes to policies, guidelines or procedures during the reporting period.

Summary of Key Issues and Actions Taken on Complaints or Audits

One complaint was made to the Office of the Information Commissioner under section 32 of the *Act* alleging incorrect sections of the *Act* were applied to justify the exemption. CDEV worked with the Information Commissioner, external third parties and other Government institutions to successfully resolve the complaint by the end of the reporting period. The exemptions were reviewed and additional records were released to the requester in March 2018.

Monitoring Compliance

Outstanding requests are reviewed regularly to ensure the file is current and processing times are met.

Highlights of the Statistical Report, 2017-18

Appendix B is intended to provide a summarized statistical report on the *Access to Information Act* from April 1, 2017 to March 31, 2018.

The Corporation received six formal requests and five informal requests during the reporting period. One request remained open at March 31, 2018.

Six formal requests were completed during the reporting period. One was abandoned, one was all exempted, one was disclosed in full and three were disclosed in part. Three required 90 day extensions and one required a 60 day extension for government and third party consultations. Two requests were closed past the statutory deadline due to complex third-party and government consultations.

Five informal requests were closed during the reporting period, all under 15 days.

Eight consultations were received from other Government of Canada institutions in addition to one outstanding from the previous reporting period. All of the consultations were closed at March 31, 2018.

Of the new consultations, two were disclosed entirely, three disclosed in part and three exempt entirely. Four were completed under 15 days and four within 16-30 days. The request carried forward from the previous period was disclosed entirely, however it took in excess of 365 days to complete due to the volume of records and external consultations required.

Two requests closed past the statutory deadline due to complex external consultations. One exceeded the deadline by 4 days and the other by 177 days. Requests closed past the statutory deadline accounted for 33% of all formal requests in this period.

Since becoming subject to the Act in September 2005 the Corporation on average

receives two formal requests plus four consultations during each reporting period. This period CDEV received more requests and consultations than in previous years. The majority were in relation to two projects undertaken by the Corporation that were of interest to the media and general public.

Exemptions Invoked & Exclusions Cited

During the reporting period exemptions were invoked under sections 18, 19, 20 and 21. Exclusion 68(a) was applied where existing records were already published and accessible elsewhere. These exemptions are the most commonly used by the Corporation due to the nature of the business.

Costs

Total costs associated with *Access to Information Act* administration activities for this reporting period are \$61,742. Expenses increased by \$11,000 from the previous period due to the higher volume of requests and consultations.
