#### Introduction

The Access to Information Act (Revised Statutes of Canada, Chapter A–1, 1985) was proclaimed on July 1, 1983. The Access to Information Act (the "Act") gives Canadian citizens and permanent residents a broad right of access to information contained in government records, including Crown corporations and agencies, subject to certain specific and limited exceptions.

This Annual Report to Parliament on the *Access to Information Act* is prepared and tabled in Parliament in accordance with section 72 of the *Act* and covers the period from April 1, 2018 to March 31, 2019.

Canada TMP Finance Ltd. ("TMP Finance" or "the Company"), formerly known as Project Deliver I, became subject to the *Access to Information Act* upon incorporation on May 28, 2018.

TMP Finance is mandated to acquire, finance and provide strategic direction to the Trans Mountain Corporation ("TMC") and its entities. TMP Finance is the parent company of TMC and reports to Parliament through the Minister of Finance.

#### **Organizational Structure and Mandate**

TMP Finance is a wholly-owned subsidiary of the Canada Development Investment Corporation ("CDEV") and has no employees. Day to day operations are administered by CDEV employees in Toronto, Ontario.

Two full-time CDEV employees are dedicated part-time to ATIP activities for CDEV and its subsidiaries, excluding TMC. The ATIP department consists of the ATIP Coordinator and one analyst. CDEV retains advice from external legal counsel and independent consultants as needed.

Trans Mountain Corporation's ATIP activities are managed by its legal department from their office in Calgary, Alberta.

TMP Finance reports to Parliament through its parent company CDEV and the Minister of Finance.

#### **Delegation Order**

The Delegation of Authority Order (Appendix A) is reviewed and approved annually by the head of the organization. The authority to approve or deny the release of departmental information requested under the Act is shared by the Executive Vice-President and the ATIP Coordinator.

#### **Information Holdings**

CDEV maintains a public website: www.cdev.gc.ca. The website provides information on ATIP matters for CDEV and its subsidiaries, excluding TMC. Completed Access to

Information request summaries are published on the website's Access to Information section.

Completed request summaries became available on the Open Government website and included in the searchable database.

TMP Finance does not maintain a formal reading room as it occupies only minimal office space. However, in accordance with the *Access to Information Act*, the Company will make arrangements to provide facilities for viewing material on an as required basis.

#### **Highlights of the 2018-2019 Statistical Report**

Appendix B is intended to provide a summarized statistical report on the *Access to Information Act* from April 1, 2018 to March 31, 2019. Since its incorporation in May 2018, TMP Finance has received no formal or informal requests and no consultations from other institutions.

#### **Training and Awareness**

Four non-ATIP employees participated in an interactive presentation hosted by CDEV's external legal advisors. The information session also served as an introduction to ATIP for the TMC employees assigned with ATIP responsibilities. The event was organized upon TMC becoming subject to the *Act* in September 2018. Topics included ATIP duties, information management and requester relations.

CDEV management meet with ATIP administrators to discuss specific requests and consultations as required.

Management are briefed on the status of files and reporting requirements on a regular basis. Summaries of formal and informal ATIP requests for CDEV and its subsidiaries are presented to the board of directors at least annually.

#### Policies, Guidelines, Procedures and Initiatives

ATIP policies, guidelines, procedures and initiatives are reviewed regularly. Changes in technology and software options are considered as they become available.

There were no changes to policies, guidelines or procedures during the reporting period.

#### **Summary of Key Issues and Actions Taken on Complaints or Audits**

No complaints were received and no audits were conducted.

#### **Monitoring Compliance**

No monitoring was necessary in this period.
