SECTION 1

Introduction to the Departmental Sustainable Development Strategy

The [2022 to 2026 Federal Sustainable Development Strategy \(FSDS\)](#) presents the Government of Canada's sustainable development goals and targets, as required by the [Federal Sustainable Development Act](#). This is the first FSDS to be framed using the 17 Sustainable Development Goals (SDGs) of the United Nations 2030 Agenda and provides a balanced view of the environmental, social and economic dimensions of sustainable development.

In keeping with the purpose of the Act, to make decision-making related to sustainable development more transparent and accountable to Parliament, Farm Products Council of Canada (FPCC) supports the goals laid out in the FSDS through the activities described in this Departmental Sustainable Development Strategy (DSDS).

The [Federal Sustainable Development Act](#) also sets out [7 principles](#) that must be considered in the development of the FSDS as well as the DSDSs. These basic principles have been considered and incorporated into Farm Products Council of Canada's DSDS.



SECTION 2

Farm Products Council of Canada's Sustainable Development Vision

As a Government of Canada public interest oversight body, the Farm Products Council of Canada oversees the national supply management system for poultry and eggs, including the operations of the four national marketing agencies: Egg Farmers of Canada; Canadian Hatching Egg Producers; Chicken Farmers of Canada; and, Turkey Farmers of Canada. FPCC also oversees the creation and operation of promotion and research agencies, including the Canadian Beef Check-Off Agency and the Canadian Pork Promotion Research Agency.

FPCC's mandate includes a collaborative role in supporting broad climate resiliency and helping industry make food supply chains more efficient by eliminating food waste and finding innovative ways to add value.

FPCC supports the 2022 to 2026 Federal Sustainable Development Strategy (FSDS) by seeking opportunities to promote innovative solutions in relation to government priorities on greening the economy and inclusive growth, including those linked to Green procurement and Indigenous economic reconciliation. FPCC will do this by considering the economic, environmental and social dimensions of its decisions, programs, services and operations.

This Departmental Sustainable Development Strategy (DSDS) represents FPCC's first sustainable development strategy.

SECTION 3

Listening to Canadians

As required by the Federal Sustainable Development Act, Farm Products Council of Canada has taken into account comments on the draft 2022-2026 FSDS made during the public consultation held from March 11 to July 9, 2022. During the public consultation, more than 700 comments were received from a broad range of stakeholders, including governments, Indigenous organizations, non-governmental organizations, academics, businesses, and individual Canadians in different age groups and of various backgrounds. The draft FSDS was also shared with the appropriate committee of each House of Parliament, the Commissioner of the Environment and Sustainable Development, and the Sustainable Development Advisory Council for their review and comment.

What We Heard

Across the submissions received, Farm Products Council of Canada identified sustainable development priorities and issues that affect us. These priorities include the following:

- **Reducing inequalities through continuous engagement with Indigenous communities** – Canadians noted the importance of consultation and engagement with Indigenous communities in order to amplify Indigenous perspectives throughout government initiatives.
- **Agriculture** – Some of the top comments from Canadians centered on the need for the Government to encourage players in the agricultural sector to substantially reduce their GHG emissions, in addition to Government's continued support for agricultural investments such as precision agriculture and technology that convert organic farm waste into biogas, clean fuels, or other high-value commodities.
- **Green Procurement** – Canadians want to see the Government of Canada implement net-zero procurement to incentivize companies' voluntary engagement in the race to net zero.

What We Did

Farm Products Council of Canada took the above-mentioned key priorities and issues into consideration in this DSDS.

While FPCC is not a lead, key contributing department, or horizontal lead identified in the [Federal Implementation Plan for the 2030](#)ⁱ Agenda for Sustainable Development and the UN Sustainable Development Goals, the organization takes into account the Government of Canada's commitment to achieving these goals in its strategic initiatives and activities.

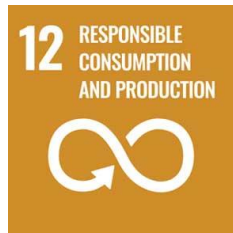
Through FPCC's main role of overseeing the operations of national marketing agencies and promotion and research agencies, FPCC has an opportunity to shine a light on the benefits that supply management brings and the role it plays in sustaining a strong Canadian economy, including the role supply management can play and the ways in which it strengthens food security both at home and globally while protecting consumers' interests.

Internally, FPCC has built a corporate culture that supports and values the diversity and inclusion of all its people and promotes opportunities for training, professional advancement, and job satisfaction that leads to a healthy and satisfied working environment. FPCC has embraced the DSDS to expand its training framework to incorporate learning on Indigenous cultural competencies, Green procurement and climate risk priorities.
