



A HISTORICAL HANDBOOK OF EXCHANGE AND TOLL SERVICE TARIFFS

FOR BELL CANADA AND BRITISH COLUMBIA TELEPHONE COMPANY

1966-1975

I - Introduction

This handbook presents the historical exchange and toll service tariffs in the period from 1966 to 1975 for the two major federally-regulated telecommunications carriers, Bell Canada and British Columbia Telephone Company. It is designed as a reference document for those readers who require basic information on the development of tariffs and rates for the major telephone services offered. These services, two point toll and basic exchange, generate the major portion of total operating revenue.

The handbook primarily consists of tables illustrating the exchange and toll tariffs, but also has a small explanatory text describing the changes in the structure of the toll and exchange service tariffs as well as the sources of information. Within the tabular section, there is one set of tables displaying the historical rates for the main business and residence basic exchange services and another set showing the historical rates for toll messages placed between locations inside a company's territory.

Common formats were used in the design of the exchange and toll service rate tables rather than presenting the varying tariff arrangements used by these companies over the years. This facilitates analysis of any trends in company rates from 1966 to 1975. For example, Bell Canada's price of a five minute customer-dialed day message between locations one hundred miles apart was \$1.10 in 1966, \$1.27 in 1971 and \$1.40 in 1975. However, changes in the structures of the tariffs are difficult to detect from the tables in the appendix because of the amount of detail recorded. Therefore, the major highlights are summarized in Section II.

II - Changes in the Structures of the Tariffs, 1966-1975

Over the years from 1966 to 1975, several significant changes have been made in the structures of the exchange and toll service tariffs of both Bell Canada and British Columbia Telephone Company.

Some of the changes which had an impact on the structure of the tariffs are discussed below.

a) Changes in the Structure of Exchange Service Tariffs

Three characteristics of the exchange service tariffs of both companies were altered; these modifications affected the rate groups and the calculation of the telephone counts.

Before 1973, Bell Canada had specific exchanges assigned to certain rate groups based on their geographical location while other exchanges were assigned to rate groups based on the size of their telephone count. British Columbia Telephone Company also employed this mixed classification method until 1975. For example, Victoria and Saanich, two British Columbia communities with considerably different telephone counts, were placed in the same rate group primarily because they were contiguous to each other. This method of assigning rate groups was replaced by a new system on which the classification for each exchange was based on its telephone count. With this change came an increase in the size of some of the rate groups, a change in the number of them, and an increase in the maximum telephone count.

Another modification that affected the rate groups was the introduction of the weighting factor plan. Under the old system, some suburban exchanges which had extended area service with the city exchange were classified into "fringes" - for example, first, second and third fringe - depending upon their distance from the city exchange. As extended area service grew, problems were encountered such as the need for extended area service between a "fringe" exchange and one outside the extended

area. An alternative system was found in the form of the weighting factor plan. The weighting factor plan involved the use of weighting factors in calculating the telephone count of an exchange. The telephone count was calculated for an exchange with extended area service by summing its telephone count and that of each of the other exchanges in the extended area subject, in each instance, to a weighting factor dependent upon the distance between the two exchanges. Bell Canada introduced this new plan in 1960, but it was not until 1973 that it applied to all exchanges in Bell Canada's territory. British Columbia Telephone Company introduced it for all exchanges in 1975. The basic design of this plan was such that it was applicable to all exchanges thus eliminating the need for special rate groups based on geographical location for specific exchanges.

The final change in the structure of the tariff was the altering of the types of telephones used in calculating the telephone count. For example, in 1965 Bell Canada included all telephones, whereas in 1975 Bell Canada excluded public telephones, extensions and others in their calculation of the telephone count.

b) Changes in Structure of Toll Service Tariffs

Five types of changes were made in the structure of the toll service tariffs of both companies. These were the introduction of customer dialing, reorganization of mileage bands, reduction of the initial period length, introduction of the discount plan and changes in the time periods of each day.

Before 1956, there were only two classes of service for toll messages - operator-handled and person-to-person. In 1956, customer-dialed service was introduced on a limited basis as a cost-saving measure. Until 1967, the rates for customer-dialed messages were the same as operator-handled. However, as the companies converted their equipment to handle customer-dialed calls, they attempted to discourage operator-handled and person-to-person traffic by lowering the price of customer-dialed messages below operator-handled rates. This trend continues to the present day,

Between 1966 and 1975, both companies considerably decreased the number of mileage bands. For example, in 1966 Bell Canada had 26 mileage bands, but by 1975 they had only 17. The impact of these changes was to increase the percentage of bands for short distance messages and decrease the percentage of those for long distances.

Both companies originally had an initial period length of three minutes for all classes of service. When discount plans were introduced - 1971 for Bell Canada, 1972 for British Columbia Telephone Company - both companies reduced their initial period length for customer-dialed messages to one minute, leaving the initial period length for the other two classes of service unaltered.

Before 1972, there were two rate schedules - one for calls placed on Sundays and one for those on weekdays. After 1971, with the introduction of discounts, there was, in effect, only one rate schedule since the rates for Sunday and off-peak hours were stated in terms of discounts from the weekday day schedule.

Before 1968, separate rates applied for two time periods on weekdays. However, the rates were the same for all of Sunday. In

1968, another time period - late night - was added for both weekdays and Sundays for customer-dialed messages only. With the introduction of discounts in 1971 or 1972, both companies had three time periods for weekdays and two or three for Sunday for customer-dialed and operator-handled messages. For person-to-person messages, Bell Canada had only one time period and this did not change between 1966 and 1975. British Columbia Telephone Company had the same time periods for person-to-person messages as for operator-handled and thus had the same changes between 1966 and 1975.

III - Sources of Information

The information for each company was obtained from the company's tariff. This is the official document describing the terms and conditions which apply to the furnishing of telephone service and equipment. The tariff generally contains the rates for exchange service, two-point toll service, and other services and equipment offered by the company.
