This allowed a disaggregation of these industries by province and the specification of provincial-specific supply patterns. The methodology employed was the same as for manufacturing industries and is discussed in the previous paper.

(2) As in the previous model, for each receiving industry, the national distribution of supply of each industry input, between domestic sources and imports, was assumed to apply for each province.

The one notable exception was that a provincial - specific distribution was estimated for the energy sector (Industry no. 3), reflecting the two-region national energy policy.

(3) Each province was assumed to supply entirely its own service requirements (national industries 4 - 8). Thus, these industries were disaggregated by province. This contrasts with the previous assumption that the supply pattern for all provinces as receivers corresponded with the provincial output pattern. The four region interregional input-output model constructed by the Agricultural Economics Research Council (AERC), which became available only recently, provides estimates that the own-region supply coefficients for service industries are very close to unity.

(4) The expenditure coefficients in the personal consumption column vectors were reduced to reflect personal income rather than personal consumption as the base. This adjustment was made so that the coefficients in that column reflect the expenditure pattern from the income received in the corresponding row, i.e. wages & salaries plus net income of unincorporated business. This balance is required whenever a row and column is included in the "closed" matrix.

Personal expenditures on goods and services from these two forms of personal income alone are not known; however, personal consumption as a percentage of total household income (i.e. including investment income and transfers) is known. This percentage is 80%

for 1966, and all consumption coefficients in the table were reduced by 20%. This implicitly assumes that the differing rates of consumption from investment income and transfers offset each other in such a way that 80% of wages & salaries and unincorporated business income is spent on goods and services.

The table could not be closed completely for the household sector as interprovincial flows of investment income are not available and because governments, which are the sources of transfers, are not included in the table.

B. Effects of the Above Modifications

(1) All industries are now disaggregated by province, i.e. the table consists of 170 rows and columns (16 industries plus personal income or wages & salaries for 10 provinces). Thus, estimates of the impact of a change in the output levels of non-manufacturing industries in a given province are produced.

(2) As a result of modifications (1) and (3) above, the value of induced income and wages & salaries retained in the province of impact has risen substantially and the disparities between provinces have fallen significantly. The percentage of income retained in the province of impact are slightly high estimates as it is assumed that all services are own-province supplied. However, in general, the results appear much more reasonable than those resulting from the

previous model and match closely the results obtained from the four-region model constructed by J.G. Young¹ which served as a basis for the AERC model.

(3) As a result of modification (2) above, the total income and wages & salaries induced domestically generally rise as one moves westerly across the provinces as more energy inputs are supplied domestically. The differences between eastern and western provinces is particularly marked for the Chemical, Rubber and Petroleum Products Industry as would be expected.

(4) The effect of modification (4) i.e. reduction in personal expenditure coefficients, is to reduce the estimates of total induced income and wage & salaries and thus the wages & salaries multipliers. How accurately these results truly estimate the absolute values of total induced income and wages & salaries is open to question as the household sector is not included totally in the matrix. In fact, the multipliers are very sensitive to the type and number of primary input and final demand vectors included in the closed matrix and researchers have included various combinations of such vectors. However, the relativity of the estimates between industries are likely quite accurately measured by the model.

C. Remaining Major Problems in the Model

Aside from general constraints which apply to inter-regional input-output analysis in general, e.g. changes in technology,

changes in relative prices, changes in trade patterns, static analysis, capacity constraints, the following aspects remain as major sources of distortions in the model:

(1) The same technology is assumed for each industry in all provinces. However, it is likely that this distortion is not significant for the level of aggregation used in the model.

(2) For each industry the national distribution of supply of industry inputs, between domestic and foreign sources, is assumed to hold for all provinces, except as noted above for the energy sector.

(3) The household sector cannot be totally included for the reasons noted above. Further, the average propensity to consume from wages & salaries in the model is based on the propensity from total household income. This assumption, as mentioned previously, has important implications for the absolute values of the multipliers.

(4) Data on interprovincial flows of services are not available; thus, own-province supply is assumed which clearly leads to overestimates of the multipliers in the province of impact.

(5) The Government sector is completely ignored in the model.

D. Results of the Impact Analysis

The results are presented in Tables I - VI and in the two tables in the Appendix following. These tables correspond closely

with those in the previous paper; however, the total induced domestic income and wages & salaries estimates now vary by province of impact and the presentation of the results reflects this change.

The interpretation of the results is identical to that in the previous paper except, as noted above, Personal Consumption is now changed to Personal Income.

The new estimates of the leakages from the province of impact have fallen substantially from the previous estimates. In the previous paper it was noted that the leakage estimates presented therein were overestimated but the extent of the overestimate is quite a surprise. Clearly the results are extremely sensitive to the assumptions incorporated in the model, and the author makes no apologies for the distorted results presented previously. It appears that the results presented below, which compare closely with estimates derived elsewhere, are more accurate and accord more closely with reasonable expectations.

While the leakage estimates have fallen as a result of the improvements in the model, the one-way nature of income flows between the Atlantic Provinces and the rest of Canada, (although less pronounced) and the lack of economic integration between the Atlantic provinces, remain as a basic feature of the Canadian spatial economic structure.

E. Further Research Work

Several research projects based on the input-output model will be undertaken in the near future. They are (in likely temporal order in which they will proceed):

(1) Linking of impact results to occupational distribution of labour force by industry and by province. Thus, levels and profiles by occupation and by province induced by industry/province - specific increases in output can be estimated. Employment multipliers can also be estimated.

(2) Based on the 1966 pattern of industry outputs by province the determination of estimates of bi-provincial trade positions. Several other statistics will also be developed.

(3) Development of some theoretical measures of regional balance and their application using the impact results of the model.

(4) The application of an algorithm to identify industrial complexes, developed by Dr. B. Lodh, to the interprovincial table in order to identify spatial-industrial complexes in Canada.

(5) Discussion of a method to estimate provincial-industrial structural change induced by the expansion/creation of industries and experiments with the methodology using the input-output model.
